## ORDINANCE

**WHEREAS**, the City of Chicago (the “City”) is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and as such, may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, pursuant to an ordinance approved by the City Council of the City (the “City Council”) on September 29, 1999, and published in the Journal of the Proceedings of the City for such date (the “1999 Ordinance”), the City conveyed the property commonly known as 4201-03 South Ellis Avenue, 4200-02 South Berkeley Avenue and 4204-16 South Berkeley Avenue, Chicago, Illinois, and legally described on Exhibit A attached hereto (collectively, the “Property”) to Abraham Lincoln Center, an Illinois not-for-profit corporation (the “Original Grantee”), by a quitclaim deed dated December 3, 1999, and recorded with the Office of the Recorder of Deeds of Cook County (the “Recorder’s Office”) on August 9, 2000, as document number 00607390 (the “Original Deed”); and

**WHEREAS**, the 1999 Ordinance and the Original Deed required that the Property be improved with a child care center with accessory parking within twenty-four (24) months of the date of the Original Deed, and that the Property be used as a child care center with accessory parking open to the public for a period of twenty (20) years from the date of the Original Deed (i.e., until December 2, 2019) (collectively, the “Original Covenants”); and

**WHEREAS**, the Original Grantee has improved the Property with a child care center with accessory parking; and

**WHEREAS**, IFF, an Illinois not-for-profit corporation (“IFF”), has acquired title to the Property pursuant to a judicial sales deed dated April 24, 2014, and recorded with the Recorder’s Office on May 8, 2014, as document number 1412816064; and

**WHEREAS**, Quad Communities Development Corporation, NFP, an Illinois not-for-profit corporation (“QCDC”), has proposed to purchase the Property from IFF; and

**WHEREAS**, QCDC has requested that the City consent to the release of the Original Covenants, subject to (1) QCDC’s recording a covenant running with the Property that for a period of seven (7) years requires the Property to be used solely for (a) the offices of and programming managed by QCDC (including any off-street parking serving such uses without charge) (b) the offices of and programming managed by those tenants listed on Exhibit B attached hereto (including any off-street parking serving such uses without charge) and (c) any other uses for which the Commissioner of the City’s Department of Planning and Development has given prior written consent, and further subject to (2) QCDC’s granting the City a right of reverter if such covenants are not satisfied (the new covenants, including the right of reverter, the “New Covenants”); and

**WHEREAS**, the City is agreeable to QCDC’s request that the City release the Original Covenants, subject to QCDC’s recording the New Covenants; now, therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** The foregoing recitals are hereby adopted as the findings of the City Council.

**SECTION 2.** The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a release of the Original Covenants; provided, however, that such release shall not become effective unless and until QCDC has recorded a document that encumbers the Property with the New Covenants.

**SECTION 3.** If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

**SECTION 4.** All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

**SECTION 5.** This ordinance shall take effect immediately upon its passage and approval.






