**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the District B3-1 Community Shopping District symbols and indications as shown on Map No. 5-1 in the area bounded by

A line 50.0 feet south of and parallel to West Cortland Street; North California Avenue; A line 75.0 feet south of and parallel to West Cortland Street; the north-south public alley west of and parallel to North California Avenue

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and approval.

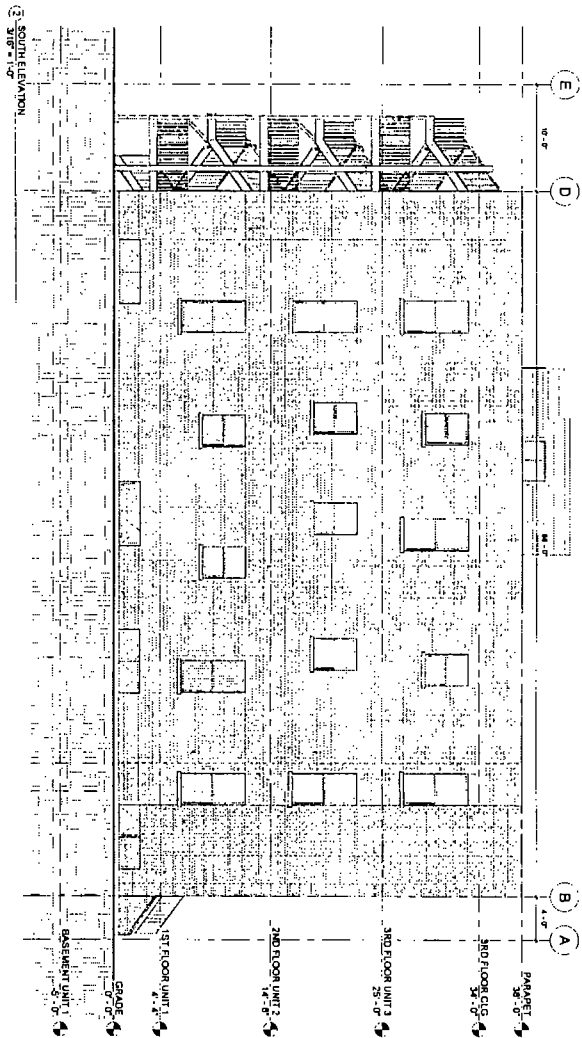




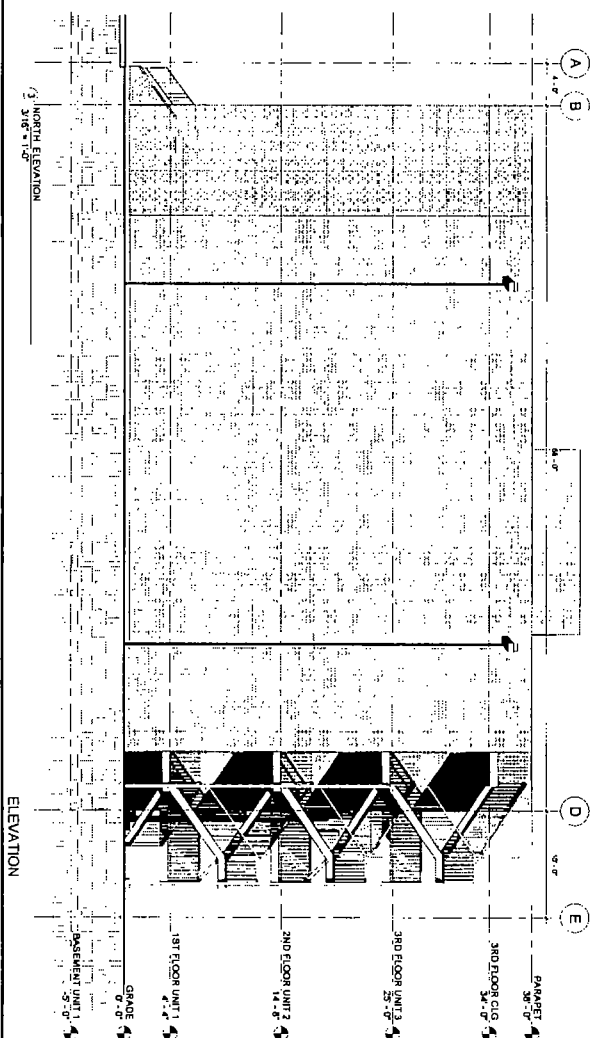
1 EAST ELEVATION

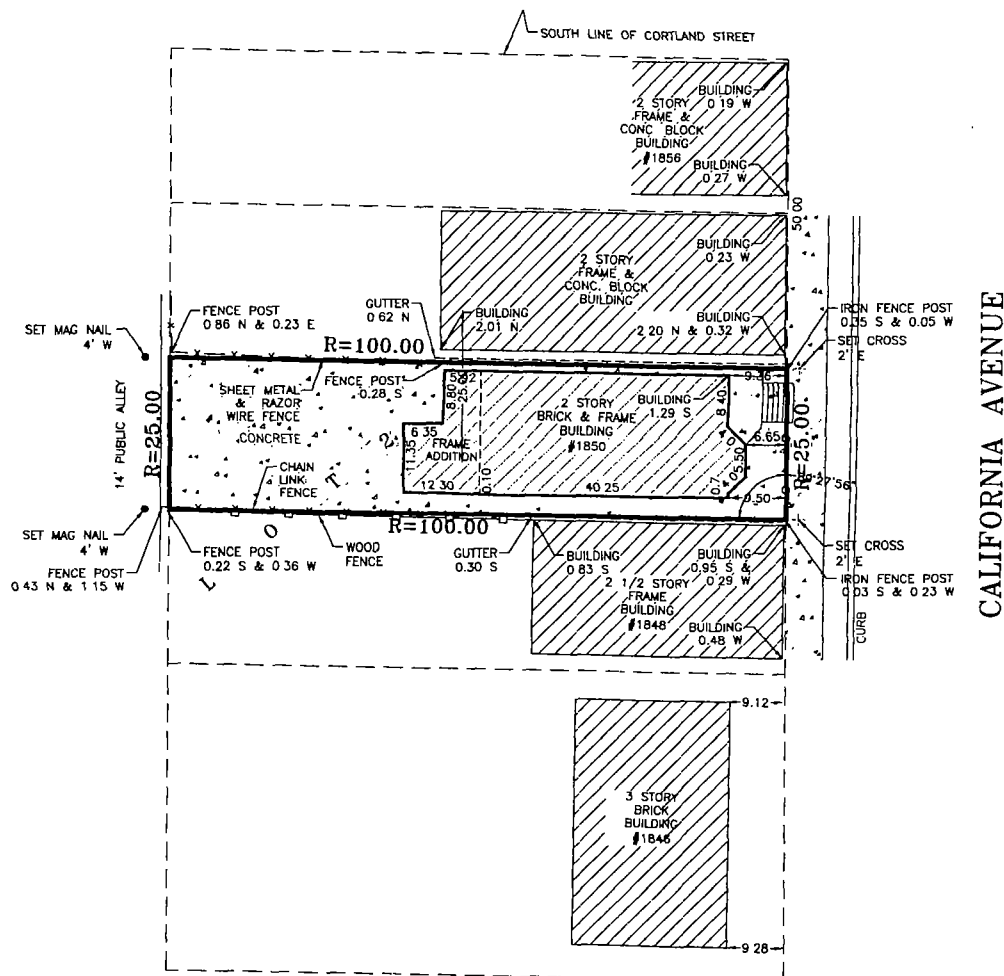

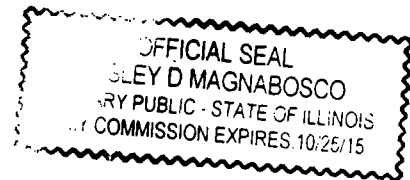

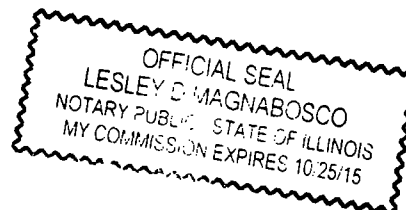
