BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning

Ordinance is hereby amended by changing all of the C1-1, Neighborhood Commercial

District symbols as shown on Map No. 14-F

in the area bounded by:

West 60th Street; the public alley next East of and parallel to South Wentworth Avenue; a line 257.19 feet South of and parallel to West 60th Street; South Wentworth Avenue.

To those of a C2-1, Motor Vehicle-Related Commercial District

SECTION 2. This Ordinance takes effect after its passage and approval.


