Be it Ordained by the City Council of the City of Chicago:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, be amended by changing the Residential Planned Development Number 990 designation as shown on Map Number 8–I in the area bounded by:

A line beginning at the western right-of-way of South Western Avenue extending westward along West 36th Street, 498.04 feet; a line beginning at the southerly right-of-way of West 36th Street extending southward along South Western Avenue, 442.46 feet; the Chicago and Alton Railroad line which is located immediately north of the Joliet and Chicago Railroad line; and the Chicago Junction Railway Company Line.

to the designation of a B3-3, Community Shopping District.

SECTION 2. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, be amended by changing the B3-3, Community Shopping District designation as shown on Map Number 8-I in the area bounded by:

A line beginning 132 feet west of the western right-of-way of South Western Avenue extending westward along West 36th Street, a line extending southward along the Chicago Junction Railway Company Line 113.86 feet; a line parallel to West 36th Street extending eastward 359.75 feet; a line extending north to 36th Street.

to the designation of RT3.5, Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 3. This ordinance shall be in force and effect from and after its passage and due publication.

You are receiving this letter because you own property within 250 feet of 3600-3636 South Western Avenue ("Property"), and this letter is part of the legal notice requirements of Chicago Zoning Ordinance Section 17-13-0107.

Please be informed that on or about April 8, 2015, 3600 Western Group, LLC will file an application with the City of Chicago for a change in zoning (also known as a Zoning Map Amendment) for the Property from Residential Business Planned Development 990 (RBPD 990) to B3-3 Community Shopping District. The purpose of the rezoning is to eliminate RBPD 990.

The owner also will apply to further change a portion of the Property from <u>B3-3</u> Community Shopping District to <u>RT 3.5</u> Residential Two-Flat, Townhouse and Multi-Unit District. The purpose of the rezoning of such portion of the Property will be to permit the development of ten single family homes facing 36th Street.

If the City determines that any information provided in this EDS is false, incomplete or inaccurate, any contract or other agreement in connection with which it is submitted may be rescinded or be void or voidable, and the City may pursue any remedies under the contract or agreement (if not rescinded or void), at law, or in equity, including terminating the Disclosing Party's participation in the Matter and/or declining to allow the Disclosing Party to participate in other transactions with the City.
