BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the C1-2 Neighborhood Commercial District symbols as shown on Map No. 18-H in the area bounded by:

West 73rd Street; the public alley East of and parallel to South Western Avenue; a line 124.93 feet South of and parallel to West 73rd Street; South Western Avenue.

To those of a C2-2, Motor Vehicle-Related Commercial District

SECTION 2. This Ordinance takes effect after its passage and approval.

The subject property is currently vacant. The Applicant needs a zoning change to allow an outdoor car sales business at the subject property.

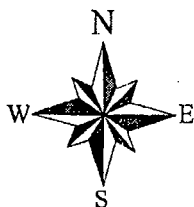

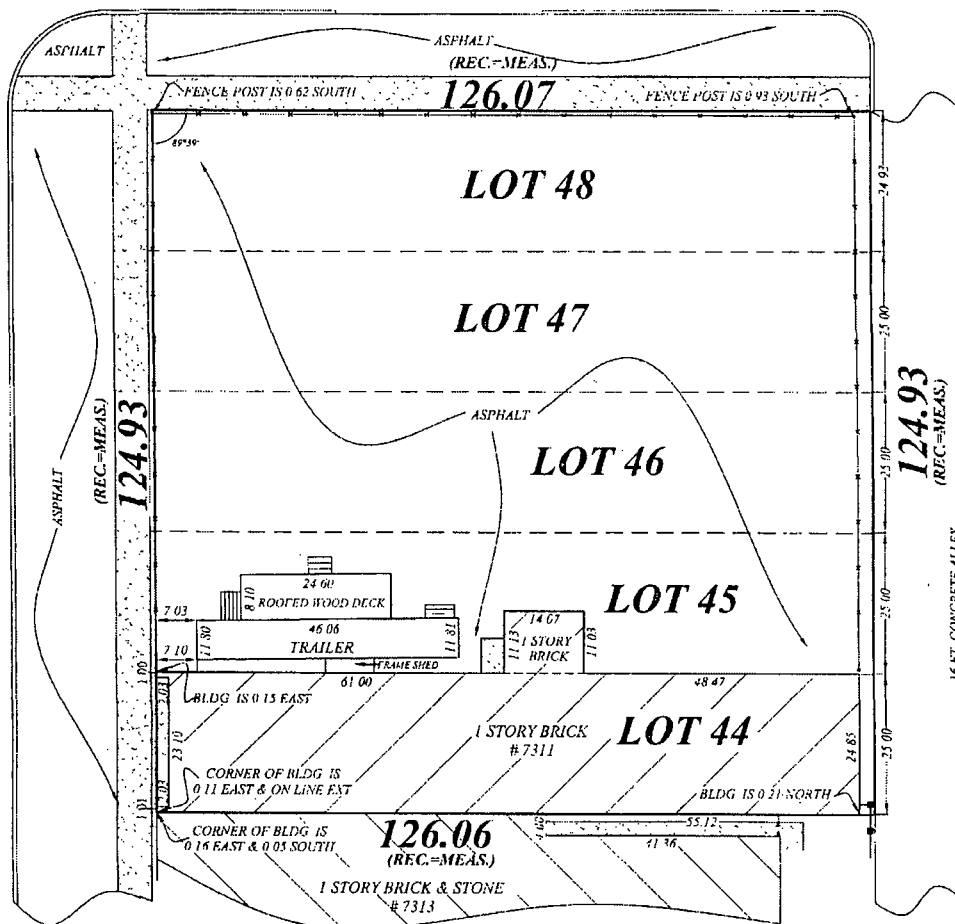
