ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District, as shown on Map 5-I in the area bounded by:

North Western Avenue, a line 240 feet South of West Wabansia Avenue, the alley west and parallel to North Western Avenue and a point 264 feet south of West Wabansia Avenue.

To those of **B2-3 Neighborhood Mixed-Use District**

SECTION 2. This ordinance takes effect after its passage and approval.




