### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the **B3-1 Community Shopping District.**, as shown on Map 7-I in the area bounded by:

North Elston Avenue, a line 81.26 feet Northwest of West Barry Avenue, the alley southwest and parallel to North Elston Avenue and a line 106.26 feet Northwest of West Barry Avenue.

To those of B2-3 Neighborhood Mixed-Use District

**SECTION 2.** This ordinance takes effect after its passage and approval.




