***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance,  
is hereby amended by changing all the B2-2 Neighborhood Mixed-Use District  
symbols and indications as shown on Map No.9-M in the area bounded by

the alley next north of and parallel to West Addison Street;  
North Menard Avenue; West Addison Street; and a line  
26.75 west of and parallel to North Menard Avenue,

to those of a C1-2 Neighborhood Commercial District and a corresponding uses district is  
hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage  
and due publication.

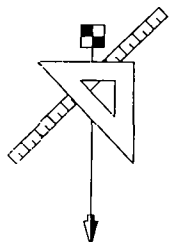
