### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RM-5 Residential Multi-Unit District symbols and indications as shown on Map No. 3-F in the area bounded by:

A line 571.09 feet north of and parallel to West Schiller Street; the public alley next east of and parallel to North Wieland Street; a line 491.09 feet north of and parallel to West Schiller Street; North Wieland Street

to those of a RM-5.5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.
