ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the **B3-1 Community Shopping District**, as shown on Map 7-I in the area bounded by:

West Fullerton Avenue, a line 121.20 feet east of North Talman Avenue, the alley north and parallel to West Fullerton Avenue and a line 145.24 feet east of North Talman Avenue.

To those of B2-2 Neighborhood Mixed Use District

SECTION 2. This ordinance takes effect after its passage and approval.



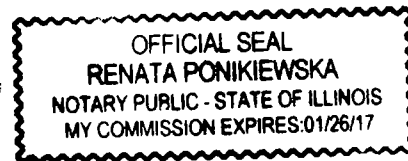



Please note that the Applicant is not seeking to rezone or purchase your property. The Applicant is required by law to send this notice because you own property within 250 feet of the property to be rezoned.

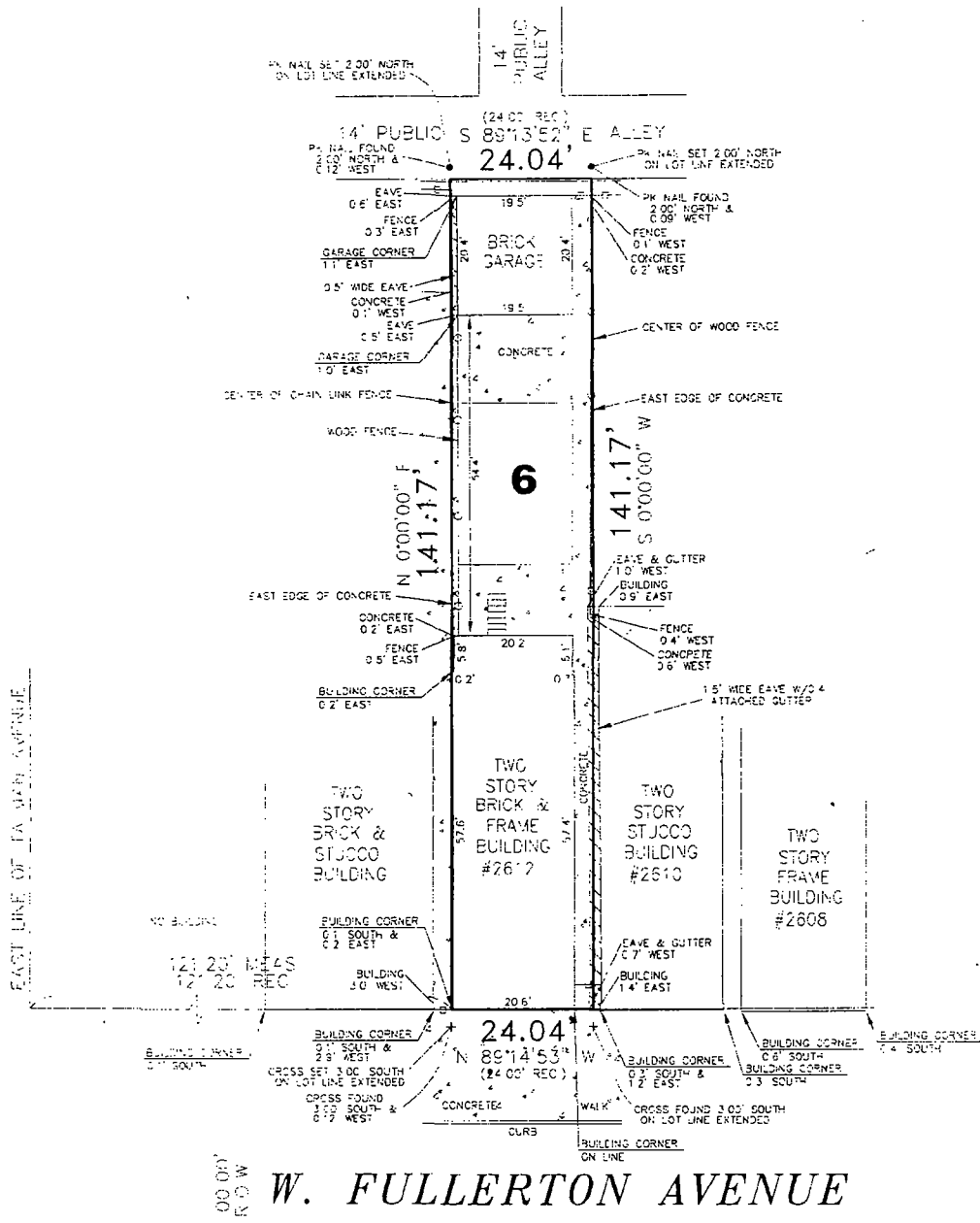
