ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 9-I in the area bounded by:

a line 250.00 feet south of West Byron Street; the alley next east of North Whipple Street; a line 275.00 feet south of West Byron Street; and North Whipple Street

to those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.


