<u>ORDINANCE</u>

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.15-M in the area bounded by

West Devon Avenue; a line 88 feet east of and parallel to North Mobile Avenue; the alley next south of and parallel to West Devon Avenue; and a line 43 feet east of and parallel to North Mobile Avenue.

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

THE GIANNOLA FAMILY TRUST DATED THE 18TH DAY OF MARCH, 2003.

SALVATORE J. GIANNOLA AND MARGUERITE R. GIANNOLA, GINA M. GIANNOLA and PETER A. GIANNOLA of Chicago, Illinois, hereby assign, transfer and deliver the property listed in the attached Exhibit "A" to SALVATORE J. GIANNOLA AND MARGUERITE R. GIANNOLA, AS COTRUSTEES OF THE GIANNOLA FAMILY TRUST DATED MARCH 18, 2003 (hereinafter "Trustee"), and as such Trustee agree to hold, manage and distribute said property and any other property added hereto, as a Trust Estate upon the following terms and conditions; provided however, if the successor Trustee cannot account for any property when examining the assets of the trust, the Trustee shall be deemed to have properly withdrawn and revoked such property from the Trust Estate.

ARTICLE I BENEFICIARY

The beneficiaries of this Trust are as follows:

- (1) SALVATORE J. GIANNOLA AND MARGUERITE R. GIANNOLA, AS COTRUSTEES OF THE SALVATORE J. GIANNOLA TRUST DATED AUGUST 4, 1998 and SALVATORE J. GIANNOLA AND MARGUERITE R. GIANNOLA, AS CO-TRUSTEES OF THE MARGUERITE R. GIANNOLA TRUST DATED AUGUST 4, 1998 as to an undivided 1/3 interest;
- (2) GINA M. GIANNOLA as to an undivided 1/3 interest;
- (3) PETER A. GIANNOLA as to an undivided 1/3 interest.

Each of the Beneficiaries shall have the right and privilege to occupy the premises as such beneficiary's principal residence, and the amount of space occupied by each beneficiary shall be equal to one apartment unit. The failure of any beneficiary to occupy the premises shall not entitle that beneficiary to net income in excess of that beneficiary's proportionate beneficial interest. However, those beneficiaries who occupy the premises shall contribute equally to the operational and ownership expenses of the property.

The net income from operation of the property shall be shared equally by the beneficiaries in proportion to their respective beneficial interest.

Any undistributed net income shall be added to principal periodically in the Trustee's sole discretion.

ARTICLE II OWNERSHIP INTEREST

Each beneficial owner acknowledges and agrees that each beneficiary has contributed equal value into the trust and shall share ownership in equal shares.

ARTICLE III DISTRIBUTION

Upon my death of Salvatore Giannola or Marguerite Giannola, that beneficiary's interest shall be transferred pursuant to the terms of the underlying above named beneficiary trust. In the event such trust has been revoked or otherwise does not exist, than the interest of Salvatore Giannola or Marguerite Giannola shall pass first to each other if living. Upon the death of any other beneficiary, and upon the passing of the survivor of Salvatore Giannola and Marguerite Giannola when the underlying above named beneficiary trust does not exist, than the decedent's interest shall pass to the decedent's descendants per stirpes and not per capita.

ARTICLE IV SPENDTHRIFT PROVISION

No income or principal distributable or to become distributable with respect to this trust shall be transferable, assignable or subject to being anticipated in any manner whatsoever, charged or encumbered by any person beneficially interested in this trust, or subject to any claim for maintenance or for the support of a spouse pursuant to a decree or separation agreement, or to being taken or reached by any legal or equitable process in satisfaction of any debt, liability or obligation of said person prior to its receipt by said persons; provided, however, that the provisions of this Article shall not prevent the exercise of, or transfer pursuant to the exercise of, any power of appointment granted hereunder.

ARTICLE V TRUSTEE'S POWERS

The Trustee is hereby given full power:

- A. To sell and exchange the trust property;
- B. To register and hold property in the name of the Trustee or in the name of a nominee or in bearer form:
- C. To invest trust funds in any property, real, personal or mixed, as the Trustee deems wise without being limited by any statute or rule of law regarding investments by Trustees, regardless of any lack of diversification.
- D. To determine whether receipts or disbursements shall be credited to or charged against income or principal;

- E. To pay all costs, taxes, expenses and charges in connection with the administration and distribution of any trust hereunder, including reasonable compensation to the counsel and agents of the Trustee, and to delegate to them such powers as the Trustee deems advisable;
- F To make distributions of the Trust Estate which are payable to any person under a legal disability, to the legal or natural guardian of such person, to the conservator of such person, directly to such person, to any person shall have the care of custody of such person, to a custodian under the Illinois Uniform Transfers to Minors Act, or by the Trustee expending the same directly for such person, and the receipt of such person(s) shall be a complete discharge to the Trustee hereunder, and;
- To improve, manage, protect and subdivide any real estate, comprising the Trust Estate, or G. any part thereof, to dedicate parks, streets, highways or alleys and to vacate any subdivision or part thereof and to resubdivide the same as often as desired, to contract to sell, to grant options to purchase, to sell on any terms, to convey either with or without consideration to convey said premises or any part thereof, to a successor or successors in trust, and to grant to such successor or successors in trust all of the title, estate, powers and authorities vested in the Trustee, to donate, to dedicate, to mortgage, pledge or otherwise encumber any such property, or any part thereof, to lease any such property or any part thereof, from time to time in possession or reversion by leases to commence in praesenti or in futuro and upon terms and for any period or periods of time, not exceeding, in the case of any single demise, the term of ninety-nine (99) years, and to renew or extend leases upon any terms and for any period or periods of time and to amend, change or modify leases and the terms and provisions thereof at any time or times hereafter, to contract to make leases and to grant options to purchase the whole or any part of the reversion and to contract respecting the manner of fixing the amount of present on future rentals, to partition or to exchange said property, or any part thereof, for other real or personal property, to grant easements appurtenant to any property, or any part thereof, and to deal with any such property, and every part thereof, in all other ways and for such other considerations as it would be lawful for any person owning the same to deal with the same whether similar to or different from the ways above specified, at any time or time thereafter; and;
- H. Each Co-Trustee, if any may act individually without the authorization of the other Co-Trustee and on behalf of this Trust, with full power and authority to bind this Trust.

ARTICLE VI PRINCIPAL RESIDENCE

It is understood and agreed by all beneficiaries that each beneficiary's ownership interest is ownership interest in the real estate at 6253 W. Devon, Chicago Illinois, which each beneficiary intends to use, and currently uses as their principal residence. For purposes of income tax treatment, this trust is a Grantor Trust as defined and intended pursuant to the Internal Revenue Code.

ARTICLE VII RESIGNATION OF TRUSTEE

Any Trustee may resign by delivering written notice to me and to the successor Trustee hereunder, if any. The successor Trustee, may approve the accounts of and give a complete release and discharge to any resigned Trustee or to the estate of any deceased Trustee hereunder.

ARTICLE VIII SUCCESSOR TRUSTEE

Upon the death, resignation or disability of SALVATORE GIANNOLA or MARUERITE GIANNOLA, than the survivor of them shall act as sole trustee. Upon the death, resignation or disability of both SALVATORE GIANNOLA and MARGUERITE GIANNOLA, than PETER GIANNOLA and GINA GIANNOLA shall act as Co-Trustees ("Trustee") of this Trust, with all rights and powers of the Trustee hereunder. If for any reason either PETER GIANNOLA or GINA GIANNOLA shall become unable or refuse to act as Trustee, than the other of them shall act as the sole Trustee who shall enjoy all rights and powers of the Trustee hereunder. With respect to the determination of the ability of any person to continue to act as a Trustee herein, it shall be made by such Trustee's then attending physician and the successive Successor Trustee, if any.

In the event there shall be no Trustee acting hereunder then such person or persons or Trust Company as shall have been appointed by written instrument executed by the named Trustee or any Successor Trustee herein, and which shall be the latest in point or time, shall become Successor Trustee hereunder. No successor Trustee shall be liable or responsible for any acts or defaults of any predecessor Trustee or for any losses or expenses resulting from or occasioned by anything done or neglected to be done in the prior administration of the Trust Estate or be required to inquire into or take any notice of such prior administration. The term "Trustee" shall include any successor Trustee acting at any time hereunder and shall include the plural.

ARTICLE IX REVOCABILITY

SALVATORE GIANNOLA and MARGUERITE GIANNOLA hereby reserve the right from time to time by written notice delivered to all the beneficiaries of the Trust and to the Successor Trustee, if any, to amend or revoke this instrument and the trust hereby evidenced, in whole or in part, except that the duties, powers and responsibilities of any Trustee shall not be changed without the written consent of the then acting Trustee and the interest and rights of any beneficiary shall not be changed without the written consent of the affected beneficiary.






