ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the DX-7 Downtown Mixed Use District symbols and indications as shown on Map 2-F in the area bounded by:

West Harrison Street; a line 220 feet west of and parallel to North Wells Street; a line 306.25 feet south of and parallel to West Harrison Street; North Wells Street; West Polk Street; and the east boundary line of the South Branch of the Chicago River;

to those of a Waterway Residential Business Planned Development subject to the statements and bulk regulations and data table attached hereto.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and publication.

WATERWAY RESIDENTIAL BUSINESS PLANNED DEVELOPMENT NO. TBD

- 1. The area delineated herein as Waterway Residential Business Planned Development Number ("Planned Development") consists of approximately 282,710 square feet of net site area (after right-of-way adjustments contemplated herein) together with certain portions of adjacent rights-of-way, as depicted on the attached Planned Development Boundary and Property Line Map ("Property"). 1000 S. Wells (Chicago), LLC (the "Applicant") is the owner of a portion of the Property and has requested this Planned Development with the authorization of the owner of the remainder of the property, Franklin Point Equities, LLC. This Planned Development is divided into Subareas (each, a "Subarea" and collectively, the "Subareas") as indicated on the attached Subarea Map.
- 2. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation ("CDOT") on behalf of the Applicant or its successors, assign or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Department of Planning and Development (the "Department") and CDOT. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of CDOT.

All work proposed in the public way must be designed and constructed in accordance with the CDOT Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by CDOT.

3. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessees. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal title holder and any ground lessees. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control for purposes of this statement shall mean that any application to the City for any amendment to this Planned Development or any other modification or change thereto (administrative, legislative or otherwise) shall be made or

authorized by all the owners of the Property and any ground/air-rights lessors of the Property, subject, however, to the following exceptions and conditions: (a) any changes or modifications to this Planned Development applicable to or in a given subarea need only be made or authorized by the owners and/or any ground/air-rights lessors of such subarea; provided, however, that for so long as the Applicant or any affiliate thereof owns or controls any part of the Property, any application to the City for any such changes or modifications (administrative, legislative or otherwise) must in all cases be additionally authorized by the Applicant and (b) where portions of the improvements located on the Property have been submitted to the Illinois Condominium Property Act, the term "owner" shall be deemed to refer solely to the condominium association of the owners of such portions of the improvements and not to the individual unit owners therein. Nothing herein shall prohibit or in any way restrict the alienation, sale or any other transfer of all or any portion of the Property or any rights, interests or obligations therein including any ground or air-rights leases. Upon any alienation, sale or any other transfer of all or any portion of the Property or the rights therein including any ground or air-rights leases (but not including an assignment or transfer of rights pursuant to a mortgage or otherwise as collateral for any indebtedness) and solely with respect to the portion of the Property so transferred. the term "Applicant" shall be deemed amended to apply to the transferee thereof (and its beneficiaries if such transferee is a land trust) and the seller or transferor thereof (and its beneficiaries if such seller or transferor is a land trust) shall thereafter be released from any and all obligations or liability hereunder; provided, however that the Applicant's right to authorize changes or modifications to this Planned Development for so long as it owns or controls all or any portion of the Property as set forth in clause (a) of this Statement Number 3 above shall not be deemed amended or transferred to apply to a transferee (or its beneficiaries as aforesaid) unless expressly assigned in a written instrument executed by the original Applicant hereunder.

- 4. This Plan of Development consists of these 18 Statements, a Bulk Regulations Table and the following plans all prepared by Perkins + Will dated ______ (collectively, the "Plans"):

Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

- 5. The following uses are permitted in this Planned Development: All uses allowed in the DX-7 Downtown Mixed-Use District, including, but not limited to, the following:
 - a. Residential uses (both on and above the ground floor):
 - i. Artist and Business Live/Work Space
 - ii. Multi-Unit residential
 - iii. Elderly Housing
 - iv. Assisted Living
 - v. Nursing Home
 - b. Public and Civic Uses:
 - i. Cultural Exhibits and Libraries (including, without limitation, museums)
 - ii. Day Care
 - iii. Parks and Recreation (including, without limitation, community centers, recreation buildings and similar assembly uses)
 - iv. Public Safety Services
 - v. Religious Assembly
 - vi. School
 - c. Business and Commercial Uses
 - i. Animal Services
 - ii. Artist Work or Sales Space
 - iii. Building Maintenance Services
 - iv. Business Support Services (except Day Labor Employment Agency)
 - v. Communication Service Establishment
 - vi. Eating and Drinking Establishments
 - vii. Financial Services
 - viii. Food and Beverage Retail Sales
 - ix. Lodging (Hotel/Motel and Vacation Rental)
 - x. Medical Service
 - xi. Office
 - xii. Accessory and Non-Accessory Parking

- 6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department. Off-Premise signs are prohibited within the boundary of the Planned Development.
- 7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
- 8. The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance with the attached Bulk Regulations Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of 282,710 square feet.
- 9. The Applicant shall obtain approvals from MWRD as may be required in order to release any stormwater from the development into the Chicago River. Stormwater detention facilities on the property shall be privately owned and maintained.
- 10. The Applicant acknowledges the importance of the Chicago River as a resource for both commerce and recreation and also acknowledges the City's goals of improving the appearance, quality and accessibility of the river, as contained in the waterway planned development guidelines contained in the Zoning Ordinance (Section 17-8-0912) and the Chicago River Corridor Design Guidelines and Standards. To further these goals, the Applicant agrees, as set forth in the Plans, to: (a) provide a minimum 30-foot building setback from the river as measured from the legal property line, which will include a continuous riverwalk as shown on the Landscape Plans, not including encroachments for structural columns or other structural support necessary for extending buildings and other building elements above the riverwalk beginning at a height of three (3) stories minimum above the lowest finished floor and extending to the top of such improvements, and will be landscaped in accordance with the Plans, and (b) permit connection of such riverwalk and landscaping with similar facilities on adjacent properties when adjacent properties are improved or redeveloped. The Applicant shall permit un-gated public access to the river setback and provide signage on the riverwalk indicating that the riverwalk is open to the public during typical Chicago Park District hours. All riverwalk and landscaping improvements within the river setback must be substantially completed within eighteen (18) months of the issuance of all necessary permits by all governmental or quasi-governmental authorities having jurisdiction over such improvements including, without limitation, the Army Corps of Engineers, Metropolitan Water Reclamation District, IDNR-OWR, Coast Guard and CDOT, and provided that planting may be delayed due to delays or inability to perform such acts due to causes beyond the reasonable control of the Applicant such as,

without limitation, war, riot, insurrection, rebellion, strike, lockout, fire, flood, storm, earthquake, tornado, unavoidable casualty or damage to personnel, material or equipment, or act of God, and provided that completion may be delayed if consistent with good landscape practice or if necessary to accommodate construction of later phases of development, but not longer than one year following receipt of the final occupancy certificate.

- 11. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
- 12. The Plans are deemed to be in conformance with the Landscape Ordinance and other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
- 13. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Environment and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.
- 14. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to Section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessees, subject to Statement 3 above.

Specifically, but without limitation, at the request of the owner(s) of the affected subarea(s), and, if then applicable, with the additional consent of the Applicant pursuant to Statement 3 above, the Zoning Administrator is authorized to approve changes to: (a) sub-area boundaries; (b) allocations of FAR floor area, dwelling units and other development rights among and between sub-areas of not more than fifteen percent (15%) of each of the applicable bulk regulations (e.g., a transfer of not more than 94 dwelling units from Subarea A to Subarea B or a transfer of not more than 76640 square feet of FAR floor area from Subarea B to Subarea C); (c) minimum parking requirements; (d) other changes to the Bulk Regulations and Data Table; and (e) site plans, landscape plans, building elevations and other Plans; provided that such changes shall not result in an increase measured over the entirety of this Planned Development in the overall maximum total FAR or total number of dwelling units as set forth in the Bulk Regulations and Data Table.

At the time of the approval of this Planned Development, all improvements on the Property are intended to be primarily residential buildings. To the extent that the Applicant desires to

change any of the buildings from primarily residential to primarily non-residential, such change shall be approved administratively pursuant to Section 17-13-0611-A. For purposes of example, an office or hotel building may be built instead of a residential building as long as approved administratively as set forth herein.

- 15. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
- 16. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all new buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. At the time of site plan approval, all new buildings must demonstrate substantial compliance with the current City of Chicago Sustainable Development Policy set forth by the Planning and Development.
- 17. As contemplated by Section 17-13-0612 of the Chicago Zoning Ordinance, construction of the improvements contemplated by this Planned Development will be completed in phases. Unless construction of the improvements in one subarea (which includes at least one residential building) has commenced within six years following adoption of this Planned Development (subject to extension for one additional year as set forth in Section 17-13-0612 of the Chicago Zoning Ordinance), then this Planned Development shall expire, and the zoning of the Property shall automatically revert to the DX-7 Downtown Mixed-Use District. Notwithstanding any provisions of Section 17-13-0612 to the contrary, the completion of the improvements in a subarea as evidenced by the issuance of a certificate of occupancy shall be deemed to vest for purposes of this Statement 17 and Section 17-13-0612.
- 18. The Applicant acknowledges and agrees that, as a planned development in a downtown zoning district, the development triggers Section 2-45-110(b)(4)(iii) of the Municipal Code (the "Affordable Requirements Ordinance" or "ARO"). Any developer of a "residential housing project" within the meaning of the ARO ("Residential Project") must: (i) develop affordable housing units as part of the Residential Project; (ii) pay a fee in lieu of the development of affordable housing units; or (iii) any combination of (i) and (ii). Pursuant to Section 2-45-110(b)(4)(iii), the Applicant may elect to satisfy the ARO requirements by complying with the affordable housing floor area bonus provided for in Section 17-4-1004. Applicant has elected to comply with Section 17-4-1004. Pursuant to Section 17-4-1004-B of the Zoning Ordinance, the Applicant has requested an increase in the floor area ratio, as set forth in the bonus worksheet required under Section 17-4-1003-D and attached hereto as Exhibit [___] ("Bonus Worksheet"). In accordance with the formulas set forth in Section 17-4-1004-C and the Bonus Worksheet, the Applicant acknowledges and agrees that it must

provide, at the Applicant's option, affordable units in one or more of the buildings in this Planned Development ("Eligible Building") consisting of at least 123,686 square feet of floor area (the "Affordable Units"), make a cash payment in lieu of providing affordable housing in the amount of Eight Million Seven Hundred Seven Thousand Four Hundred Sixty-Eight and 00/100 Dollars (\$8,707,468) ("Cash Payment") or a combination of providing affordable units and making the Cash Payment, in which event the amount of Affordable Units and Cash Payment required shall be adjusted to account for the combination selected. The Cash Payment shall be prorated among the buildings to be constructed on the Property. The portion of the Cash Payment due for each building shall be determined by multiplying the Cash Payment by a fraction, the numerator of which is the floor area in the subject building and the denominator of which is the total floor area permitted in this Planned Development (the "Pro Rata Cash Payment"). For purposes of example, if the building in Subarea A contains 636,185 square feet of floor area, the Cash Payment due for such building would be \$2,239,370.75 (\$8,707,468 * (636,185 / 2,473,713)).

Prior to the issuance of any building permits for an Eligible Building, including, without limitation, excavation or foundation permits, the Applicant must either make the required Cash Payment (which shall be prorated as set forth herein) or provide a performance bond or other security in the amount of the Cash Payment ensuring construction of the Affordable Units. If the Applicant elects to construct the Affordable Units for some or all of the buildings constructed on the Property or for all or part of the obligations under the ARO imposed hereunder, it must also enter into an Affordable Housing Agreement with the City pursuant to Section 17-4-1004-E9 prior to the issuance of any building permits for the Eligible Building, including, without limitation, excavation or foundation permits. The terms of the Affordable Housing Agreement and any amendments thereto are incorporated herein by this reference. The Applicant acknowledges and agrees that the Affordable Housing Agreement will be recorded against the Eligible Building and will constitute a lien against each Affordable Unit in an amount equal to the pro rata portion of Pro Rata Cash Payment attributable to the floor area of the Affordable Unit. The City shall execute partial releases of the Affordable Housing Agreement prior to or at the time of the sale of each Affordable Unit to an income-eligible buyer at an affordable price, subject to the simultaneous execution and recording of a mortgage, restrictive covenant or similar instrument against such Affordable Unit. In addition to the Affordable Housing Agreement, the Applicant acknowledges and agrees that, pursuant to Section 17-4-1003-D3, the Bonus Worksheet will serve as an official record of bonuses and amenities. The Applicant must comply with the applicable affordable housing standards and requirements set forth in Section 17-4-1004, the terms of which are incorporated herein by this reference. Notwithstanding anything to the contrary contained in Section 17-4-1003-E, the Commissioner of the Department may enforce remedies for breach of the Affordable Housing Agreement, and enter into settlement agreements with respect to any such breach, subject to the approval of the Corporation Counsel, without amending the Development. Dear Sir or Madam:

As required by Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about June 10, 2015, the undersigned, on behalf of 1000 S. Wells (Chicago), LLC (the "Applicant"), intends to file an application to rezone the property located at 650-658 S. Wells and 700-758 S. Wells; 223-313 W. Harrison Street; 301-321 W. Polk Street and 201-249 W. Polk Street, Chicago, Illinois from the DX-7 Downtown Mixed-Use District to a Waterway Residential-Business Planned Development. A map of the development site is printed on the reverse side of this letter.

The development site is currently vacant. The Applicant seeks approval of plans for a residential/mixed-use project containing multiple buildings to be constructed in phases. The project will include an overall maximum 8.75 FAR and approximately 2,700 residential dwelling units. The project will include residential, public and civic, commercial and recreational uses, parking, and accessory and incidental uses.

The proposed change of zoning does *not* apply to your property. You are receiving this notice as required by the Chicago Municipal Code because the Cook County Assessor's records indicate that you own property within 250 feet of the development site.

I am an authorized representative of the Applicant and my address is 203 North LaSalle Street, Suite 1900, Chicago, IL 60601. The Applicant, which is a venture of CMK Companies Ltd. and Lend Lease River South Properties LLC, owns a portion of the development site and has an address of c/o CMK Companies, 225 W. 
