SECTION 1. Permission and authority are hereby given and granted to SOUTH WELLS PLACE, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use twenty-four (24) Balcony(s) projecting over the public right-of-way adjacent to its premises known as 839 S. Wells St..

The grantee shall pay to the City of Chicago as compensation for the privilege #1117579 herein granted the sum of one thousand eight hundred (\$1,800.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
