SUBSTITUTE ORDINANCE

WHEREAS, the Annual Appropriation Ordinance for the year 2015 (the "2015 Appropriation Ordinance") of the City of Chicago (the "City") contains estimates of revenues receivable as grants from agencies of the state and federal governments and public and private agencies; and

WHEREAS, in accordance with Section 8 of the 2015 Appropriation Ordinance, the heads of various departments and agencies of the City have applied to agencies of the state and federal governments and public and private agencies for grants to the City for various purposes; and

WHEREAS, the City through its Department of Public Health ("Health") has been awarded additional federal grant funds in the amount of \$3,068,000 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention ("CDC") which shall be used for the Building and Strengthening Epidemiology and IT Capacity — Ebola Supplemental Program (the "BSE Grant"); and

WHEREAS, the City through Health has been awarded federal grant funds in the amount of \$61,000 by the Illinois Department of Public Health which shall be used for the Child and Adult Care Food Program; and

WHEREAS, the City through Health has been awarded federal grant funds in the amount of \$2,636,000 by United States Department of Health and Human Services, Assistant Secretary for Preparedness & Response which shall be used for the Hospital Preparedness Program (HPP) Ebola Preparedness and Response Activities Program; and

WHEREAS, the City through its Department of Family and Support Services ("DFSS") has carryover private grant funds in the amount of \$112,000 from various private contributors which shall be used for the Foster Grandparent Program; and

WHEREAS, the City through DFSS has carryover private grant funds in the amount of \$49,000 from various private contributors which shall be used for the Senior Companion Program; and

WHEREAS, the City through DFSS has been awarded additional federal grant funds in the amount of \$1,744,000 by the United States Department of Housing and Urban Development which shall be used for the Shelter Plus Care Program; and

WHEREAS, the City through its Department of Police has been awarded federal grant funds in the amount of \$210,000 by the Research Triangle Institute International which shall be used for the National Crime Statistics Exchange Program; and

WHEREAS, the City through its Office of Emergency Management and Communications ("OEMC") has been awarded federal grant funds in the amount of \$373,000 by the Illinois Emergency Management Agency which shall be used for the Urban Areas Security Initiative; and

WHEREAS, the 2015 Appropriation Ordinance included an appropriation of \$9,345,627 in
