BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-1, Neighborhood Commercial District symbols and indications as shown on Map No. 1-G in area bound by

A line 100.46 feet east of and parallel to north Carpenter Street, a line 100.57 feet north of and parallel to west Lake Street, a line 125.64 feet east of and parallel to north Carpenter Street, West Lake Street

to those of a C1-2, Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.
