#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3, Residential Single-Unit (Detached House) District symbols and indications as shown on Map No 10-I in area bound by

South California Avenue, a line 170.54 feet south of and parallel to west 42<sup>nd</sup> Street, the alley next east of and parallel to south California Avenue, a line 200.54 feet south of and parallel to west 42<sup>nd</sup> Street

to those of a RT4, Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.




