ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Community Shopping District symbols and indications as shown on Map No. 13-I in the area bounded by

North Lincoln Avenue, a line perpendicular to North Lincoln Avenue, 200.04 feet northwest of west Winnemac Avenue, the alley next northeast of and parallel to North Lincoln Avenue, a line perpendicular to north Lincoln Avenue 150.00 feet southeast of and parallel to west Winnemac Avenue

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.




TWO-WAY TRAFFIC






SECOND FLOOR PLAN






ROOF DECK AND PENTHOUSE PLAN




WEST ELEVATION






