ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the B1-2 Limited Manufacturing/Business District symbols and indications as shown on Map No. 13-G in the area bounded by:

A line 198.70 feet north of and parallel to the north line of West Argyle Street;
The alley next east of and parallel to North Broadway Street;
The alley next north of and parallel to West Argyle Street;
The alley next east of and parallel to North Broadway Street;
A line 98.70 feet north of and parallel to the north line of West Argyle Street;
North Broadway Street

to those of a C2-5 Commercial, Manufacturing and Employment District.

SECTION 2: This ordinance shall take effect upon its passage and due publication.



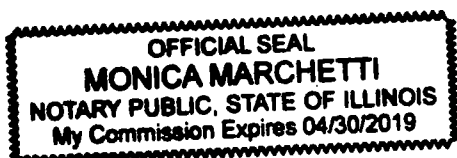

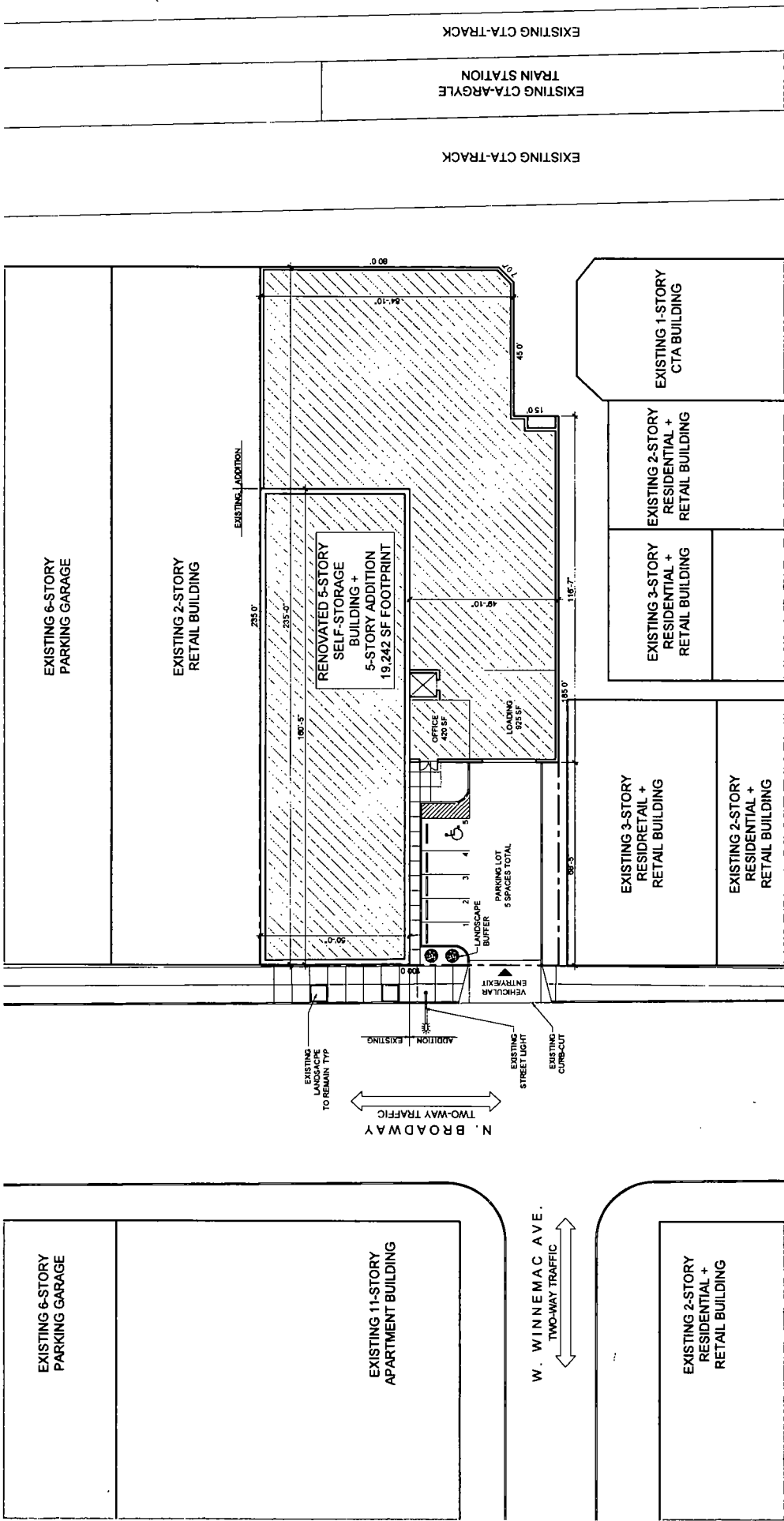
The Applicant seeks a change in zoning from B1-2 Neighborhood Shopping District to C2-5 Motor Vehicle-Related Commercial District, to allow residential self-storage as a permitted use (although self-storage is currently allowed as a lawful nonconforming use), and thereby facilitate the expansion of an existing self-storage building.

The Applicant proposes to expand an existing five-story, 41,560 square foot self-storage building (and adjacent parking lot) to an expanded 60’ high, 76,800 s.f. self-storage building (and adjacent parking lot).

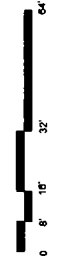

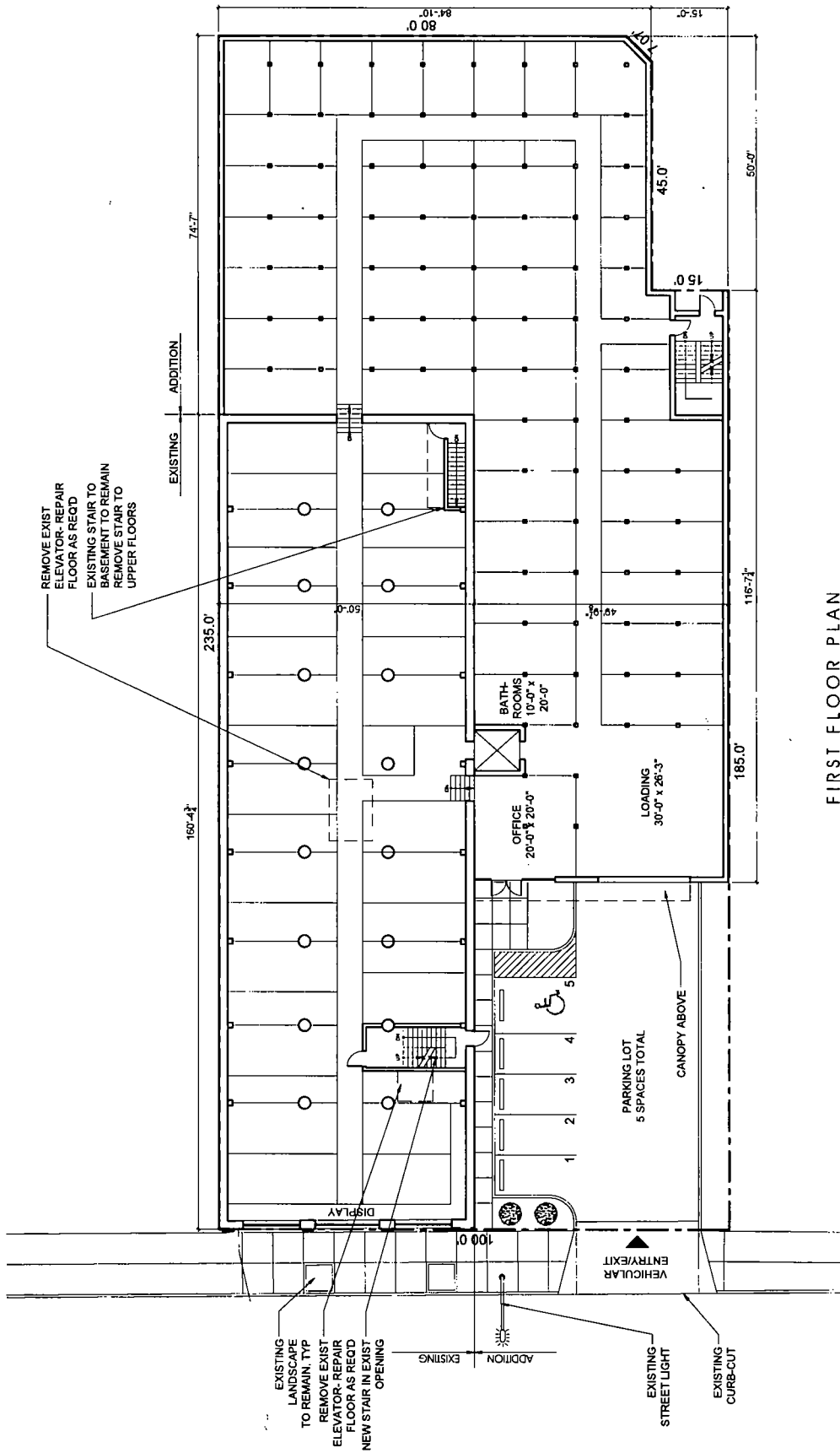
SITE PLAN-

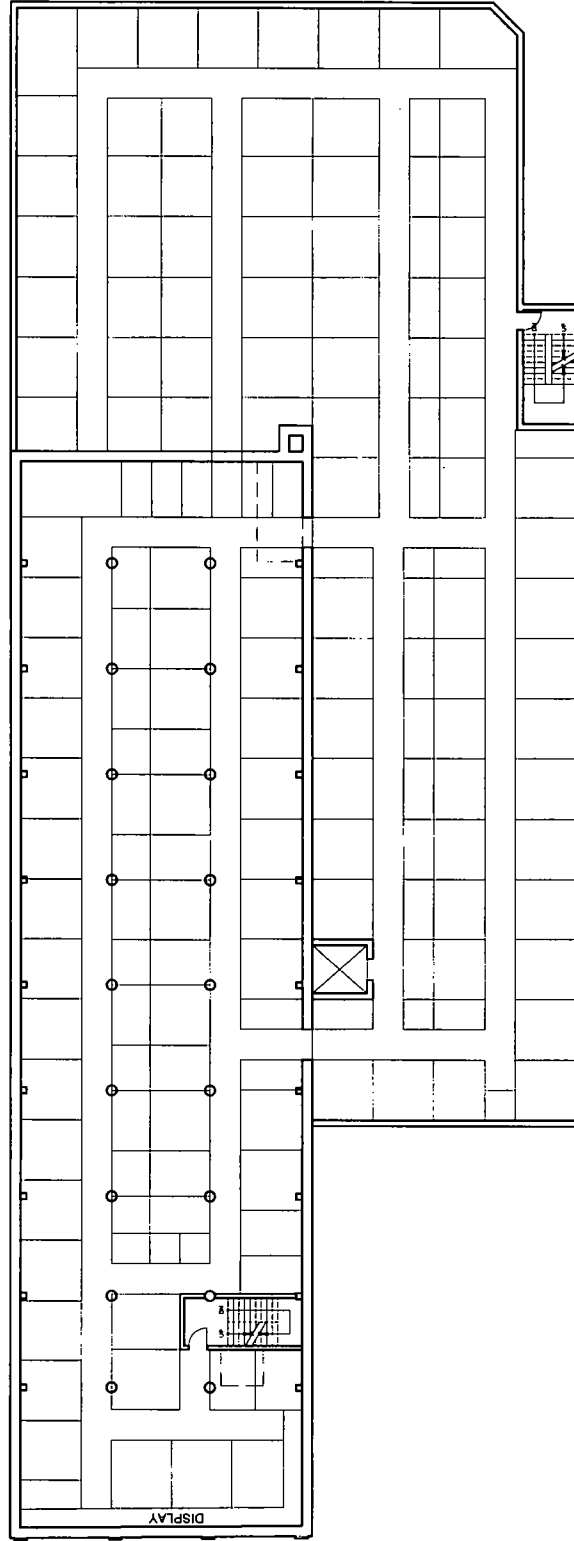

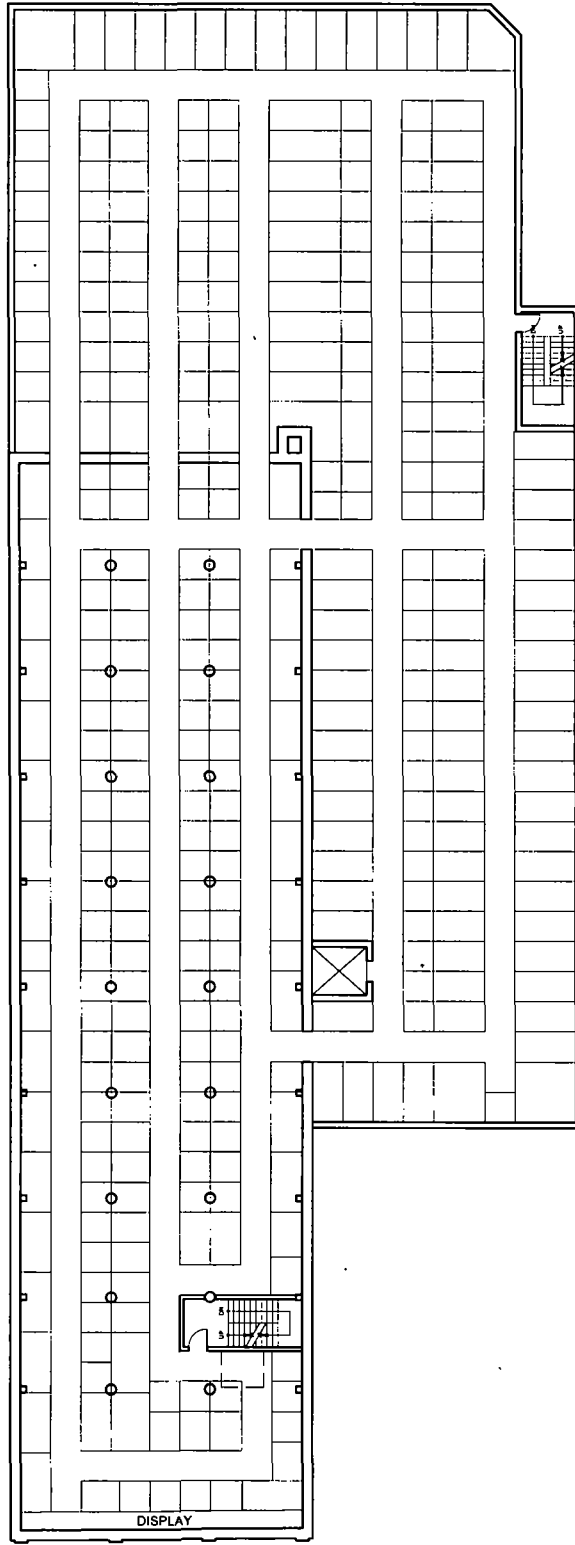

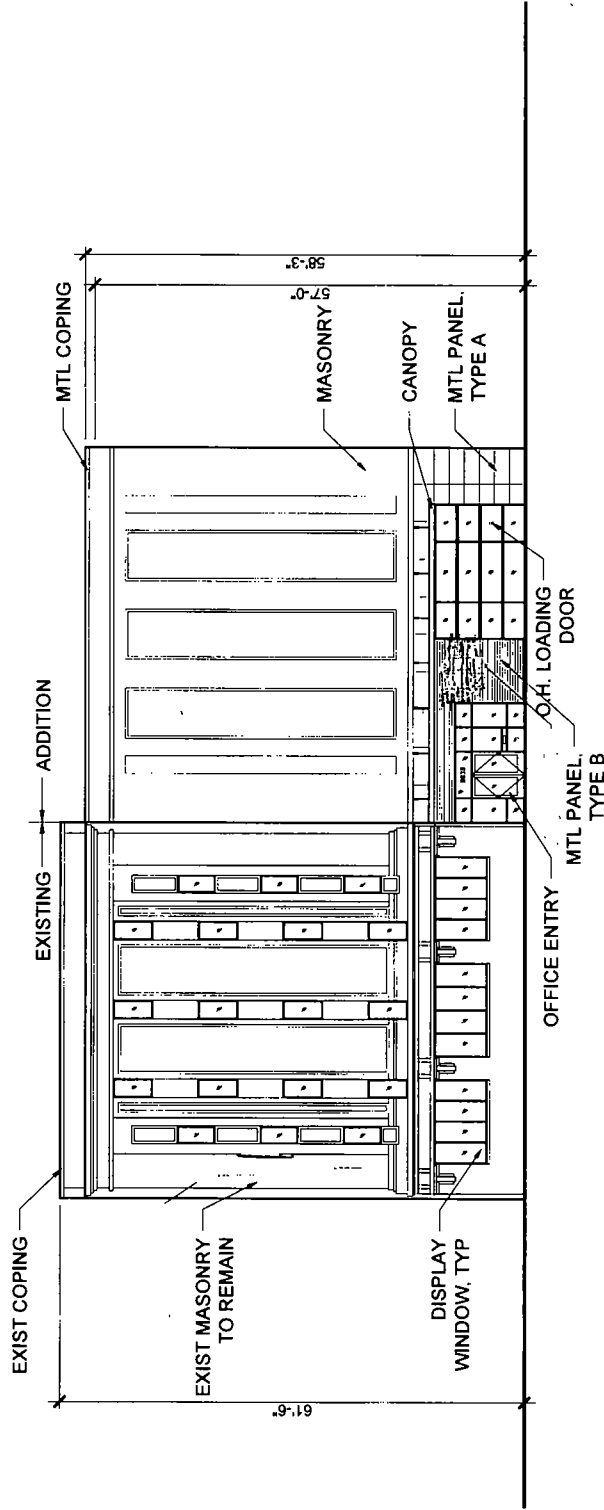

WEST ELEVATION

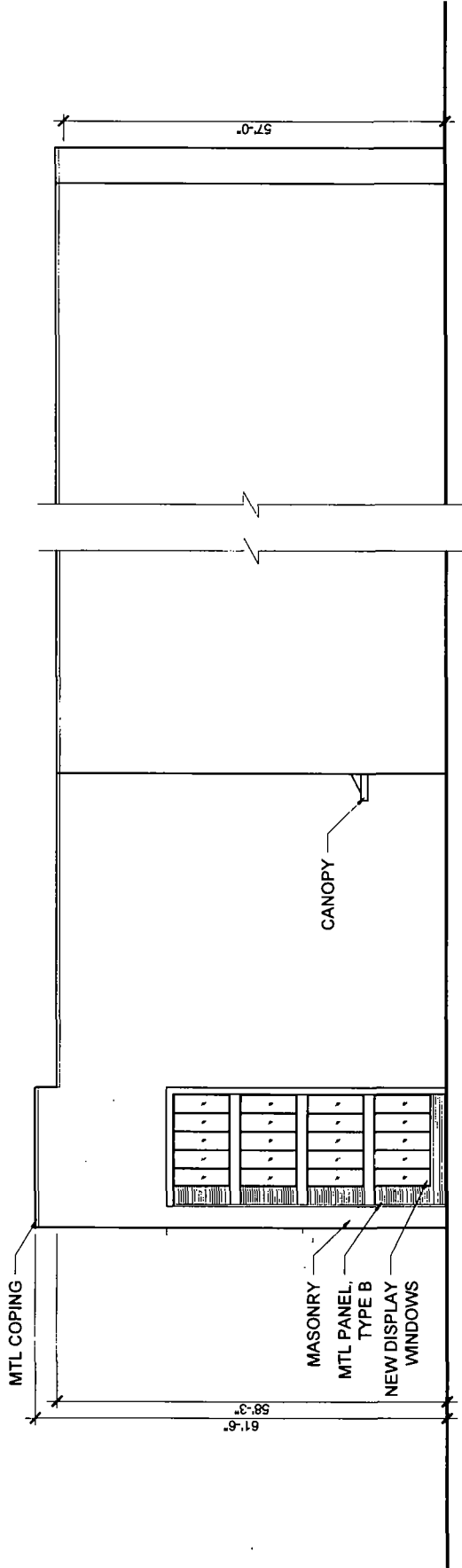
