WHEREAS, the Knights of Columbus has donated more than \$1.3 billion, and volunteered over 640 million hours of service in the past decade; and,

WHEREAS, the Illinois State Council of the Knights of Columbus will hold their 46th Annual Fund Drive on September 18-20, 2015 to benefit programs that serve individuals with intellectual disabilities, distributing proceeds to more than 1,200 service organizations throughout Illinois;
