#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance,

is hereby amended by changing all the B3-2 Community Shopping District symbols

and indications as shown on Map No.7-G in the area bounded by

a line 214 feet south of and parallel to West Barry Avenue; the alley next east of and parallel to North Sheffield Avenue; a line 239.18 feet south of and parallel to West Barry Avenue; and North Sheffield Avenue,

to those of a B2-2 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.






