ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning

Ordinance is hereby amended by changing all of the B1-2, Neighborhood Shopping

District symbols as shown on Map No. 11-G

in the area bounded by:

North Clybourn Avenue; a line 496.91 feet Southeast of and almost parallel to North

Sheffield Avenue (as measured along the south boundary of North Clybourn Avenue);

the public alley next Southwest of and parallel to North Clybourn Avenue; a line 281

feet Southeast of and almost parallel to North Sheffield Avenue (as measured along the

south boundary of North Clybourn Avenue).
