BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1 That Section 17 of the Municipal Code of Chicago, the City Zoning Ordinance be amended by changing all the M1-3 Limited Manufacturing/Business Park District, RT-4 Residential Two-Flat, Townhouse and Multi-unit District and C2-3 Motor Vehicle-Related Commercial District symbols and indications as shown on Map No. 1-G in area bound by

NORTH ABERDEEN STREET; NORTH ABERDEEN STREET; WEST HURON STREET; A LINE 73.50 FEET WEST OF AND PARALLEL TO NORTH ABERDEEN STREET; THE ALLEY NEXT NORTH OF WEST HURON STREET; THE ALLEY NEXT SOUTHWEST OF AND PARALLEL TO NORTH ABERDEEN STREET AND, NORTH OGDEN AVENUE

To those of a B3-5 Community Shopping District, and a corresponding use district is hereby established in the area above described.

SECTION 2 Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-5 Community Shopping District symbols shown on Map 1-G in area bound by

NORTH ABERDEEN STREET; NORTH ABERDEEN STREET; WEST HURON STREET; A LINE 73.50 FEET WEST OF AND PARALLEL TO NORTH ABERDEEN STREET; THE ALLEY NEXT NORTH OF WEST HURON STREET; THE ALLEY NEXT SOUTHWEST OF AND PARALLEL TO NORTH ABERDEEN STREET AND, NORTH OGDEN AVENUE

To those of a Residential-Business Planned Development, subject to the use and bulk regulations set forth in the Plan of Development attached hereto and made a part hereof.

SECTION 3 The ordinance shall be in force and effect from and after its passage and due publication.

RESIDENTIAL-BUSINESS PLANNED DEVELOPMENT No. _____

Plan of Development Statements

1. The area delineated herein as Residential Business Planned Development Number _____, ("Planned Development") consists of approximately 39,196.7 square feet of property located at 768 North Aberdeen Street, which is depicted on the attached Planned Development Boundary and Property Line Map ("Property") and is owned or controlled by the Applicant, John Kelly.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.
3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assigns or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Planning and Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

4. This Plan of Development consists of 16 Statements: a Bulk Regulations Table; a Plat of Survey; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; a Site Plan; a Sub-Area Map; Floor Plans; Landscape Plan; Building Elevations prepared by Fitzgerald Associates Architects and dated _____, submitted herein. Full-sized copies of the Site Plan, Landscape Plan

and Building Elevations are on file with the Department of Planning and Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

5. The following uses as permitted in the B3-5 Community Shopping District are permitted in the area delineated herein as a Residential Business Planned Development No. _____ subject to the list of uses permitted in Sub-Area A and Sub-Area B below: Multi-Unit Residential; Day Care; Parks and Recreation; Art Sales Space; Restaurant General; Outdoor Patio grade level; Bank; Automated Teller Machine Facility; Liquor Store (packaged goods); Liquor Sales (as accessory use); Medical Service; Office; Parking, non accessory; Hair Salon, Nail Salon or Barbershop; Dry cleaning drop off or pickup (no on premises plant); Retail Sales, General; Children's Play Center; Residential Storage Warehouse; Warehousing, Wholesaling and Freight Movement; Off Premise Signage; all uses legally existing at the time of passage of this Ordinance and continually operating thereafter. The following uses shall be prohibited: Adult Use.

In each of the following Sub Areas, the following uses shall be permitted in this Planned Development:

Sub-Area A: Multi-Unit Residential; Day Care; Parks and Recreation; Art Sales Space; Restaurant General; Outdoor Patio grade level; Bank; Automated Teller Machine Facility; Liquor Store (packaged goods); Liquor Sales (as accessory use); Medical Service; Office; Parking, non accessory; Hair Salon, Nail Salon or Barbershop; Dry cleaning drop off or pickup (no on premises plant); Retail Sales, General; Children's Play Center. The following uses shall be prohibited: Adult Use.

Sub-Area B: Multi-Unit Residential; Day Care; Parks and Recreation; Art Sales Space; Restaurant General; Outdoor Patio grade level; Bank; Automated Teller Machine Facility; Liquor Store (packaged goods); Liquor Sales (as accessory use); Medical Service; Office; Parking, non accessory; Hair Salon, Nail Salon or Barbershop; Dry cleaning drop off or pickup (no on premises plant); Retail Sales, General; Children's Play Center; Residential Storage Warehouse; Warehousing Wholesaling and Freight Movement; Off Premises Signage; all uses legally existing at the time of passage of this Ordinance and continually operating thereafter. The following uses shall be prohibited: Adult Use.

6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Planning and Development.

7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
8. The maximum permitted Floor Area Ratio ("FAR") for the site shall be 5.0, in accordance with the attached Bulk Regulations Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of 39,196.7 square feet.
9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Planning and Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Planning and Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Fleet and Facility Management and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.
12. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs, conserves energy and maximizes the preservation of natural resources. The Applicant shall achieve at least basic LEED Certification under the Leadership in Energy and

Environmental Design Green Building Rating System for all new construction within the Planned Development.

15. The Applicant acknowledges and agrees that the rezoning of the Property from M1-3, Rt-3 and C2-3 to B3-5 and then to a Residential-Business Planned Development for construction of this Planned Development triggers the requirements of Section 2-45-110 of the Municipal Code (the “Affordable Housing Ordinance”). Any developer of a “residential housing project” within the meaning of the Affordable Housing Ordinance (“Residential Project”) must: (i) develop affordable housing units as part of the Residential Project; (ii) pay a fee in lieu of the development of affordable housing units; or (iii) any combination of (i) and (ii). In accordance with these requirements and the Affordable Housing Profile Form attached hereto as an Exhibit, the Applicant has agreed to provide 19 affordable housing units in the Residential Project for households earning up to 100% of the Chicago Primary Metropolitan Statistical Area median income (the “Affordable Units”), or make a cash payment to the Affordable Housing Opportunity Fund in the amount of \$100,000 per unit (“Cash Payment”). At the time of each Part II review for the Residential Project, Applicant may update and resubmit the Affordable Housing Profile Form to the Department of Planning and Development (“HED”) for review and approval. If the Applicant subsequently reduces the number of dwelling units in the Residential Project, HED may adjust the requirements of this Statement 16 (i.e., number of Affordable Units and/or amount of Cash Payment) accordingly without amending the Planned Development. Prior to the issuance of any building permits for the Residential Project, the Applicant must either make the required Cash Payment, or execute an Affordable Housing Agreement in accordance with Section 2-45-110(i)(2). The terms of the Affordable Housing Agreement and any amendments thereto are incorporated herein by this reference. The Applicant acknowledges and agrees that the Affordable Housing Agreement will be recorded against the Residential Project and will constitute a lien against each Affordable Unit. The City shall execute partial releases of the Affordable Housing Agreement prior to or at the time of the sale of each Affordable Unit to an income-eligible buyer at an affordable price, subject to the simultaneous execution and recording of a mortgage, restrictive covenant or similar instrument against such Affordable Unit. The Commissioner of HED may enforce remedies for breach of the Affordable Housing Agreement, and enter into settlement agreements with respect to any such breach, subject to the approval of the Corporation Counsel, without amending the Planned Development.
16. This Planned Development shall be governed by Section 17-13-0612 of the Zoning Ordinance. Should this Planned Development ordinance lapse, the Commissioner of the Department of Planning and Development shall initiate a Zoning Map Amendment to rezone the property to (underlying zoning that formed the basis of this Planned Development).


City Ordinance (Municipal Code, Section 17-13-0107) requires that I send you this notice.

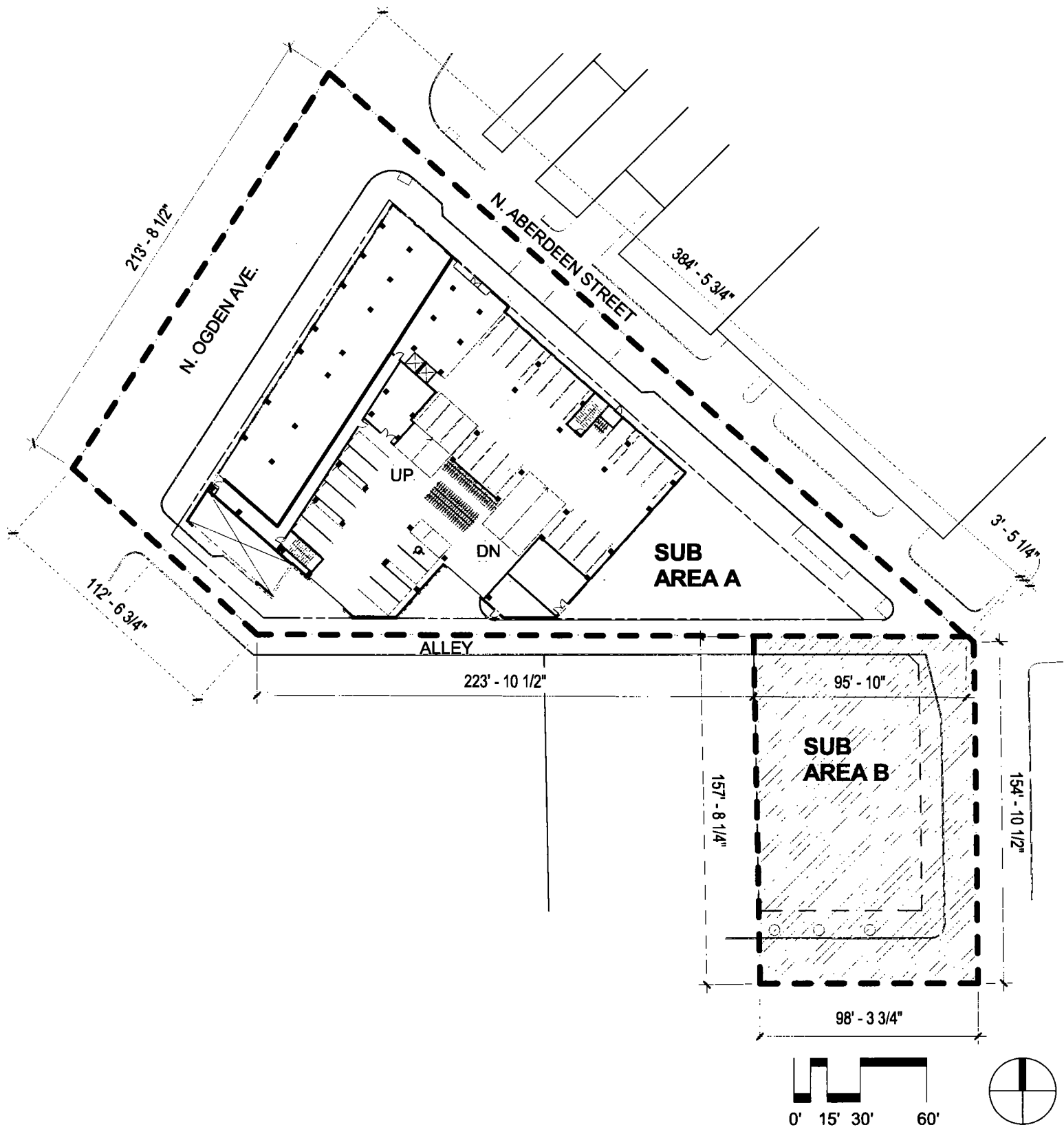

Planned Development No. Sub-Area Map

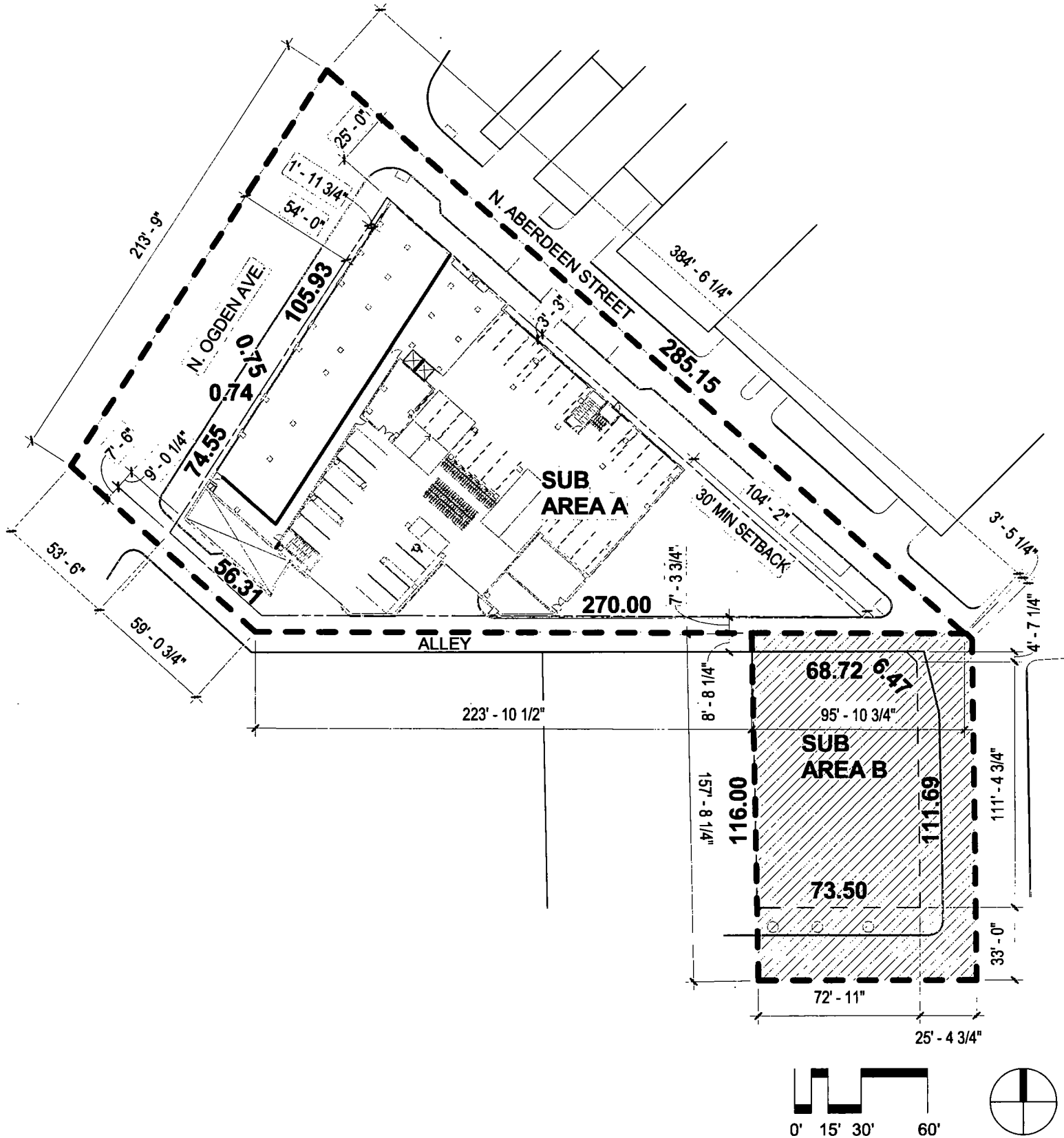

Property Line / PD Boundary Map

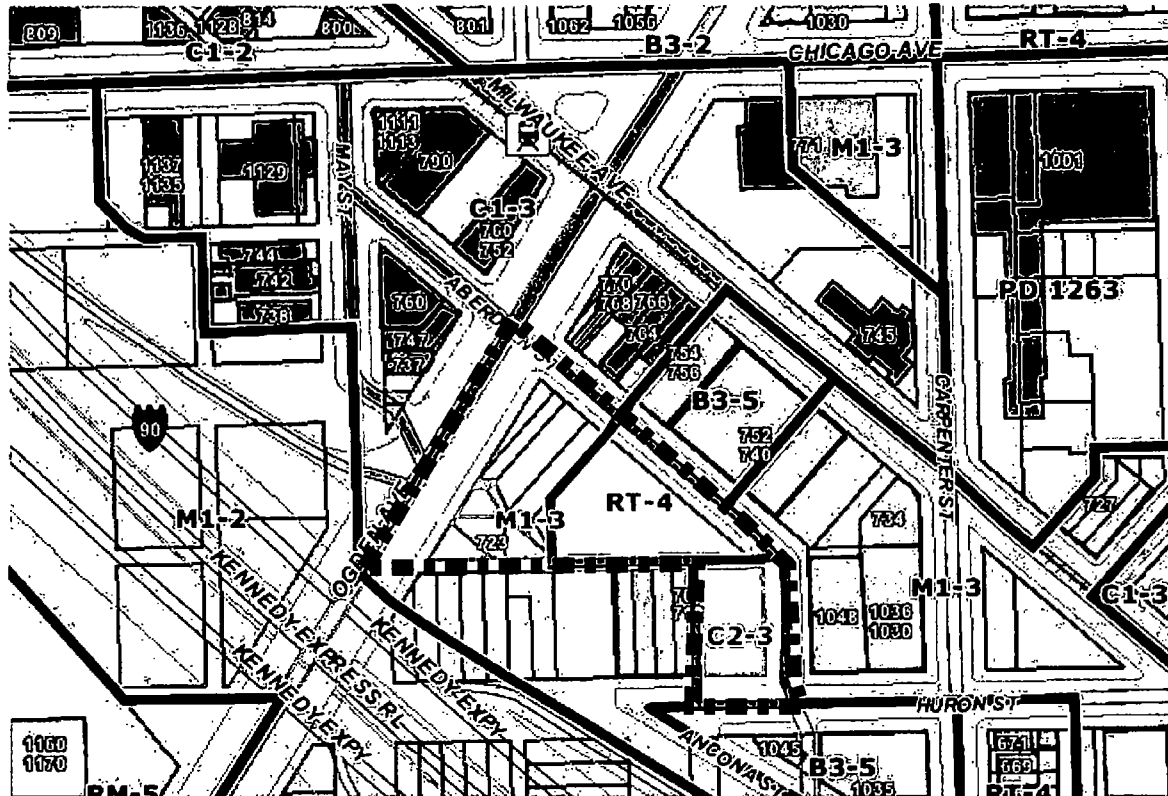

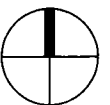
Planned Development No. Existing Zoning and Street System Map

ZONING BOUNDARY

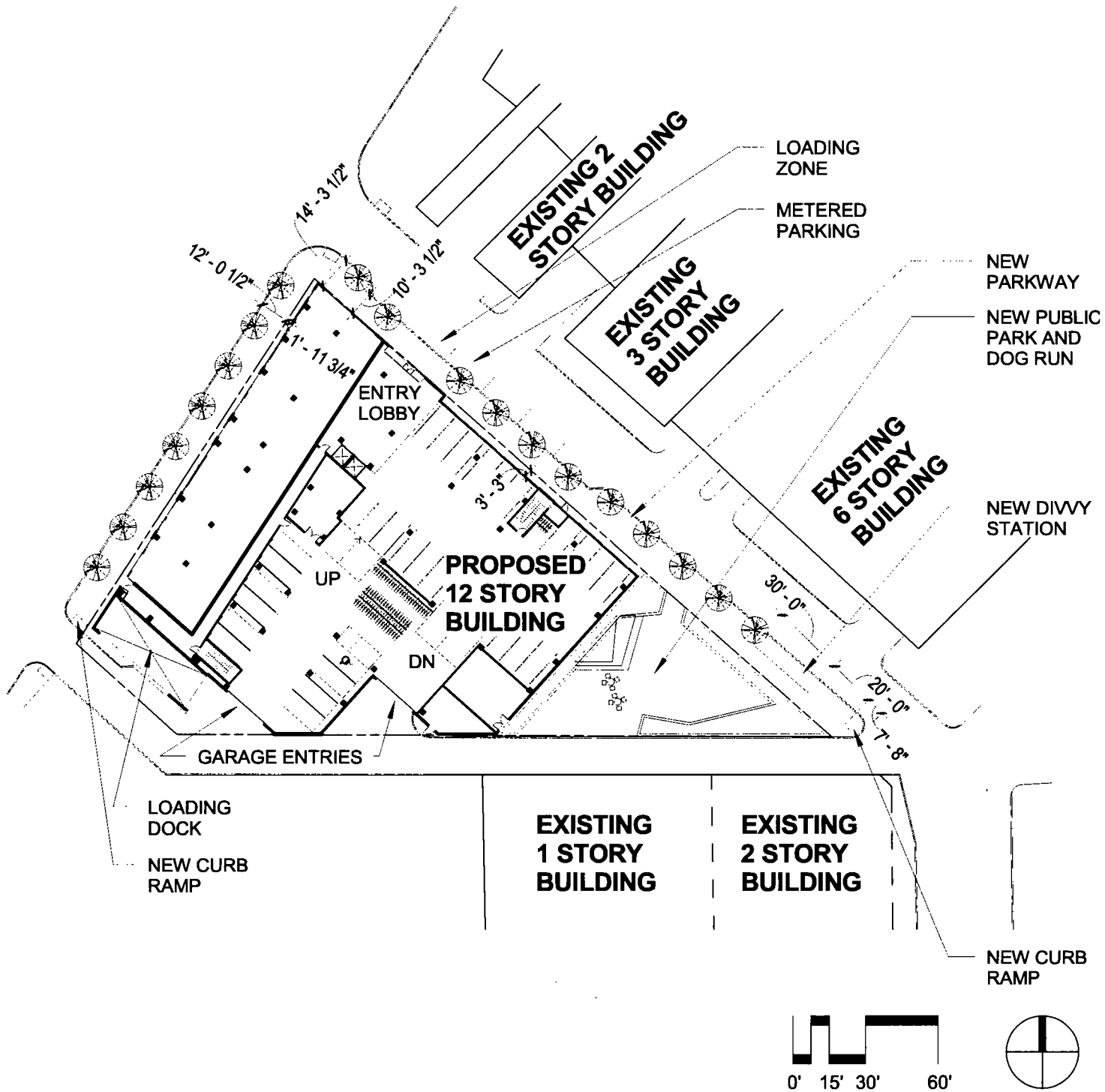

Planned Development No. Sub- Area A - Generalized Site Plan

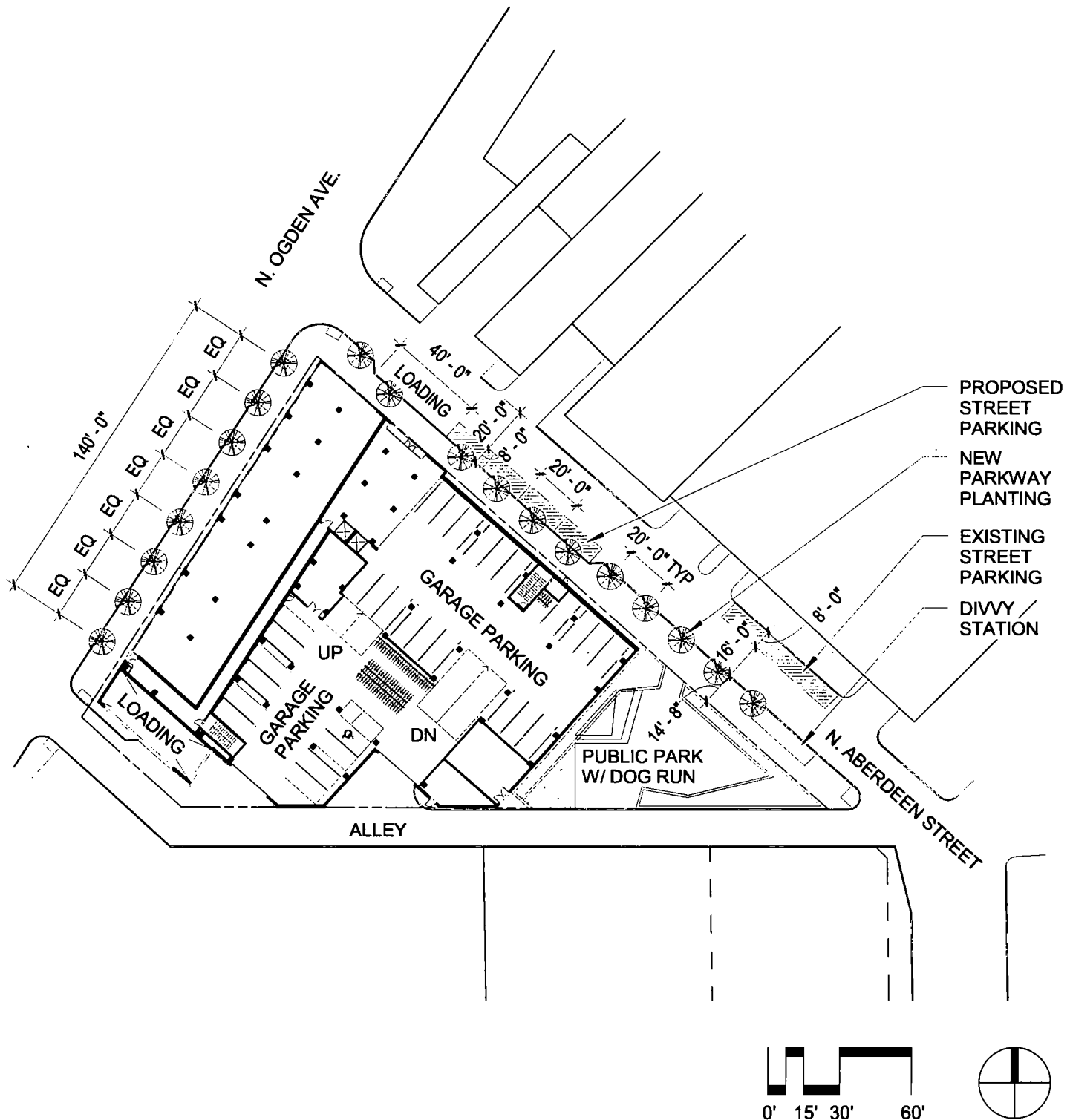

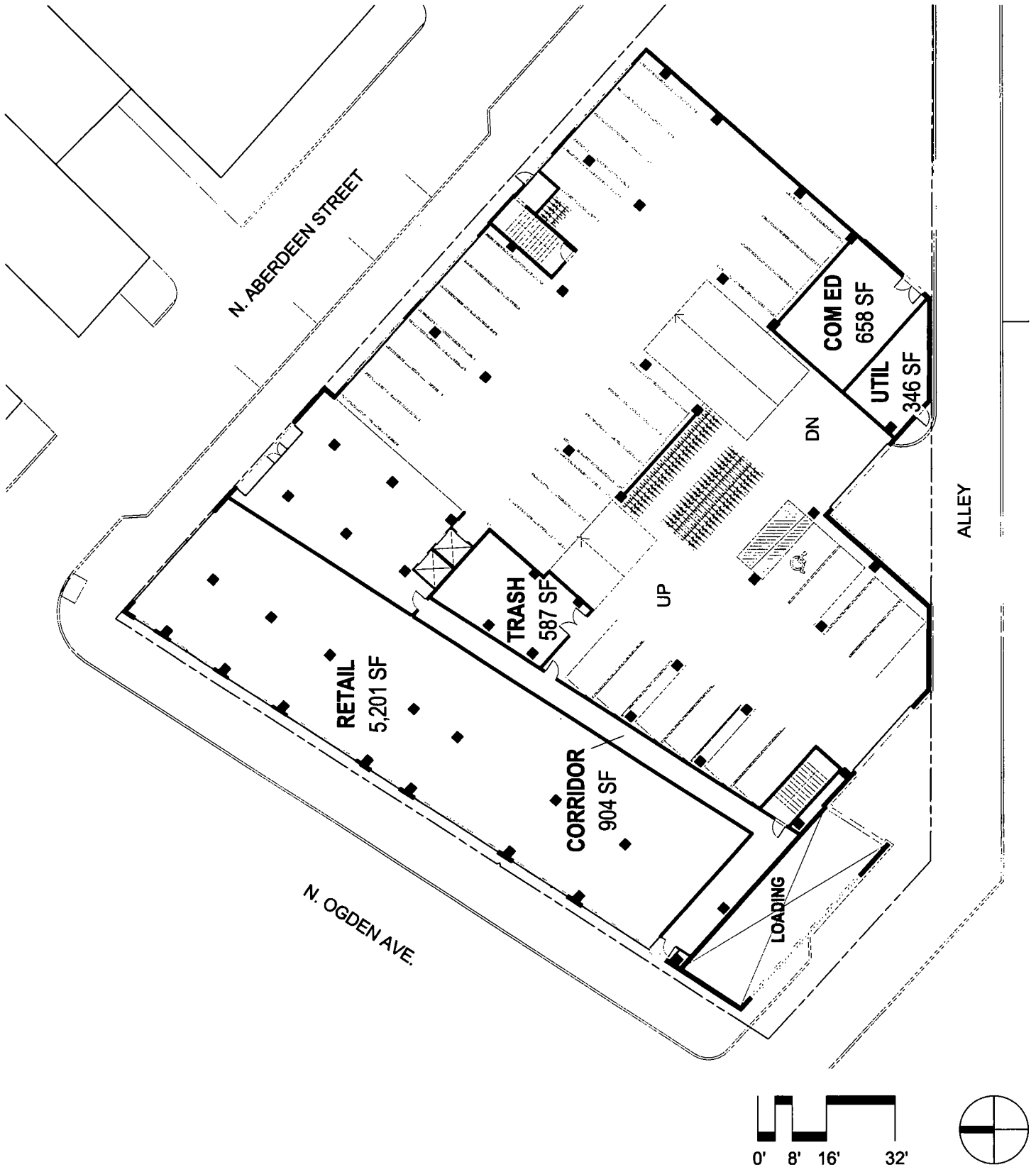

Planned Development No. Ground Floor Plan

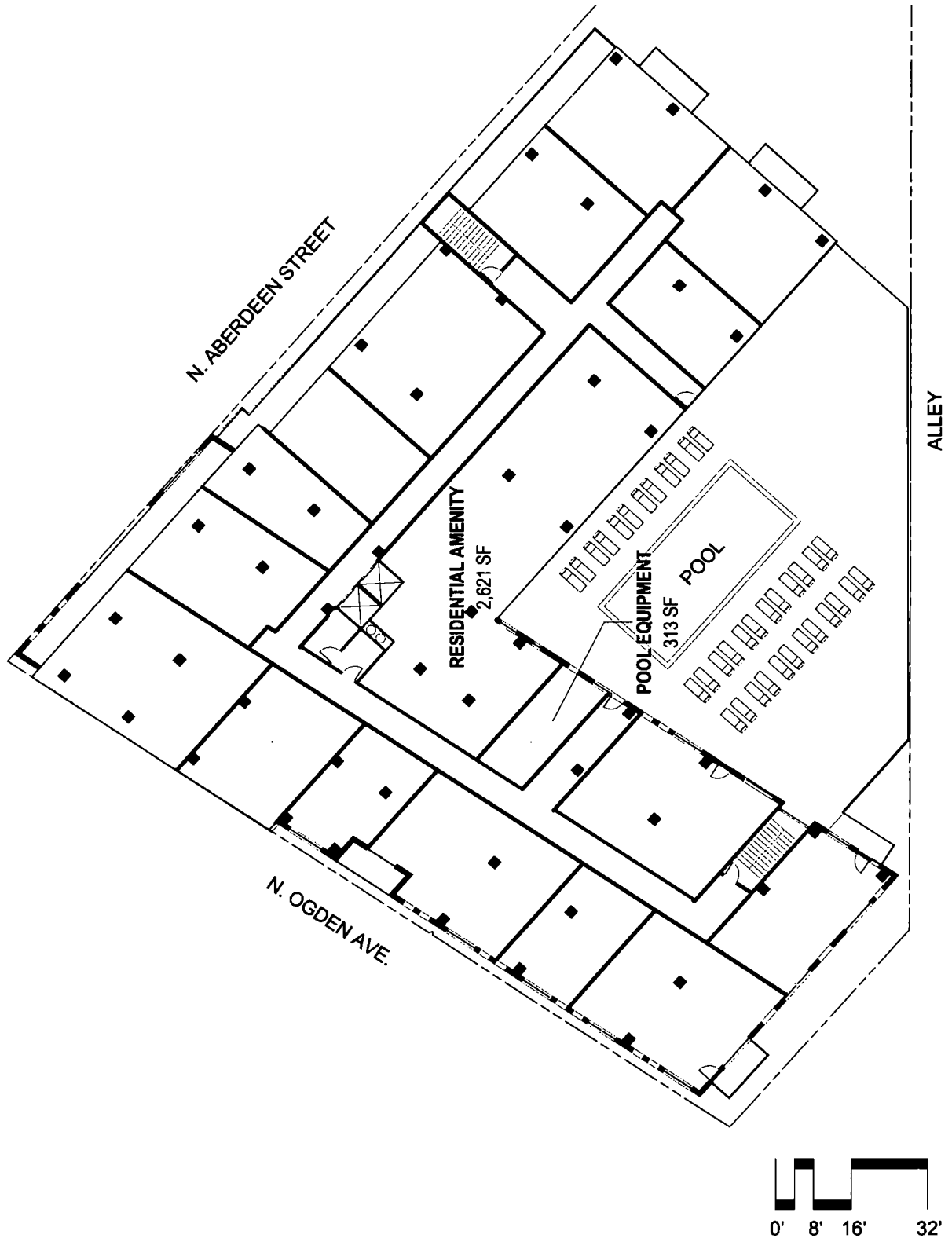

Planned Development No. Mechanical Roof Screen Plan

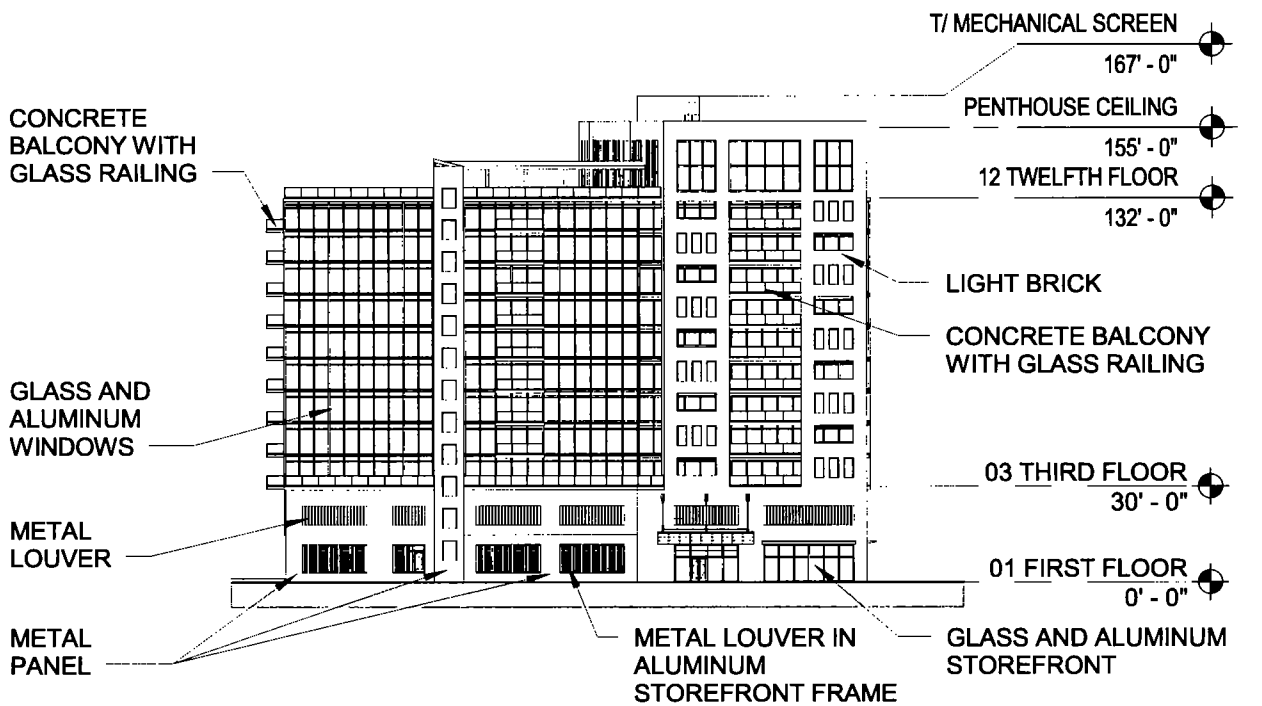

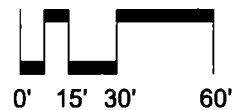
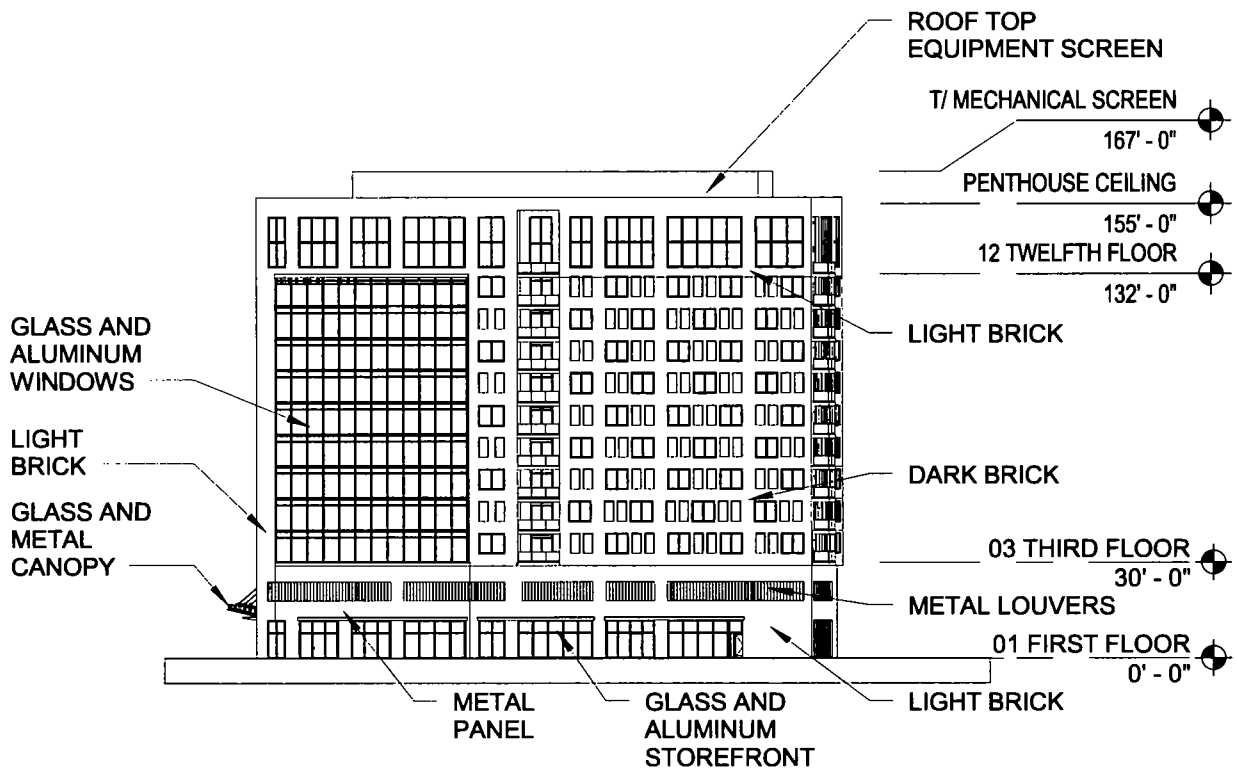
Planned Development No. Northeast Elevation

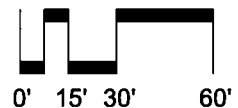
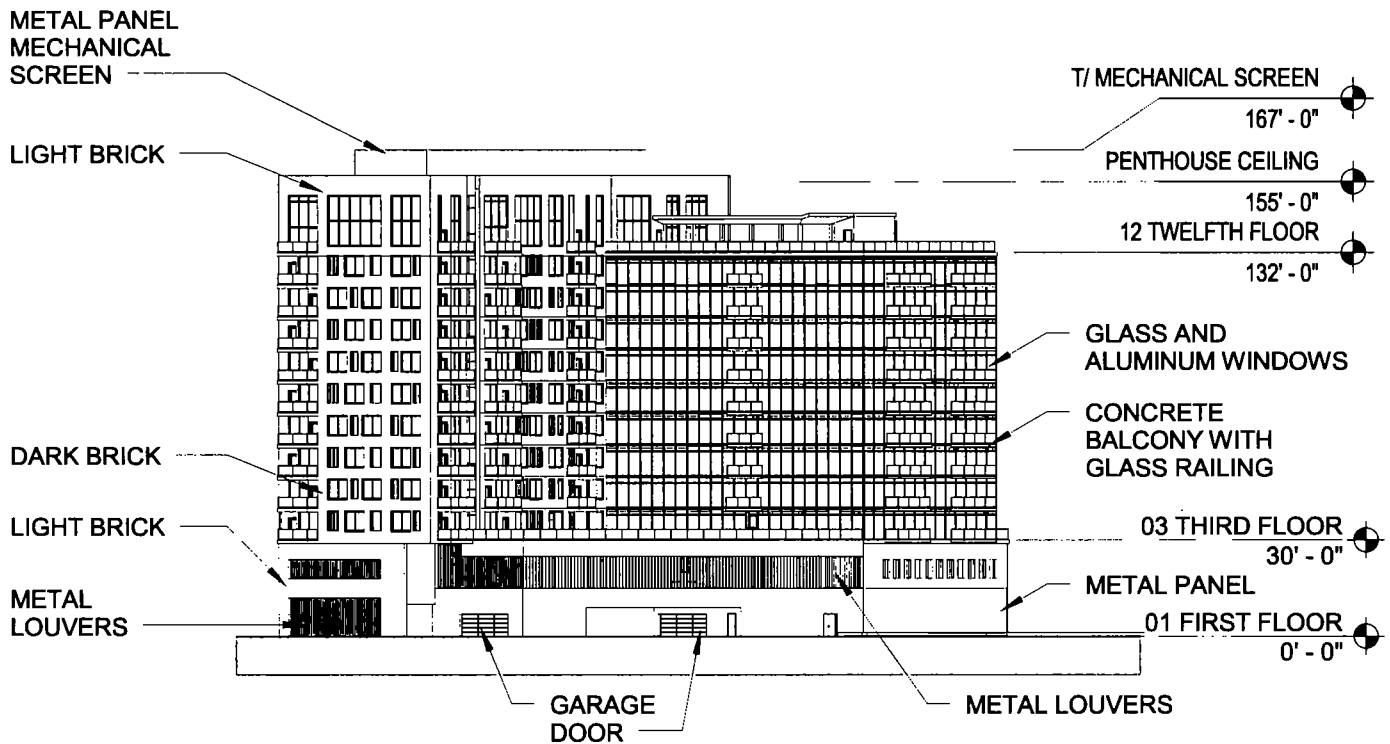
Planned Development No. Northwest Elevation
