COMMERCIAL ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the properties at 2348-2356 W. 107th Street, 10631-10643 S. Western Avenue and 10647-10659 S. Western Avenue are owned by Beverly Western Partners LLC, an Illinois Limited Liability ("Beverly Western Partners, LLC"); and

WHEREAS, Beverly Western Partners, LLC proposes to use the portion of the alley to be vacated herein to assemble properties for a commercial redevelopment including a Buona Restaurant; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of part of public alley, described in the following ordinance; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. THAT PART OF THE EAST-WEST 16 FOOT PUBLIC ALLEY LYING NORTH OF LOTS 13 AND 14 AND SOUTH OF LOT 15 IN BLOCK 4 IN JERNBERG'S SUBDIVISION OF THE WEST HALF OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF THE WEST HALF OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 18, TOWNSHIP 37 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN RECORDED JUNE 25, 1890 AS DOCUMENT 1293095 AND DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE NORTH LINE OF SAID LOT 14 LYING 50.00 FEET EAST OF AN PARALLEL TO THE WEST LINE OF SAID SECTION 18; THENCE, ON AN ASSUMED BEARING, NORTH 0 DEGREES 00 MINUTES 00 SECONDS EAST, ALONG SAID PARALLEL LINE, 16.00 FEET TO A POINT ON THE SOUTH LINE OF SAID LOT 15: THENCE SOUTH 89 DEGREES 56 MINUTES 21 SECONDS EAST, ALONG THE SOUTH LINE OF SAID LOT 15, 99.36 FEET TO A POINT ON THE NORTHERLY EXTENSION OF THE EAST LINE OF SAID LOT 13; THENCE SOUTH 0 DEGREES 02 MINUTES 04 SECONDS EAST, ALONG SAID NORTHERLY EXTENSION, 16.00 FEET TO THE NORTHEAST CORNER OF SAID LOT 13; THENCE NORTH 89 DEGREES 56 MINUTES 21 SECONDS WEST, ALONG THE NORTH LINE OF SAID LOTS 13 AND 14, 99.36 FEET TO THE POINT OF BEGINNING; ALL IN COOK COUNTY, ILLINOIS, as shaded and legally described by the words "HEREBY VACATED" on the plat hereto attached as Exhibit A, which drawing for greater clarity, is hereby made a part of this

ordinance, be and the same is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacation.

SECTION 2. The City of Chicago hereby reserves for the benefit of Commonwealth Edison, RCN, AT&T/SBC and Comcast, their successors or assigns, a non-exclusive utility easement to operate, maintain, construct, replace and renew overhead wires, poles, and associated equipment and underground conduit, cables, and associated equipment for the transmission and distribution of electrical energy, telephonic and associated services under, over and along the alley herein vacated, with the right of ingress and egress. The grade of the vacated public way shall not be altered in a manner so as to interfere with the operation and maintenance of the facilities of the aforementioned utilities. No buildings, permanent structures or obstructions shall be placed over Commonwealth Edison, RCN, AT&T/SBC and or Comcast facilities without express written release of easement by the involved utility. Any future vacation-beneficiary prompted relocation of said facilities, lying within the area being vacated, will be accomplished by the involved utility, and be done at the expense of beneficiary of the vacation.

SECTION 3. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, Beverly Western Partners, LLC shall deposit in the City Treasury of the City of Chicago, a sum sufficient to defray the costs of removing paving and curb returns, and constructing sidewalk and curb at the entrance to that part of the alley hereby vacated, in accordance with current Department of Transportation's <u>Regulations for Opening</u>, <u>Repair and Construction in the Public Way</u> and its appendices.

SECTION 5. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, Beverly Western Partners, LLC shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with a full sized corresponding plat as approved by the Superintendent of Maps and Plats.

SECTION 6. This ordinance shall take effect and be in force from and after its passage. The vacation shall take effect and be in force from and after its recording.


