#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning
Ordinance, is hereby amended by changing all the B1-2 Neighborhood Shopping
District symbols and indications as shown on Map No. 3-G in the area bounded by

a line 25.34 feet south of and parallel to West Cortez Street; the alley next east of and parallel to North Ashland Avenue; a line 169.34 feet south of and parallel to West Cortez Street; and North Ashland Avenue,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.


