BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Section 10-4-120 of the Municipal Code of the City of Chicago is hereby amended by inserting the language underscored and by deleting the language struck through, as follows:

10-4-120 Violation - Penalty

Any person who shall violate, neglect or refuse to observe any of the provisions of this chapter dealing with street names and numbers, where no other penalty is specifically provided, shall be fined not less than \$5.00 \quad \text{100.00} nor more than \text{\$20.00} \quad \text{\$250.00} for each offense.

SECTION 2. This ordinance shall take effect and be in force hereinafter its passage and publication.
