#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-5 Community Shopping District symbols and indications as shown on Map No. 13-G in the area bounded by:

North Broadway; West Gunnison Street; the public alley next west of and parallel to North Broadway; a northeasterly line perpendicular to the public alley next west of and parallel to North Broadway 121.44 feet south of center line of West Gunnison Street (as measured along the east boundary line of the public alley next west of and parallel to North Broadway),

to those of C1-5 Neighborhood Commercial District.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about October 6, 2015 the undersigned attorney will file an application for a change in zoning from B3-5 Community Shopping District to C1-5 Neighborhood Commercial District on behalf of the Applicant, Flynn Industries, LLC, for the property located at 4830 N. Broadway, Chicago, Illinois 60640 and bounded by:

North Broadway; West Gunnison Street; the public alley next west of and parallel to North Broadway; a northeasterly line perpendicular to the public alley next west of and parallel to North Broadway 121.44 feet south of center line of West Gunnison Street (as measured along the east boundary line of the public alley next west of and parallel to North Broadway),

The purpose of the proposed zoning amendment is to allow for the establishment of a tavern with an amusement arcade. With a vintage video game theme, the intended tavern will offer approximately 30 amusement arcade machines that will be free of charge to patrons. The machines will not have any payoff possibilities as play is simply for amusement and nostalgia.

The applicant is Flynn Industries, LLC, an Illinois limited liability company, with its principal office located at 4830 N Broadway, Chicago, Illinois 60640. Its manager and primary contact person is Aaron Allen.

The property is owned by Hu's International Group, Corp., an Illinois corporation, located at 1160 S. Michigan Avenue #3007, Chicago, Illinois 60605. 




