ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois and as such may legislate as to matters which pertain to its local government and affairs; and

WHEREAS, the City has determined that the continuance of a shortage of affordable housing to persons of low and moderate income is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City, pursuant to the Home Investment Partnerships Program, received from the United States Department of Housing and Urban Development an allocation of funds to make loans and grants to expand the long-term supply of affordable housing through, among other things, acquisition, new construction, reconstruction and moderate and substantial rehabilitation in low- and moderate-income areas; and

WHEREAS, on or about April 7, 1993, the City made a loan of HOME funds in the principal amount of \$1,483,069 (the "Loan") to Renaissance West Limited Partnership, an Illinois limited partnership (the "Borrower"), with an interest rate of zero percent per annum and a maturity date of July 1, 2014 (the "Maturity Date"), as set forth in that certain Note dated as of April 7, 1993, given to the City by the Borrower; and

WHEREAS, the current balance on the Loan is approximately \$1,000,431; and

WHEREAS, the Loan was secured by, among other things, that certain Junior Mortgage Security Agreement and Financing Statement dated as of April 7, 1993, made by the Borrower in favor of the City (the "Mortgage"); and

WHEREAS, proceeds of the Loan were used to provide for the acquisition and construction of a project consisting of one five-story 100 unit multi-family housing building (the "Project") by the Borrower located generally at 2513-25 West Fullerton Avenue, Chicago, Illinois 60647 (the "Property"); and

WHEREAS, the sole general partner of the Borrower is Renaissance West, Inc., an Illinois corporation (the "General Partner"); NJK Venture, LLC, an Illinois limited liability company (the "Shareholder"), is the sole shareholder of the General Partner; and Nancy J. Kapp, an individual, is the managing member of the Shareholder; and

WHEREAS, the Mortgage is subordinate to that certain mortgage and assignment of rents and leases each dated as of April 7, 1993 (the "Senior Mortgage"), securing a loan in the amount of \$1,400,000 (the "Senior Loan"), made by the Borrower in favor of BMO Harris Bank, N.A., a national banking association as successor to Harris Trust and Savings Bank; and

WHEREAS, the Borrower desires to extend the Maturity Date of the Loan to May 1, 2023 in order to be coterminous with the Senior Loan and has requested that the City approve a proposed extension of the Maturity Date; and

WHEREAS, the City's Department of Planning and Development ("DPD") desires to approve an extension of the Maturity Date (the "Extension") of the Loan in a manner which (1) will not alter the principal balance of the Loan, (2) will not alter the interest rate on the principal balance of the Loan, and (3) will extend the Maturity Date of the Loan; (4) will require the Borrower to enter into an additional regulatory agreement (the "City Regulatory Agreement") in connection with the Extension; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Extension is hereby approved as described above. The Commissioner of DPD (the "Commissioner") or a designee of the Commissioner are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable, in connection with the implementation of the Extension and the City Regulatory Agreement.

SECTION 3. Notwithstanding anything to the contrary contained in the Municipal Code of Chicago (the "Municipal Code") or any other ordinance or mayoral executive order, no parties other than the owners of the Property as of the date following the date of the closing of the Extension (collectively, the "Owner"), any legal entities which are direct owners in excess of 7.5% of the Owner which changed in connection with the Extension, and all legal entities who constitute the direct or indirect controlling parties of the Owner (as determined by the Corporation Counsel), shall be required to provide to the City the document commonly known as the "Economic Disclosure Statement and Affidavit" (or any successor to such document) in connection with the Extension.

SECTION 4. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 5. This ordinance shall be effective as of the date of its passage and approval.
