
## **SUBDIVISION ORDINANCE**

Be it Ordained by the City Council of the City of Chicago:

**SECTION 1.** Chicago Department of Transportation, the Commissioner or any of her designees, are hereby authorized and directed to approve a proposed City Hyde Park Resubdivision being a subdivision of certain lots owned by 1525 HP, LLC, an Indiana Limited Liability Company in the block bounded by S. Harper Avenue, E. Hyde Park Boulevard, E. 52<sup>nd</sup> Street and approximately S. Lake Park Avenue, and legally described in the attached plat (Exhibit A, CDOT File: 11-04-15-3710) which, for greater certainty, is hereby made a part of this ordinance.

**SECTION 2.** The subdivision herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, 1525 HP, LLC, an Indiana Limited Liability Company shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the full sized corresponding Plat approved by the Department of Transportation / Superintendent of Maps

**SECTION 3.** This ordinance and exhibit subdivision plat shall take effect and be in force from and after its recording.

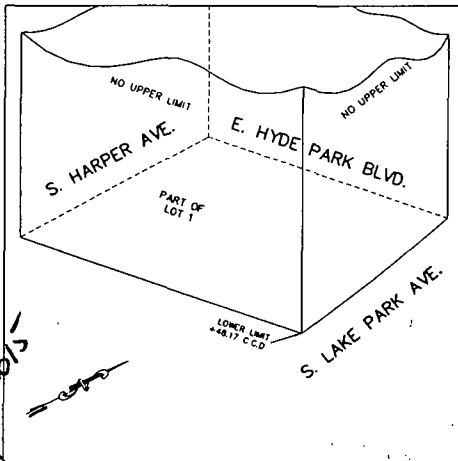
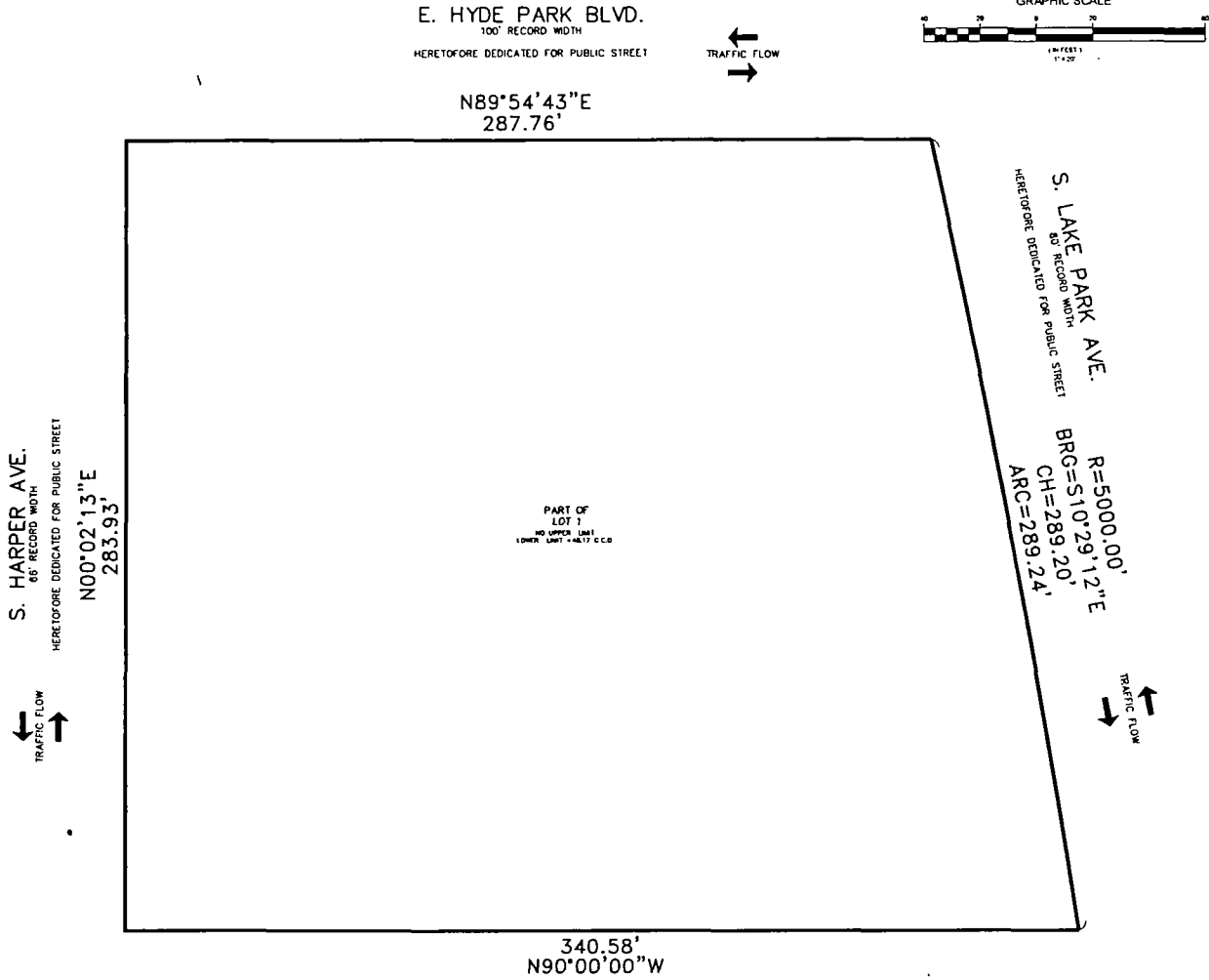
