#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 9-G in the area bounded by

A line 82.02 feet north of and parallel to West Dakin Street; North Sheridan Road; West Dakin Street; a line 125 feet west of and parallel to North Sheridan Road

to those of B3-5 Community Shopping District, and a corresponding use district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.

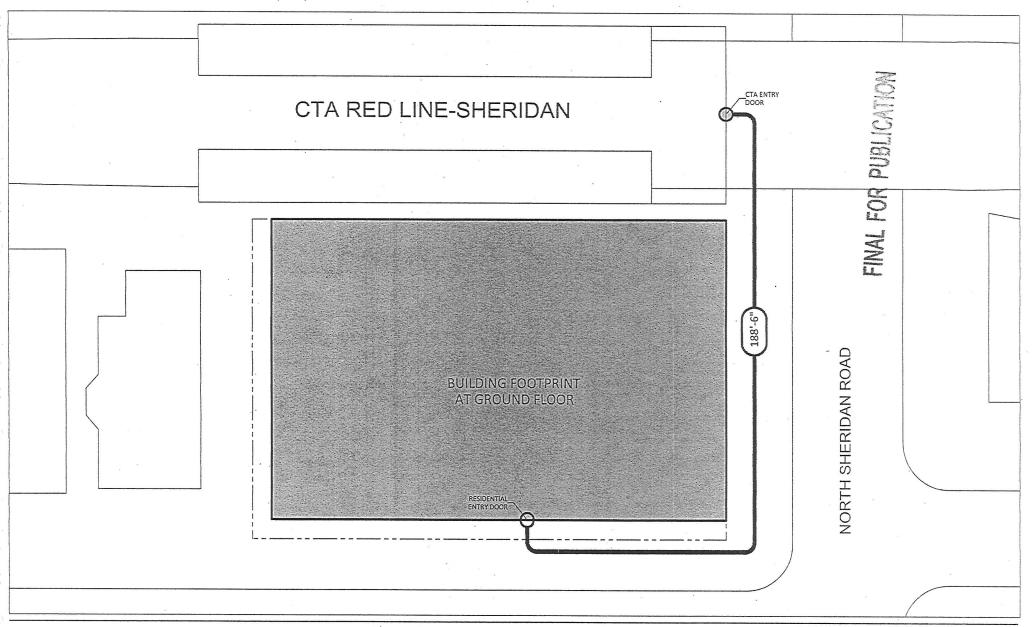

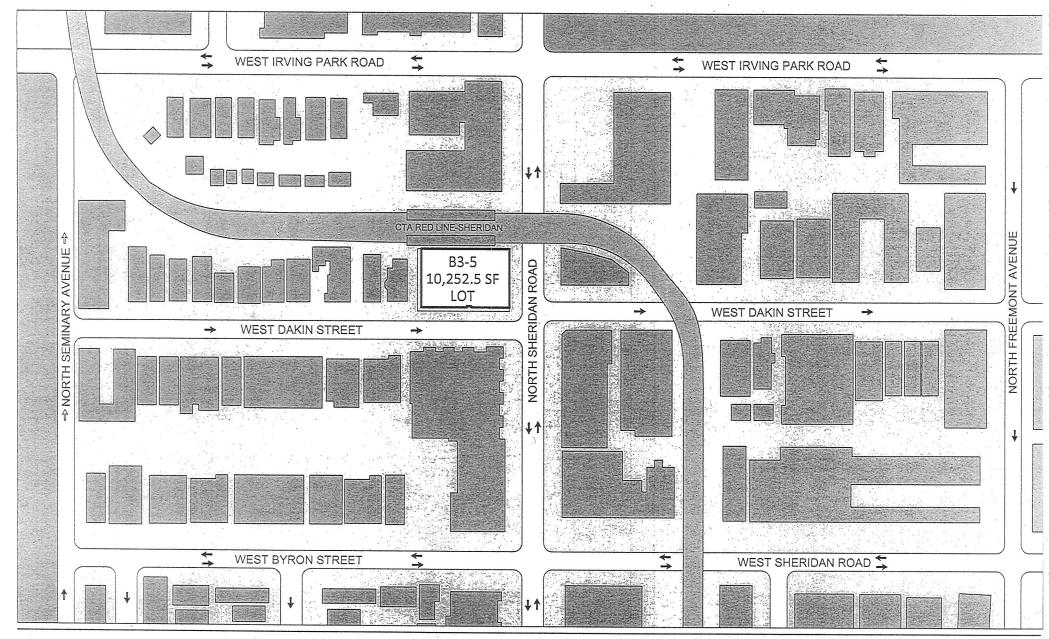

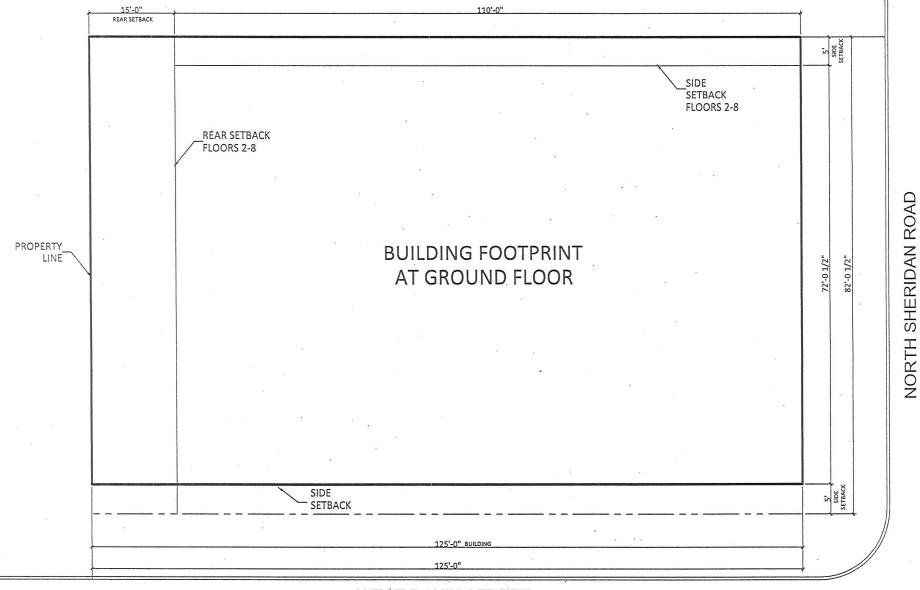


RESIDENTIAL ENTRY TO CTA 3630 NORTH SHERIDAN

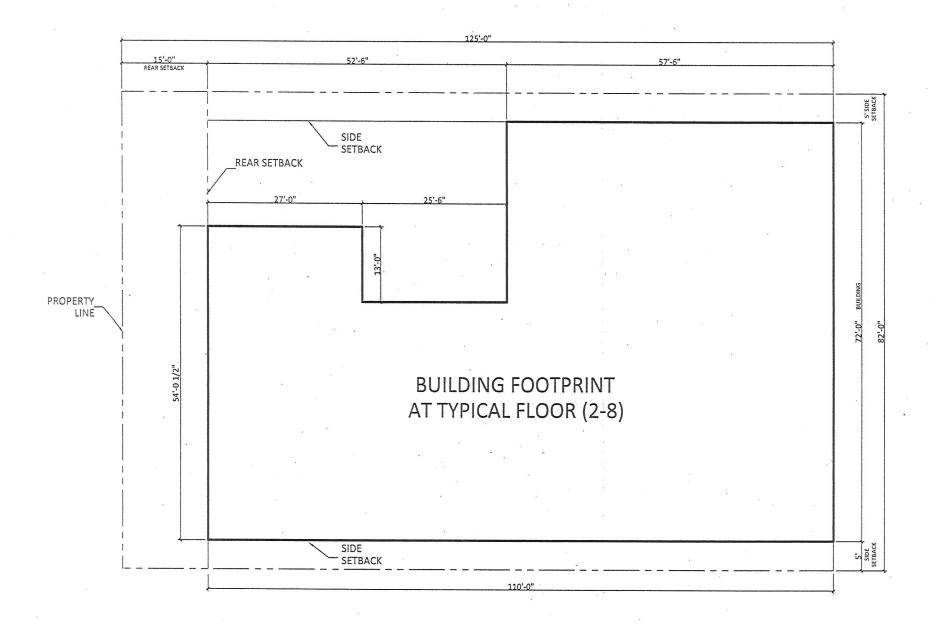
SITE MAP 3630 NORTH SHERIDAN N SCALE 1:1000

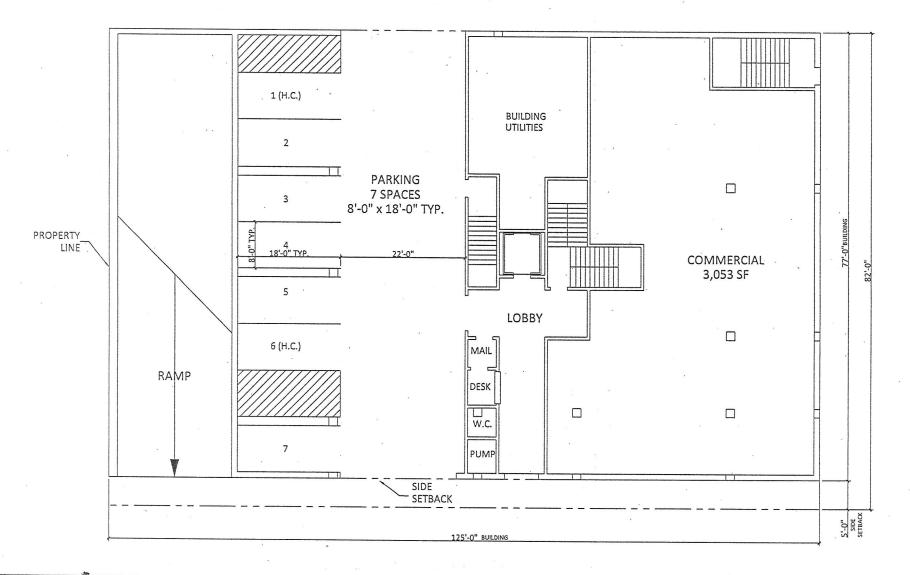
SITE PLAN 3630 NORTH SHERIDAN N SCALE 3/32\*=1'-0'

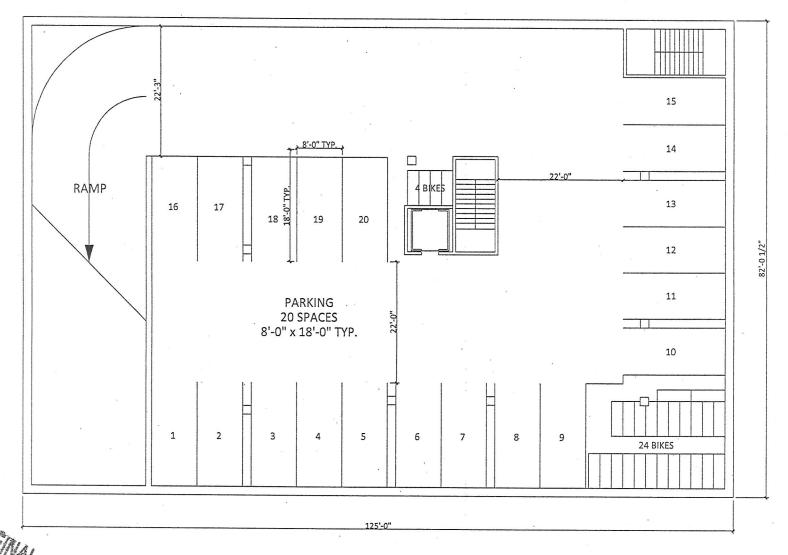
SITE PLAN 3630 NORTH SHERIDAN N SCALE 3/32\*=1'-0"

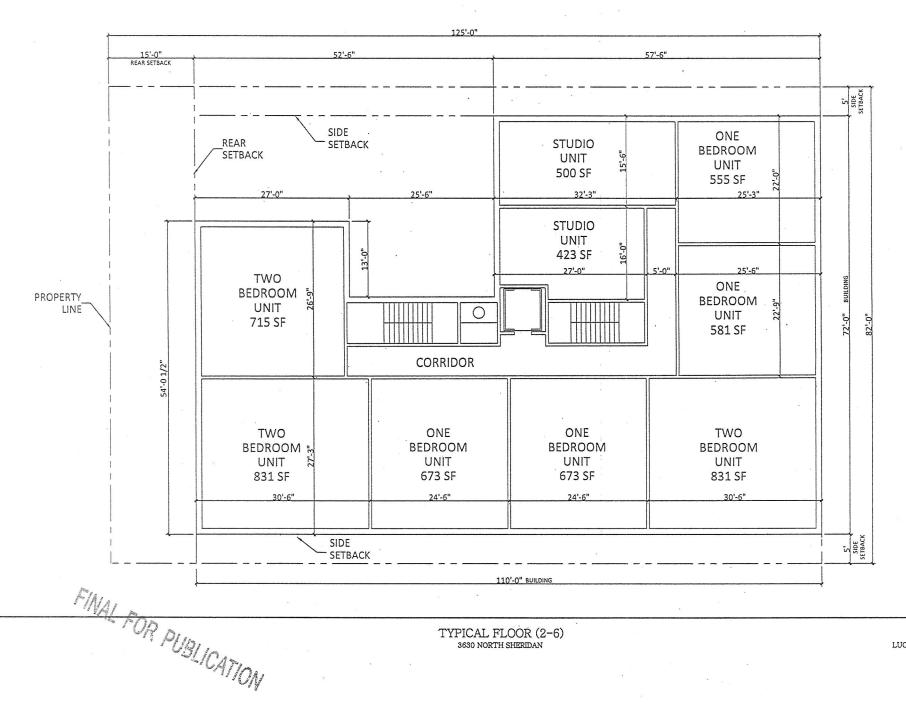

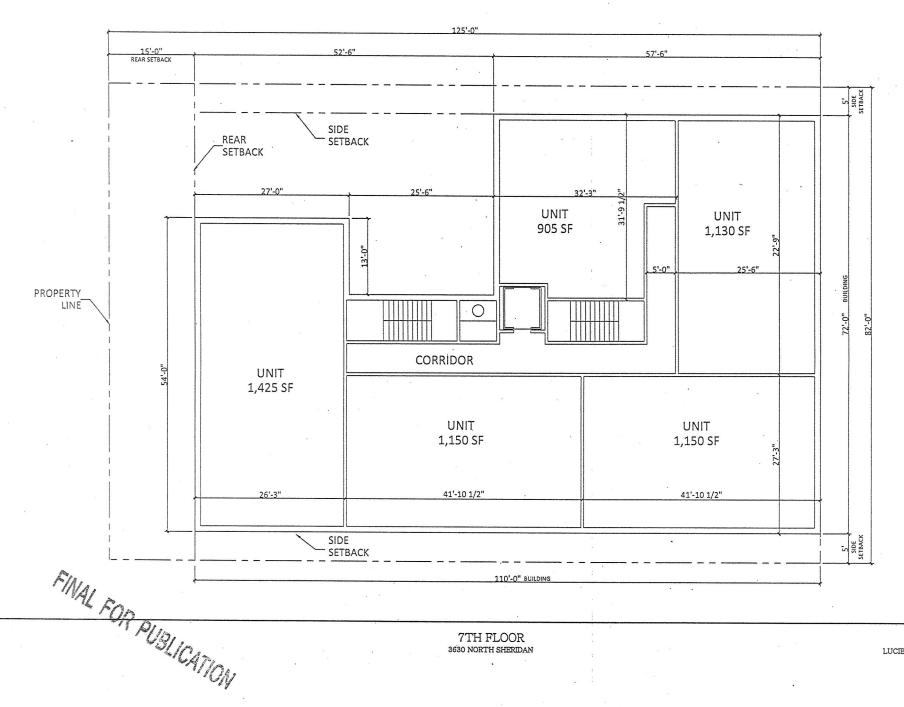
GROUND FLOOR 3630 NORTH SHERIDAN N SCALE 3/32"=1'-0"

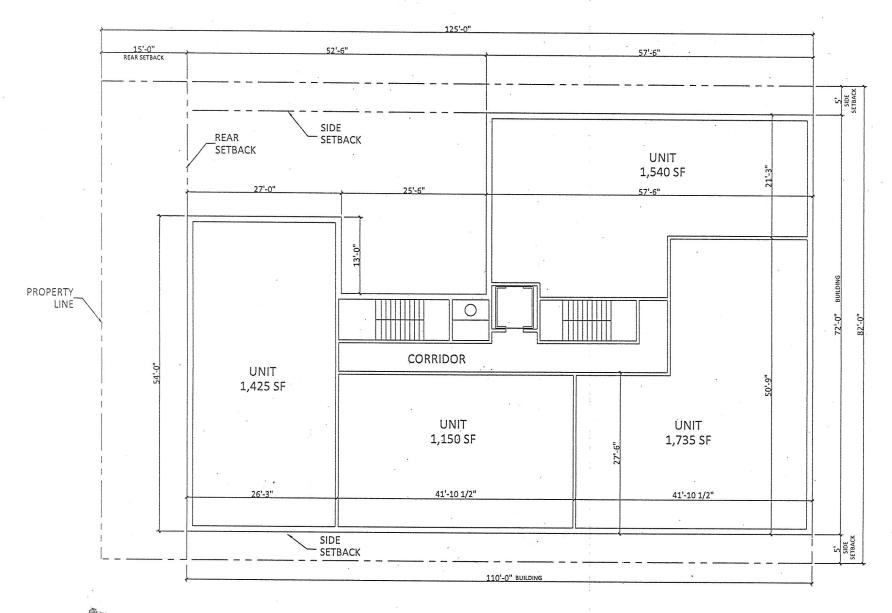


TYPICAL FLOOR (2-6) 3630 NORTH SHERIDAN

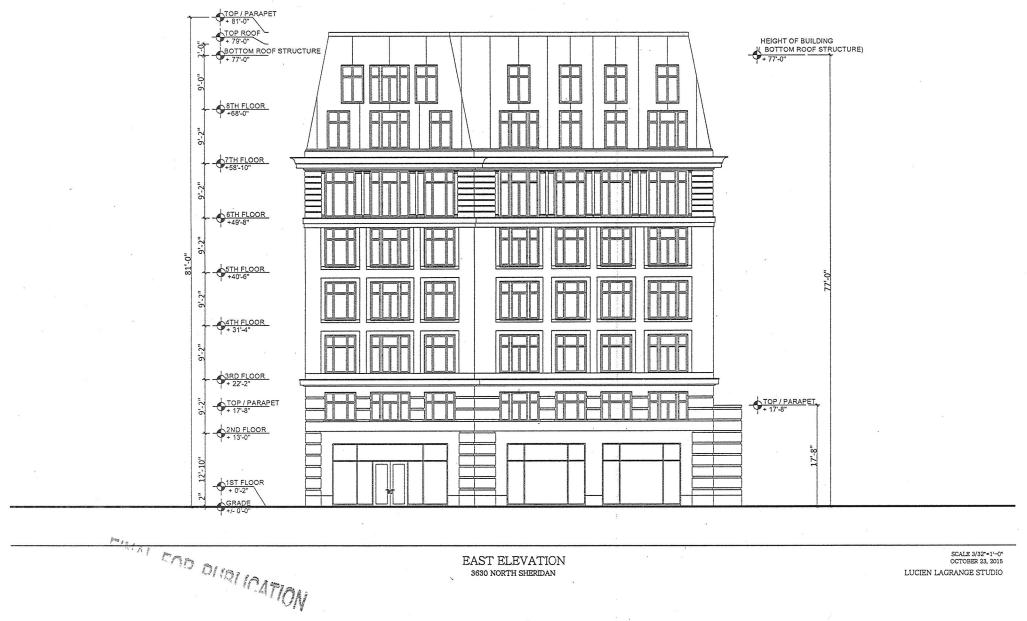


7TH FLOOR 3630 NORTH SHERIDAN
