In accordance with the Amendment to the Chicago Zoning Code enacted by the City Council, Section 17-13-0107-A, please be informed that on or about **December 1**, 2015, I, the undersigned, intend to file an application for a change in zoning from the M1-2 Limited Manufacturing/Business Park District to the C1-3 Neighborhood Commercial District, on behalf of the Applicant, Red Cedar Partners, LLC, for the subject property located at 2611 North Western Ave./2646 North Jones Street, Chicago, Illinois.

The Applicant seeks a zoning amendment to permit a proposed two-story day-care center with a rooftop playground. The Applicant proposes developing the subject property with a new 10,914 square foot, two-story building. The building will be 44'-4" in height and will be masonry in construction. Eight parking spaces will be provided to accommodate 23 staff members.
