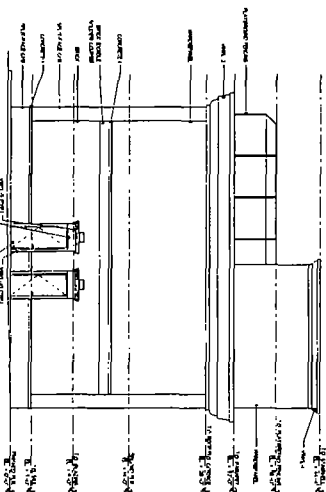
EAST ELEVATION
