## ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1:** Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the RM5 Residential Multi-Unit District symbols and indications as shown on Map No. 6-F in the area bounded by:

West 23rd Place;

South Princeton Avenue;

The alley next south of and parallel with West 23rd Place; and

A line 75.27 feet west of and parallel to the west right-of-way line of South Princeton Avenue;

to those of a B2-5 Neighborhood Mixed-Use District, which is hereby established in the area described.

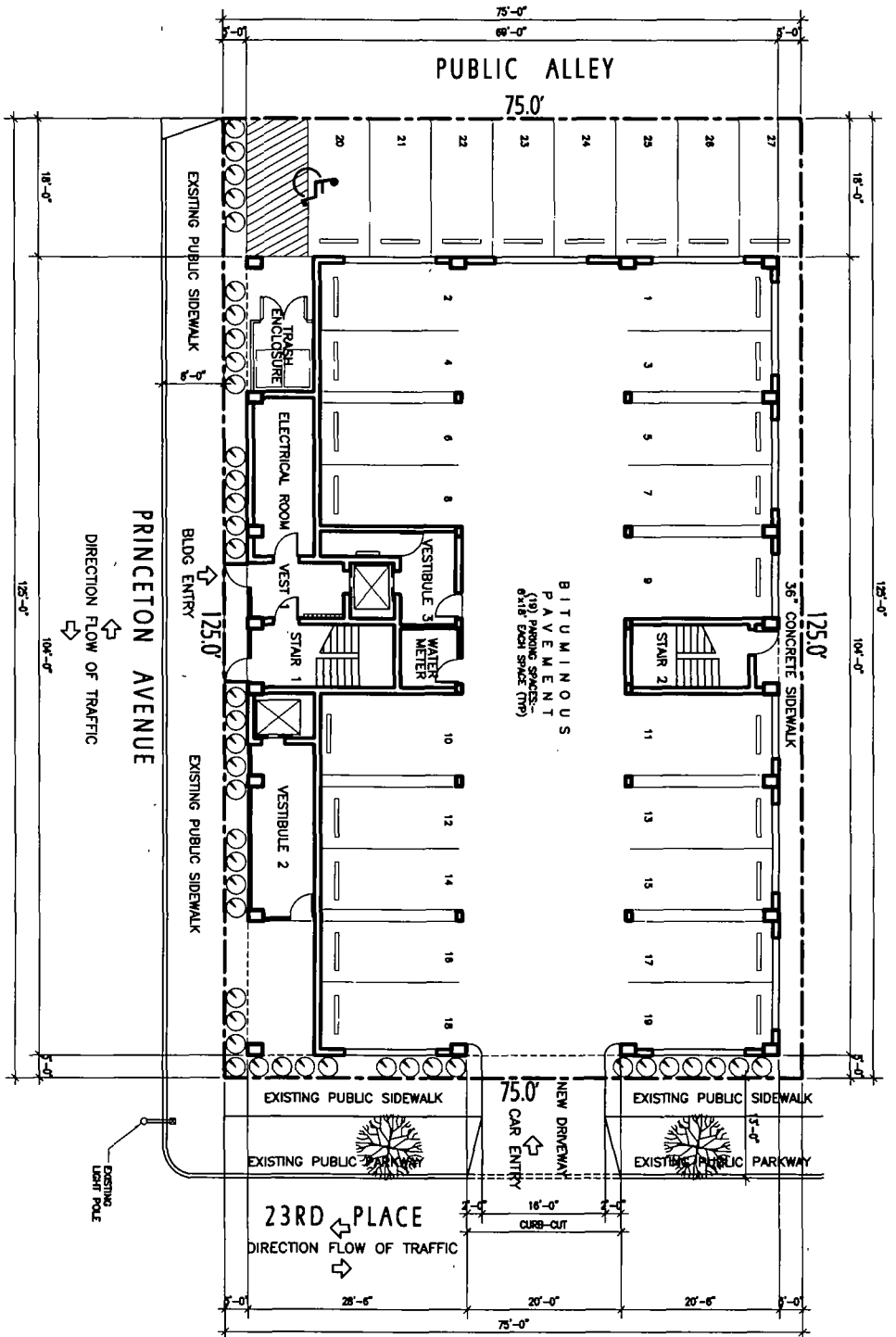
**SECTION 2:** This ordinance shall take effect upon its passage and due publication.

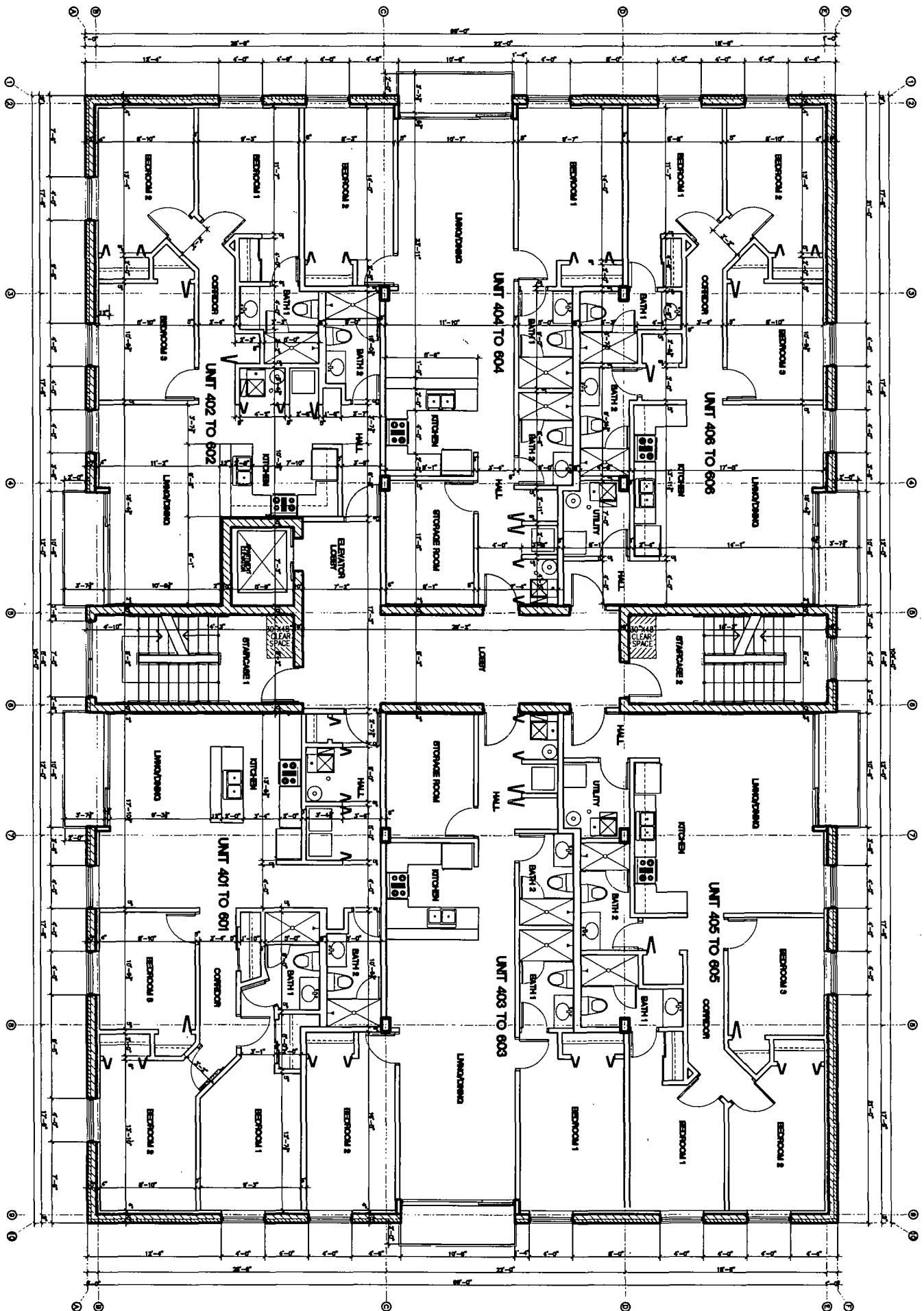
ARCHITECTURAL 1ST FLOOR SOUTH PLAN





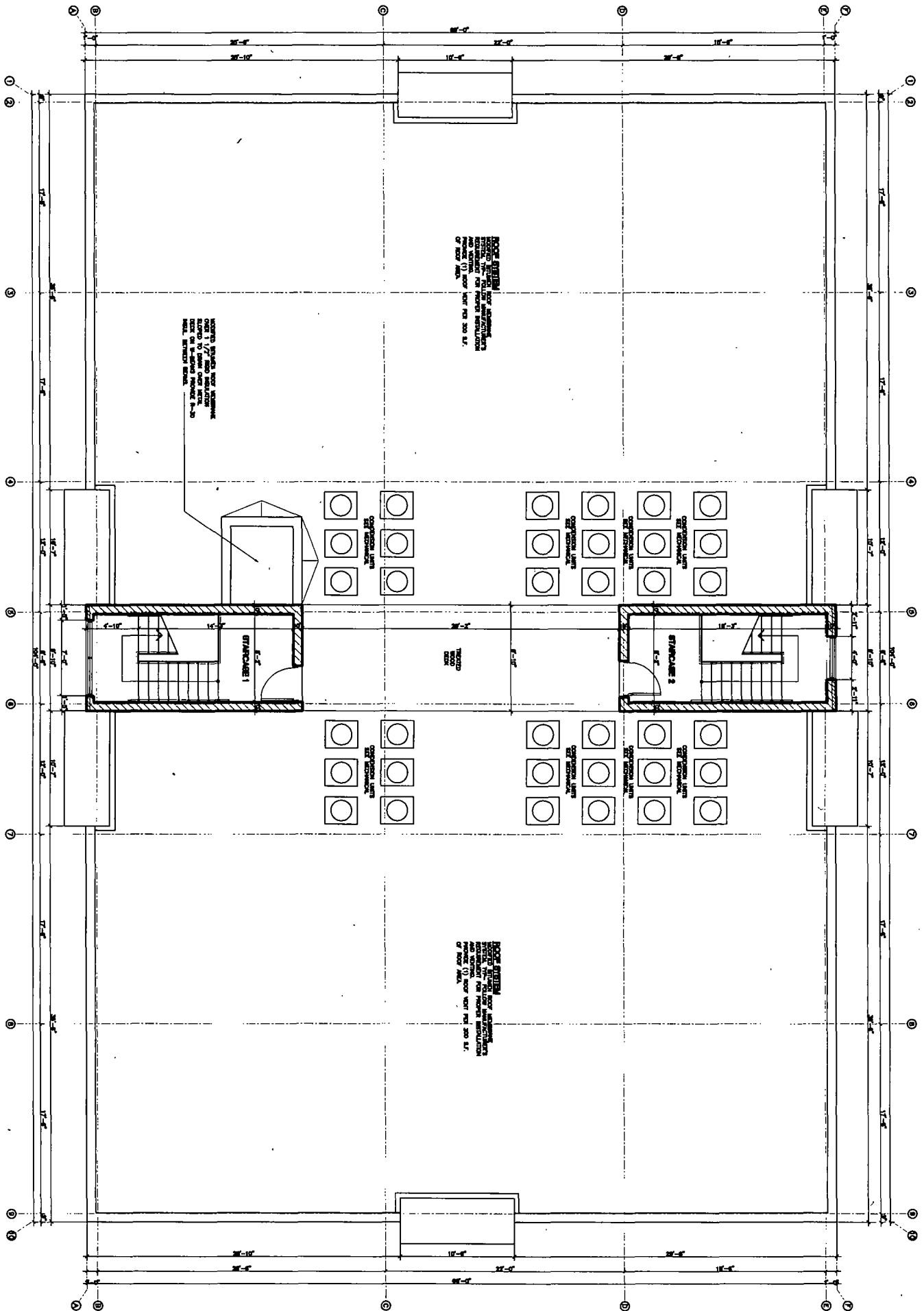
ARCHITECTURAL 2ND AND 3RD FLOOR PLAN

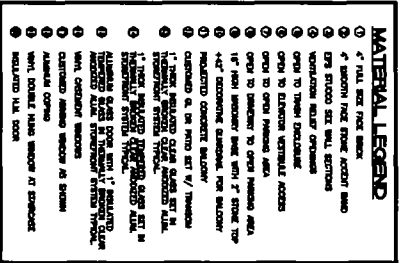

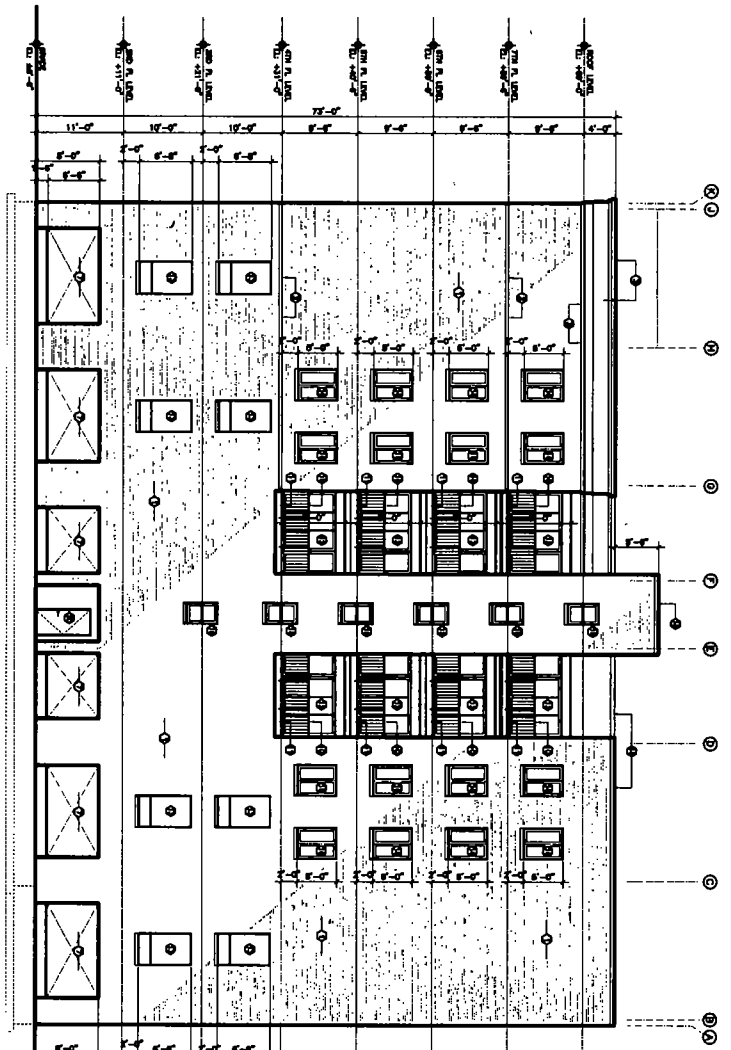
ARCHITECTURAL ROOF PLAN



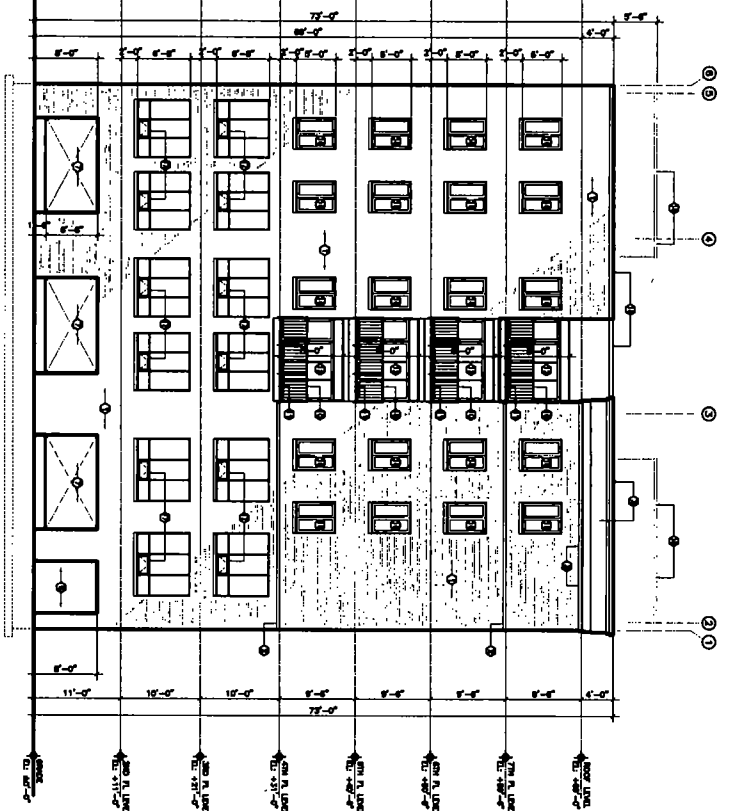




EXTERIOR WEST ELEVATION



EXTERIOR SOUTH ELEVATION

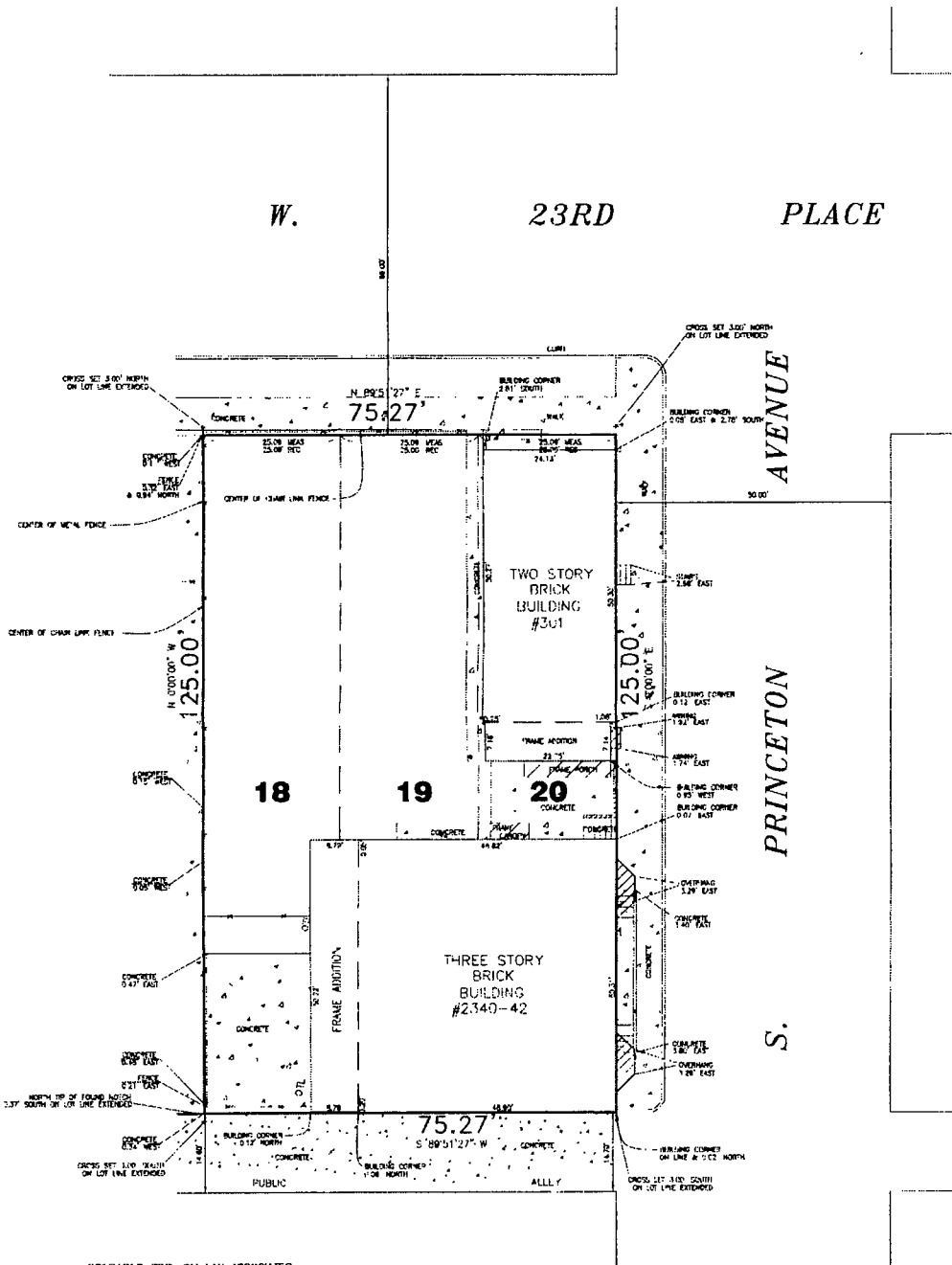
