ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M2-3 District symbols and indications as shown on Map No. 8-G in the area bounded by:

A public alley next north of and parallel to West 38th Street; a public alley next east of South Lituanica Avenue; West 38th Street; South Lituanica Street.

to those of the RS-3 District

SECTION 2. This ordinance takes effect after its passage and due publication.

TYPE I NARRATIVE

RS-3 Residential Single-Unit (Detached House) District

The subject property is approximately 30,784 square feet. The Applicant is proposing to rezone the property to RS-3 Residential Single-Unit (Detached House) District. The proposed residential development consists of eight single family (8) lots. Each lot contains one (1) single family home and a four hundred (400) square foot, two (2) stall garage per home.

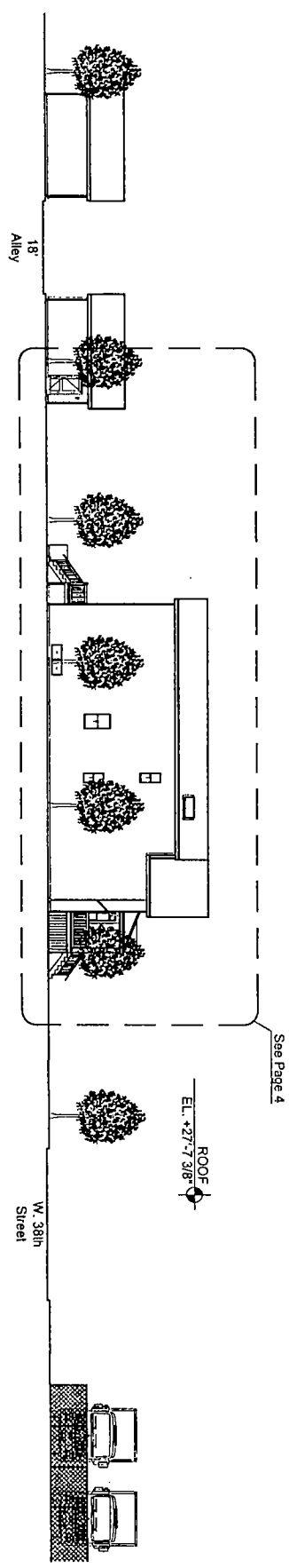
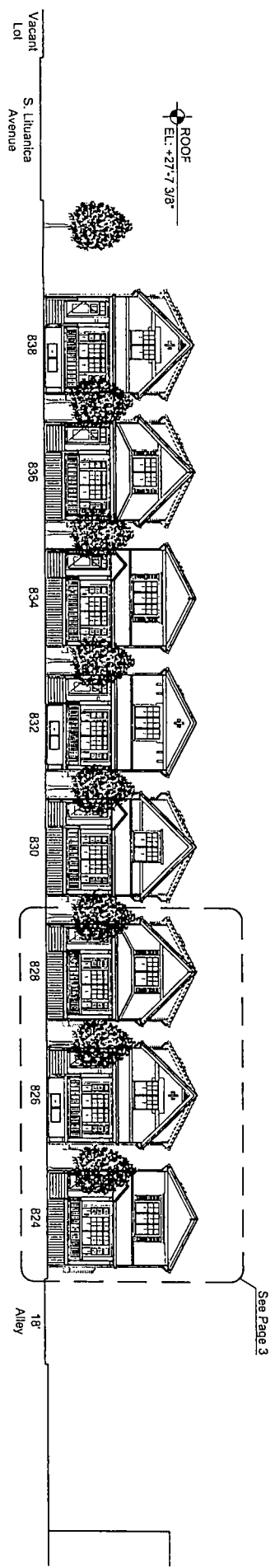

NORTH ALLEY ELEVATION

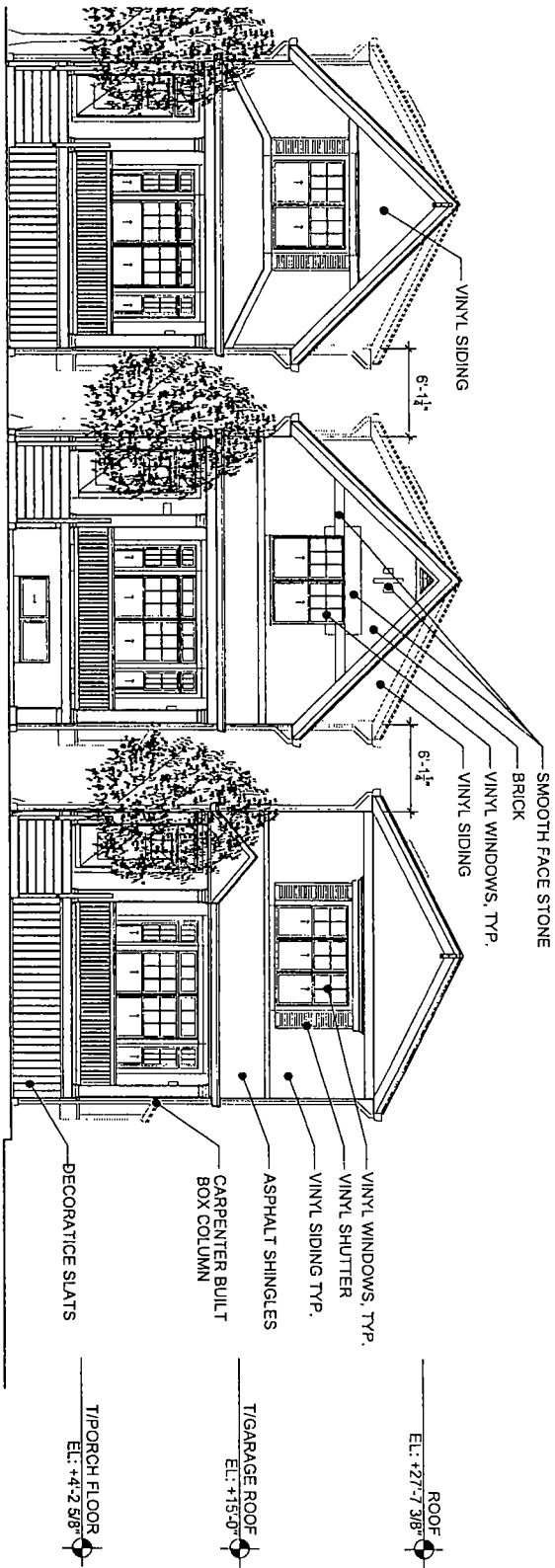


EAST ALLEY ELEVATION

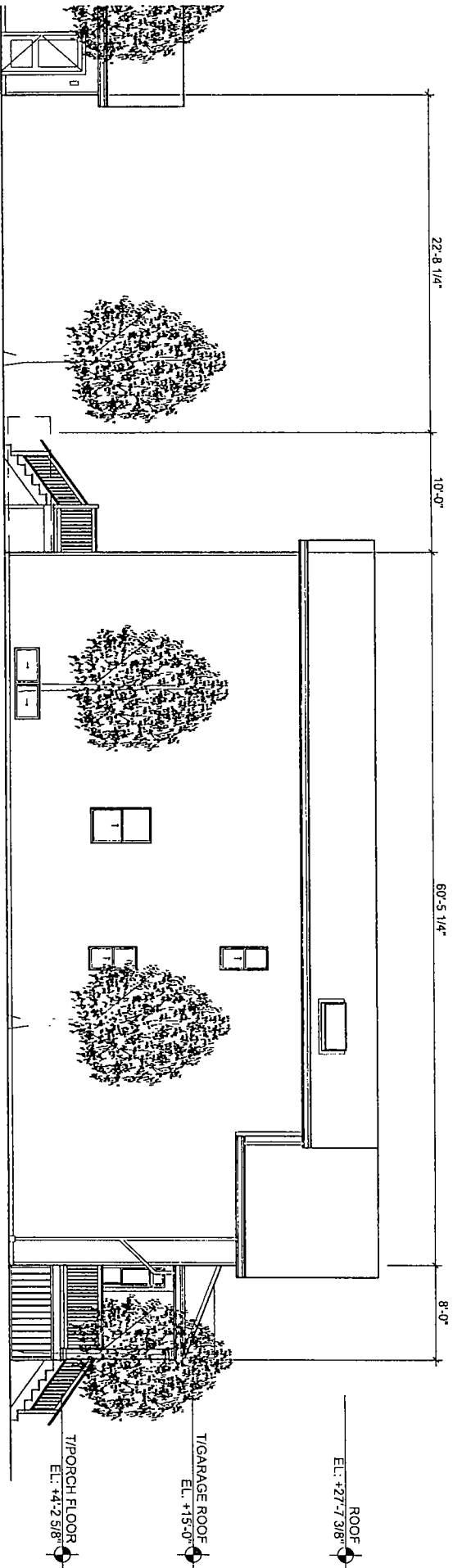
ENLARGED 38TH ST. ELEVATION

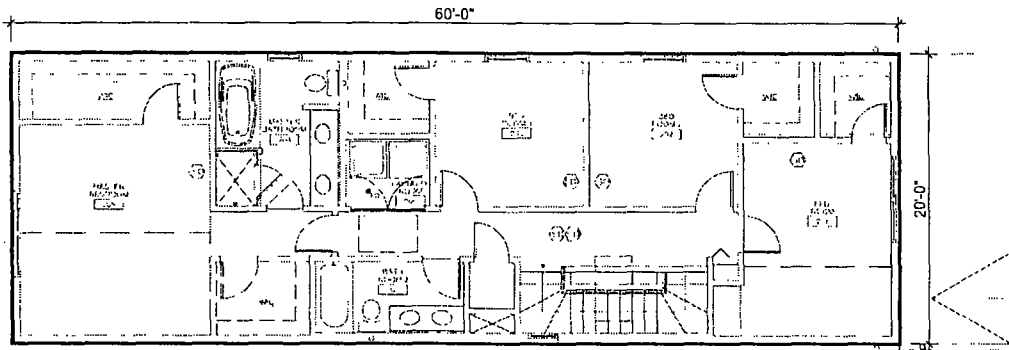

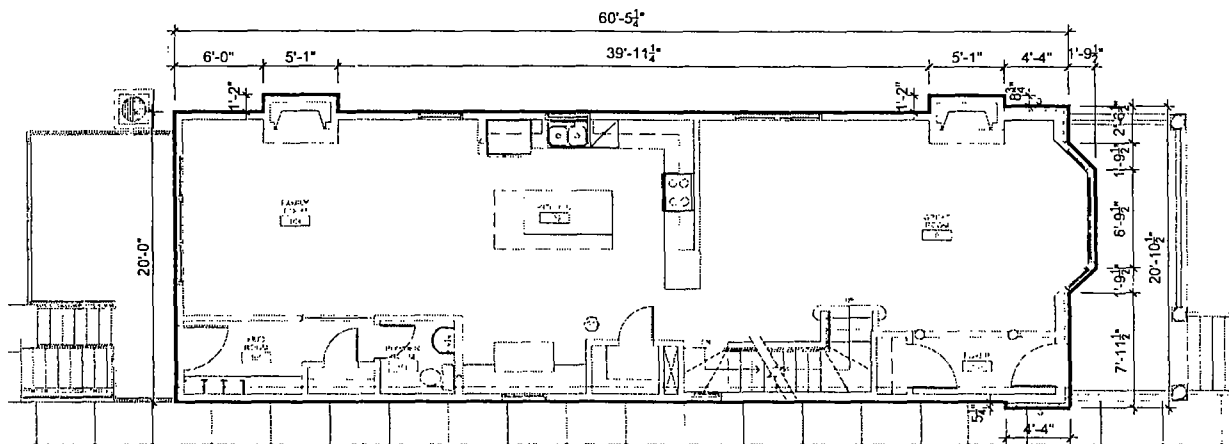


ENLARGED LITUANICA AVE. ELEVATION



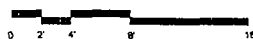


SECOND FLOOR PLAN
