SECTION 1 That the City Zoning Ordinance be amended by changing all the RT-4 Residential Two-flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 13-G in area bound by

WEST BALMORAL AVENUE; A LINE 219.4 FEET EAST OF AND PARALLEL TO NORTH CLARK STREET; THE PUBLIC ALLEY NEXT SOUTH OF WEST BALMORAL AVENUE; AND, A LINE 189.4 FEET EAST OF AND PARALLEL TO NORTH CLARK STREET.

To those of an RM 4.5 Residential Multi-Unit District, and a corresponding use district is hereby established in the area above described.

SECTION 2 The ordinance shall be in force and effect from and after its passage and due publication.

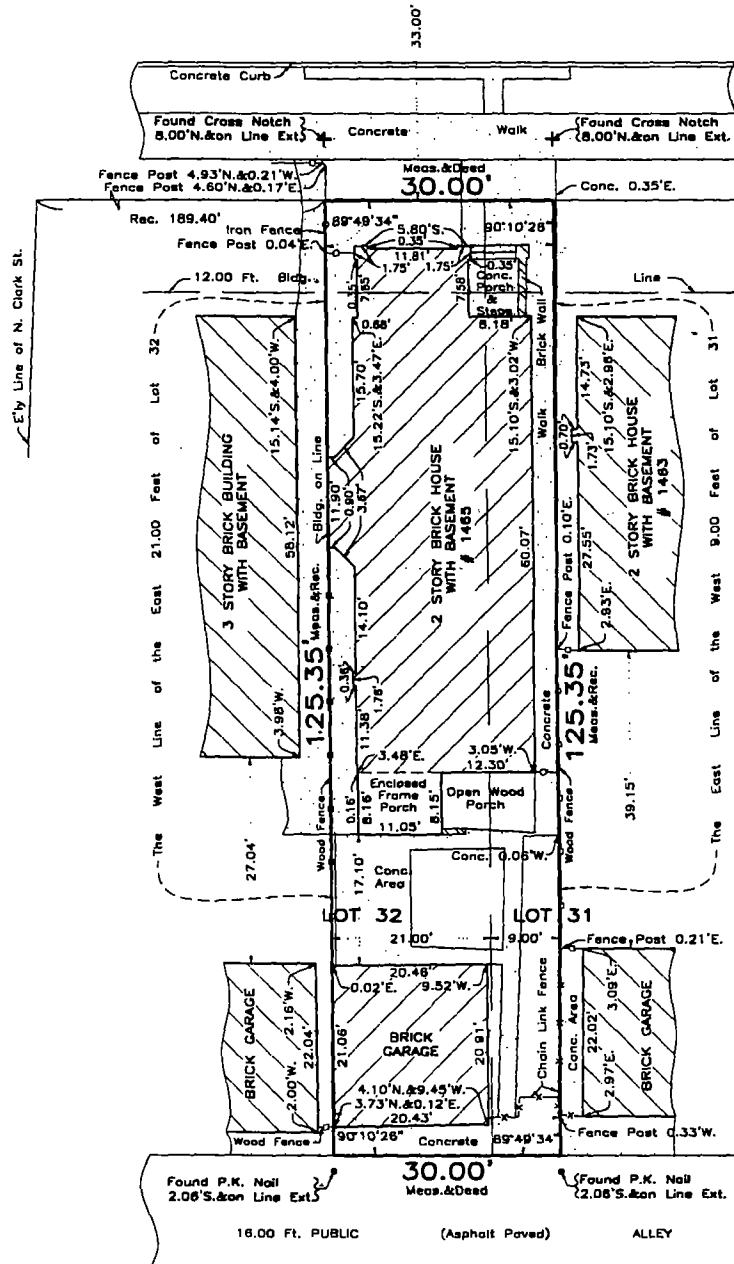
