#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the C1-1 Neighborhood Commercial District symbols and indications as shown on Map No.26-J in the area bounded by

a line 190 feet north of and parallel to West 111<sup>th</sup> Street; the alley next east of and parallel to South Harding Avenue; the alley next north of West 111<sup>th</sup> Street; a line 136.19 feet east of and parallel to South Harding Avenue; West 111<sup>th</sup> Street; and South Harding Avenue,

to those of a C1-3 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.
