ORDINANCE

#18603T1 INTRO DOTE Dec 9, W15

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/Business Park District, as shown on Map 1-G in the area bounded by:

West Grand Avenue, a line 278 feet West of North Noble Street, a point 100.47 feet South of West Grand Avenue and parallel to West Grand Avenue and a line 253 feet West of North Noble Street.

West Ferdinand Street, a line 250.82 feet West of North Noble Street, West Ferdinand Street and a line 275.82 feet West of North Noble Street, and a point 51.50 North of West Ferdinand Street.

To those of **B2-3** Neighborhood Mixed-Use District

SECTION 2. This ordinance takes effect after its passage and approval.

NARRATIVE AND PLANS FOR THE PROPOSED REZONING AT 1427 WEST GRAND AVENUE/ 1426 WEST FERDINAND STREET

The Application to change zoning for 1427 West Grand Avenue/1426 West Ferdinand Street from M1-2, Limited Manufacturing/Business Park District to B2-3 Neighborhood Mixed-Use District. The Applicant intends to construct a four story building consisting of four (4) residential dwelling units with parking.
