## **ORDINANCE**

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 1-G in the area bounded by

The public alley next north of and parallel to West Ohio Street; a line 125.38 feet west of and parallel to North Bishop Street; West Ohio Street; a line 150.46 feet west of and parallel to North Bishop Street,

to those of an RM4.5 Residential Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

## Narrative

1458 W. Ohio St. Zoning Amendment Type 1 Rezoning Supplemental Submittal

#### **Project Description :**

The applicant seeks to rezone the above mentioned property from zoning district RS-3 to RM-4.5. The applicant does not seek to change the use of the land, which is currently residential. The applicant is seeking a zoning change to permit construction of a new four story, three dwelling unit residence with a 3-story rear porch, 180 SF balconies at four floors, and three parking spaces are rear.
