BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance,
Is hereby amended by changing all the B3-1 Community Shopping District symbols and
indications as shown on Map No.5-I in the area bounded by

West Armitage Avenue; a line 276.07 feet east of and parallel to
North Washtenaw Avenue; the alley next south of and parallel to
West Armitage Avenue; and a line 252.07 feet east of and parallel
to North Washtenaw Avenue,

to those of a B2-3 Neighborhood Mixed-Use District is hereby established in the area
above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage
and due publication.

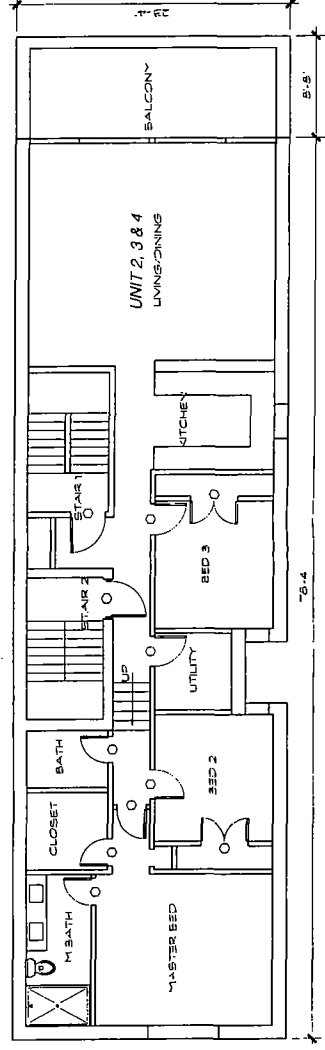


1 SITE PLAN

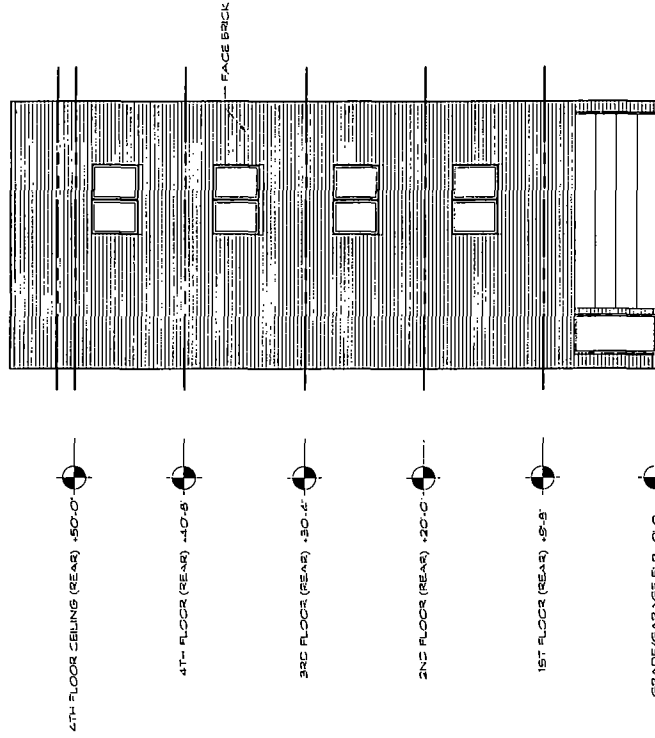




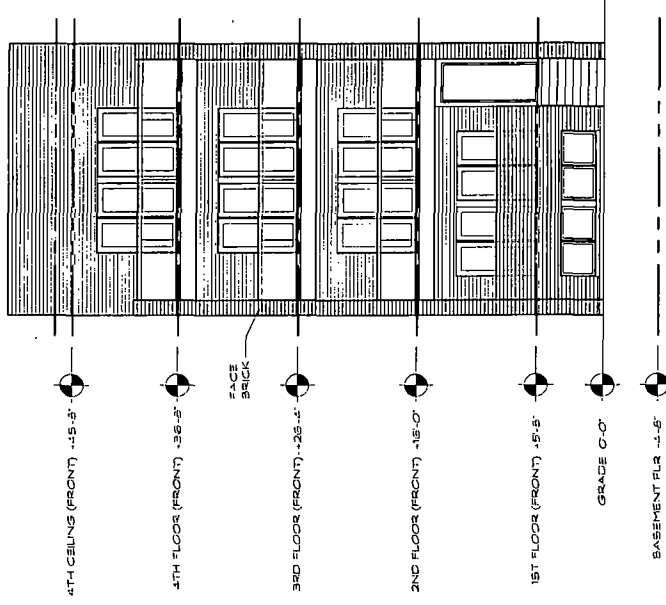
2 ROOF PLAN



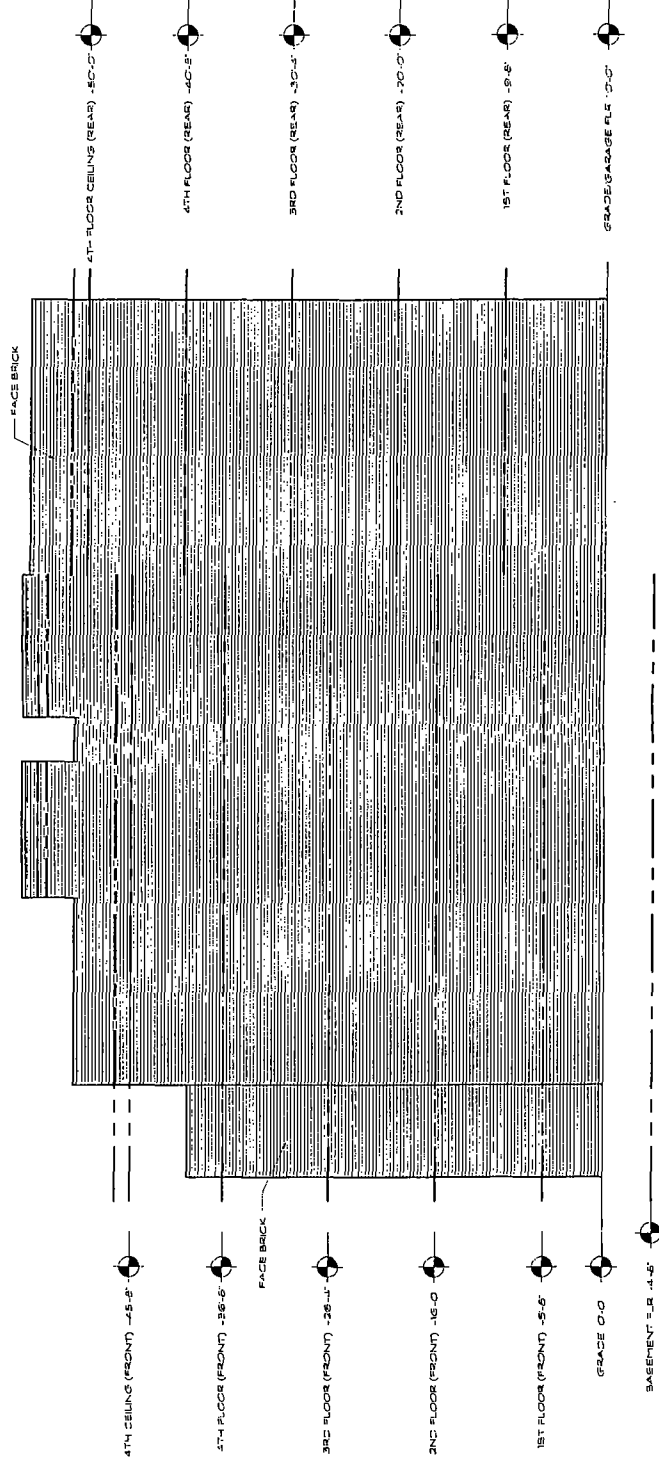
1 2ND, 3RD & 4TH FLOOR PLAN



2 REAR ELEVATION



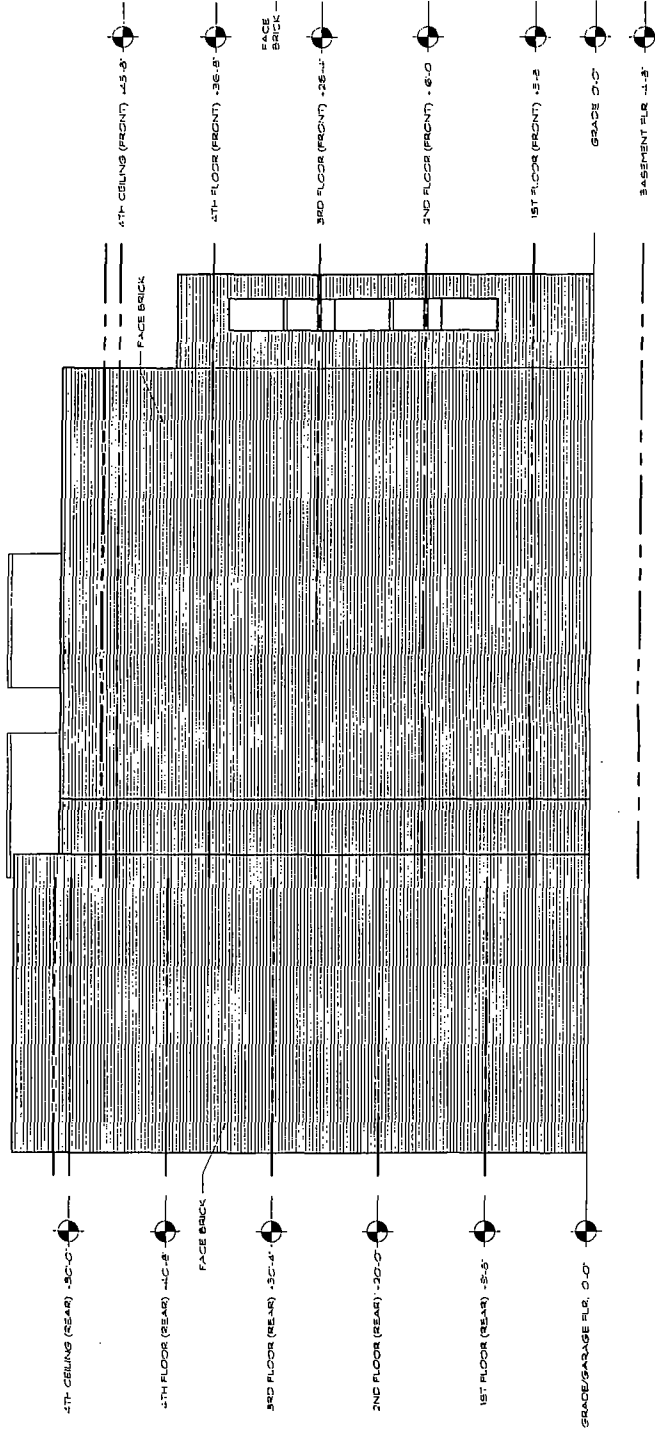
1 FRONT ELEVATION
