ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1: Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all the C2-5 Motor Vehicle-Related Commercial District symbols and indications as shown on Map No. 3-F in an area bounded by:

West Institute Place; North Wells Street; West Chicago Avenue; a line 90.18 feet west of and parallel to North Wells Street; a line 109.29 feet north of and parallel to West Chicago Avenue; the alley next west of and parallel to North Wells Street

to the designation of RM6.5 Residential Multi-Unit District and a corresponding use district is hereby established in the area above described.

SECTION 2: Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all RM6.5 Residential Multi-Unit District symbols and indications as shown on Map No. 3-F in an area bounded by:

West Institute Place; North Wells Street; West Chicago Avenue; a line 90.18 feet west of and parallel to North Wells Street; a line 109.29 feet north of and parallel to West Chicago Avenue; the alley next west of and parallel to North Wells Street

to the designation of Residential Business Planned Development No. _____ which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development herewith attached and made a part thereof and to no others.

SECTION 3: This Ordinance shall be in force and effect from after its passage and due publication.

RESIDENTIAL BUSINESS PLANNED DEVELOPMENT NO. _____
PLAN OF DEVELOPMENT STATEMENTS

1. The area delineated herein as Residential Business Planned Development No. _____ consists of approximately 20,789 square feet of property which is depicted on the attached Planned Development Boundary and Property Line Map (“Property”) and is owned or controlled by the Applicant, Chicago Wells Development LLC.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant’s successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time applications for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or under single designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.
3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees, or grantees. Any dedication or vacation of streets or alleys, or grants of easements, or adjustments of right-of-way, shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assignees, or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Planning and Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

4. This Plan of Development consists of these fifteen (15) Statements; a Bulk Regulations and Data Table; an Existing Land Use Map; Existing Zoning Map; a Property Line and Right of Way Adjustment Map; a Site Plan/ Landscape Plan; a Green Roof Diagram; and Building Elevations prepared by architect Antunovich Associates dated December 17, 2015. Full size copies of the Site Plan, Landscape Plan and Building Elevations are on file with the Department of Planning and Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the

established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

5. The following uses shall be allowed within the area herein delineated as Residential Business Planned Development: Multi-unit Residential, retail/commercial uses, office, accessory parking, related facilities, and accessory uses.
6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Planning and Development. Off-Premise signs are prohibited within the boundary of the Planned Development.
7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
8. The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance with the attached Bulk Regulations and Data Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations and Data Table has been determined using a Net Site Area of 20,789 square feet.
9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Planning and Development. The fee, as determined by staff at the time, is final and binding on the

Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.

10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Planning and Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Environment and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.
12. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to Section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
13. The Applicant acknowledges and agrees that the rezoning of the Property from C2-5 to RM6.5 for construction of the Residential Project triggers the requirements of Section 2-44-090 of the Municipal Code (the "2007 Affordable Housing Ordinance"). Any developer of a "residential housing project" within the meaning of the Affordable Housing Ordinance must: (i) develop affordable housing units as part of the residential housing project; (ii) pay a fee in lieu of the development of affordable housing units;

In accordance with these requirements and the Affordable Housing Profile Form attached hereto as Exhibit A, the Applicant has agreed to provide [10% if affordable at 100% AMI, lesser percentage if affordable at 80% AMI] affordable housing units in the Residential Project for households earning up to [80%] [100%] of the Chicago Primary Metropolitan Statistical Area median income (the “Affordable Units”), and/or make a cash payment to the Affordable Housing Opportunity Fund in the amount of \$100,000 per unit (“Cash Payment”). At the time of each Part II review for the Residential Project, Applicant shall update and resubmit the Affordable Housing Profile Form to DPD for review and approval. If the Applicant subsequently reduces the number of dwelling units in the Residential Project, DPD may adjust the requirements of this Statement No. 13 (i.e., number of Affordable Units and/or amount of Cash Payment) accordingly without amending this Planned Development. Prior to the issuance of a building permit for the Residential Project, the Applicant must either make the required Cash Payment, or execute an Affordable Housing Agreement in substantially the form attached hereto as Exhibit B in accordance with Section 2-45-110(i)(2). The terms of the Affordable Housing Agreement and any amendments thereto are incorporated herein by this reference. The Applicant acknowledges and agrees that the Affordable Housing Agreement will be recorded against the Property and will constitute a lien against each Affordable Unit. The City shall execute partial releases of the Affordable Housing Agreement prior to or at the time of the sale of each Affordable Unit to an income-eligible buyer at an affordable price, subject to the simultaneous execution and recording of a mortgage, restrictive covenant or similar instrument against such

Affordable Unit. Notwithstanding anything to the contrary contained in Sec. 17-4-1003-E, the Commissioner of the Department of Planning and Development may enforce remedies for breach of the Affordable Housing Agreement, and enter into settlement agreements with respect to any such breach, subject to the approval of the Corporation Counsel, without amending the planned development ordinance.

14. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enable and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote accessibility.
15. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. At the time of a hearing before the Chicago Plan Commission, all developments must be in substantial compliance with the current City of Chicago Sustainable Development Policy set forth by the Department of Planning and Development. The project will be eligible for Building Certification and will provide a green roof to cover at least 50% of the net roof area of the building. "Net roof area" is defined as total roof area minus any required perimeter setbacks, roof top structures, and roof-mounted equipment.





B. EXISTING LAND-USE MAP






D. PROPERTY LINE AND RIGHT OF WAY ADJUSTMENT MAP


J1. EAST BUILDING ELEVATION ALONG NORTH WELLS STREET




J2. WEST BUILDING ELEVATION ALONG ALLEY


J3. SOUTH BUILDING ELEVATION ALONG WEST CHICAGO AVENUE

Pursuant to the provisions of the Chicago Zoning Ordinance, Title 17 of the Municipal Code of Chicago, the Department of Planning and Development hereby submits this report and recommendation on a proposed Residential Business Planned Development for your review and recommendation to the Chicago City Council. The application for this amendment to the Chicago Zoning Ordinance was introduced into the City Council on July 29, 2015. Notice of the public hearing was published in the Chicago Sun-Times on December 2, 2015. The applicant was separately notified of this public hearing.

The applicant filed the application as a mandatory planned development per the requirement of section 17-8-0512 Tall Buildings. The applicant proposes to reclassify the site to an RM-6.5, Residential Multi-Unit District prior to establishing the Residential Business Planned Development.

SITE AND AREA DESCRIPTION

The approximately 20,789 square foot site lies in the Near North Side (8) Community Area. The rectangular shaped site is currently improved by a four (4) masonry buildings with heights ranging from two (2) to four (4) stories. The Site is currently C2-5, Motor Vehicle-Related Commercial District. The site is neither within the Lake Michigan and Chicago Lakefront Protection District, nor within a Chicago Landmark District but is located in the Near North Tax Increment Finance District.

The site is bounded on the north by West Institute Place and Planned Development No. 477 (Moody Bible Institute), on the east by North Wells Street, on the south by West Chicago Ave. and a 2-story commercial building and a public alley on the west of the property. There is a mix of uses along North Wells Street and West Chicago Avenue that include commercial, retail, institutional and accessory parking.

The site is served by the Chicago Transit Authority bus routes #37 (Sedgwick), # 66 Chicago Ave., #156 (Belmont/ Sheridan); The CTA's Brown Line Franklin Chicago rail station provides access to the area located ¼ mile and west of the site.

PROJECT DESCRIPTION

The applicant proposes to construct a multi-story mixed-use building with ground floor office space, dwelling units, accessory parking and accessory uses. The applicant is seeking an up zoning to a unified RM-6.5 and then to a Residential Business Planned Development. The proposal includes the construction of a 24-story (342') residential tower with 55 dwelling units, 4,087 square feet of office space, and 105 accessory parking spaces. The unit breakdown for the project is as follows: 11 efficiency units, (15) 2-bedroom units, (19) 3-bedroom units and (10) 4-bedroom units.

The project has an estimated total project cost of \$66,469,000.00 and the expected construction time line is 24 to 30 months. The project is anticipated to generate 150 construction jobs and 20 full time jobs.

DESIGN

The multi-story building is primarily comprised of a pre-finished aluminum and glass window system. This architectural vocabulary defines primarily the residential tower fronting West Institute Place, West Chicago Avenue and North Wells Street elevations. The ground floor contains office space that fronts West Chicago Avenue, and is enclosed by a glass storefront. The residential units are contained on floor six through twenty-two with floor twenty-three programed for amenities and mechanical uses.

The townhouse parking garage fronts on North Wells Street and includes only 8 parking spaces, while the main, 105 accessory parking spaces are accessed via an entry from West Institute Place. The parking garage is concealed along West Institute Place with a townhouse unit. The garage itself conceals all accessory parking spaces with an aluminum and spandrel glass system along the base of the building.

ACCESS/CIRCULATION

The site has vehicular access via North Wells Street and West Institute Place via two proposed curb cuts. Pedestrian access for the residential tower is located along North Wells Street from a residential entry lobby. The ground floor of the proposed building is designed for commercial office space fronting West Chicago Avenue. The design of the base of the building improves the pedestrian experience and is enlivened by a glass façade fronting the street frontage.

LANDSCAPE / SUSTAINABILITY

The project will install new parkway trees along West Chicago Avenue (3 trees), West Institute Place (2 trees) and North Wells Street (6 trees). The project will provide a total of 11 new parkway trees and will comply with CDOT and the City's Landscape Ordinance.

The project will also comply with the Storm Water Management Ordinance, implementing best practices in stormwater management. The project will satisfy the requirements of the City of Chicago's Sustainable Development matrix. The project anticipates receiving Building Certification and will provide approximately 8,126 square feet of green roof covering 50% of the net roof area.

BULK/USE/DENSITY

The site will be rezoned to an RM-6.5 and has a maximum allowable Floor Area Ratio (F.A.R) of 6.6. This proposed Residential Business Planned Development will achieve an F.A.R of 7.57, through section 17-2-0304-C Premium. The section states that a multi-unit residential building located in an RM-6.5 district on lots that permit 50 or more dwelling units, are eligible for floor area ratio premiums in accordance with the following:

For each one percent decrease in the number of dwelling units below the maximum number permitted under Sec.17-2-0303-A, a 0.50% increase in the allowable floor area ratio is allowed, provided that the floor area ratio is not increased by more than 25% over the otherwise applicable maximum under Sec. 17-2-0304-A.

Based on the projects net site area of 20,789 square feet the Minimum Lot Area would permit 74 dwelling units under the RM 6.5 District. The developer has opted to reduce the density of the building and develop 55 dwelling units. The reduction in dwelling units from 74 to 55 would permit the developer an increase of 0.97 FAR for a total maximum of 7.57 FAR (6.6 FAR x 114.68% = 7.57 FAR). The premium as defined by the above referenced section cannot exceed a maximum FAR of 8.125.

RECOMMENDATION

The Department of Planning and Development has reviewed the project materials submitted by the applicant and has concluded that the proposed application for a Residential Business Planned Development would be appropriate for the site and that the project meets the review criteria for planned developments set forth in the Zoning Ordinance (Section 17-13-0900).

1. The project complies with the Standards and Guidelines for Planned Developments in the Zoning Ordinance (Section 17-8-0900).
 - a. Compliance with Zoning. The proposed amendment to the Planned Development would conform to all the requirements and restrictions of the RM-6.5 Residential Multi-Unit District for uses, height, floor area ratio, and density.
 - b. Transportation, Traffic Circulation and Parking: The site has vehicular access via a proposed curb cut from North Wells Street and an additional curb cut from West Institute Place. The pedestrian access for the residential tower is located along North Wells Street and is identified via a residential entry lobby.

Loading will occur internal to the building envelope and foot print and be accessed from a proposed curb cut from West Institute Place.

- c. Pedestrian Orientation. The proposed project will allow unimpeded pedestrian flow on North Wells Street and West Chicago Avenue. Residential patrons will access the residential entry lobby through North Wells Street.
- d. Urban and Building Design. The building's modern design emphasizes the contrast among the various types of architectural styles and vocabulary along North Wells Street and West Chicago Avenue. The building materials of the building include architectural window system, spandrel glass (at the garage levels), metal panel system, brick veneer at the townhome elevations, and concrete columns are of high quality.

The design of the building's base and the materials of the building conceal the parking garage from the public view along North Wells Street and West Institute Place.

- 2. The proposed development is compatible with the character of the surrounding area in terms of uses, density and building scale.

Current development north and south of the site is comprised of a mix of uses along North Wells Street which include residential, office, institutional and commercial uses. The permitted uses of office and multi-unit residential uses are those allowed within the project's underlying zoning of RM-6.5, Residential Multi-Unit District.

- 3. The public infrastructure facilities and city services will be adequate to serve the proposed development at the time of occupancy.

The proposed Planned Development has been reviewed by the Chicago Department of Transportation's and all requested changes have been made. Copies of this application have been circulated to other City departments and agencies and all comments received which have been addressed in the revised application.

Based on the foregoing, it is the recommendation of the Department of Planning and Development that the revised application for a Residential Business Planned Development for CHICAGO WELLS DEVELOPMENT, LLC, be approved and that the recommendation to the City Council Committee on Zoning, Landmarks and Building Standards be: "As Amended, Passage Recommended."
