BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No.13-J in the area bounded by

West Foster Avenue; a line 166.15 feet east of and parallel to North Central Park Avenue; the alley next south of and parallel to West Foster Avenue; and North Central Park Avenue,

to those of a C2-1 Motor vehicle-Related Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
