#### **ORDINANCE**


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 1-L in the area bounded by:


A line 60 feet South of and parallel to West End Avenue; North Lotus Avenue; a line 85 feet South of and parallel to West End Avenue; the public alley next West of and parallel to North Lotus Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.
