BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-1, Community Shopping District symbols as shown on Map No. 7-O in the area bounded by:

A line 175 feet South of and parallel to West Barry Avenue; North Harlem Avenue; a line 250 feet South of and parallel to West Barry Avenue; the public alley next West of and parallel to North Harlem Avenue.

To those of a B2-2, Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and due publication.
