## **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS2 Residential Single-Unit (Detached House) District symbols as shown on Map No. 9-O in the area bounded by:

A line 312.60 feet South of and parallel to West Addison Street; a public alley next East of and parallel to North Oketo Avenue; a line 385.60 feet South of and parallel to West Addison Street; North Oketo Avenue.

To those of a RS3 Residential Single-Unit (Detached House) District

SECTION 2. This Ordinance takes effect after its passage and due publication.
