ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.7-J in the area bounded by

A line 191.00 feet north of and parallel to West Diversey Avenue, North Avers Avenue, a line 241.08 feet north of and parallel to West Diversey Avenue, the public alley next east of and parallel to North Avers Avenue

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


