ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 9- J in the area bounded by:

A line 323.72 feet North of and parallel to West Roscoe Street; North Lawndale Avenue; a line 273.72 feet North of and parallel to West Roscoe Street; the public alley next West of and parallel to North Lawndale Avenue.

To those of an RM4.5, Residential Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and approval.

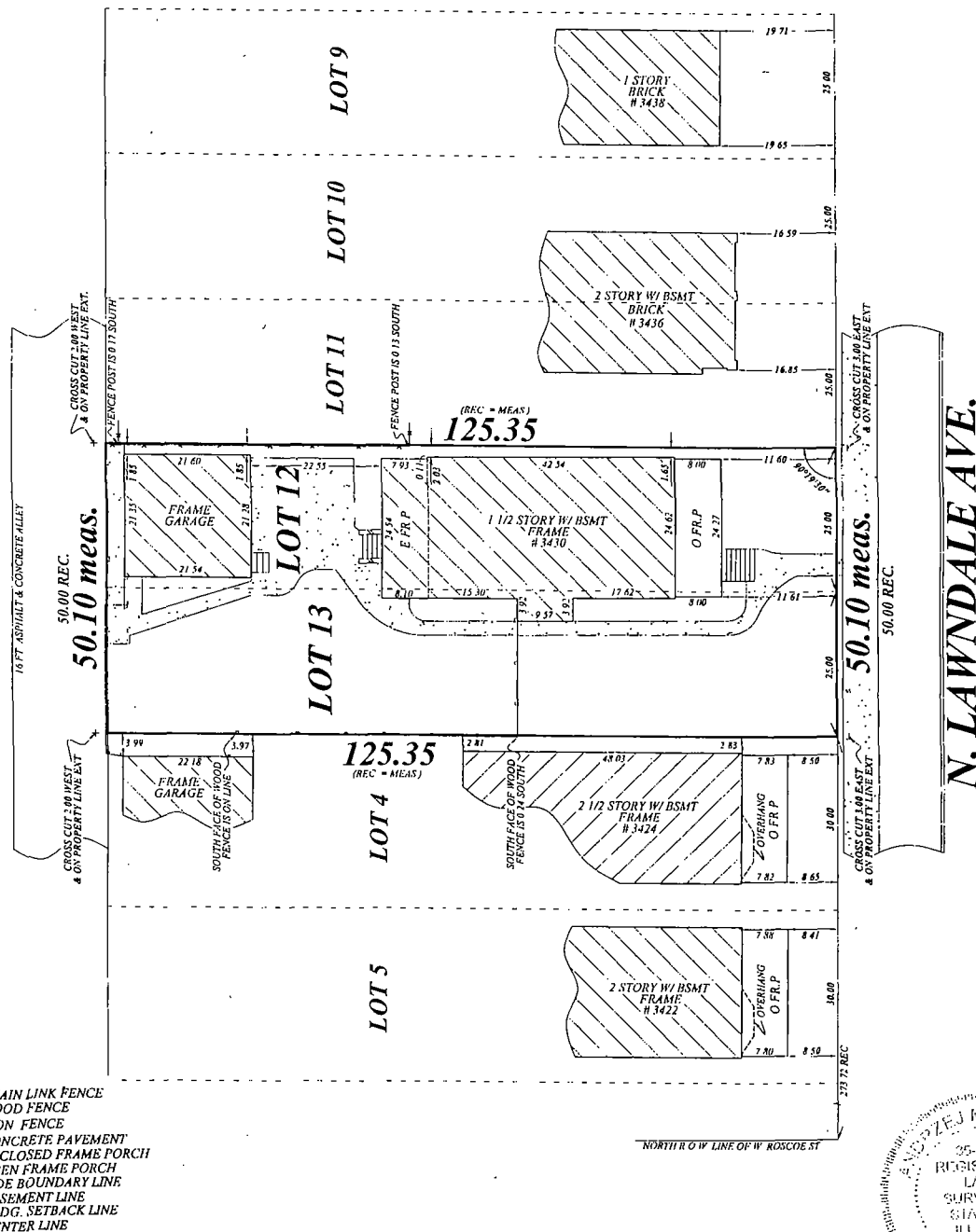

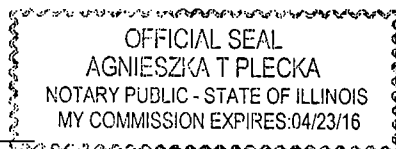

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 16, 2016 the undersigned will file an Application for a change in zoning from an RS3, Residential Single-Unit (Detached House) and an RM4.5, Residential Multi-Unit Zoning District to an RM4.5, Residential Multi-Unit Zoning District on behalf of Krystyna and Tadeusz Kawula for the property located at 3428-30 North Lawndale Avenue, Chicago, Illinois.



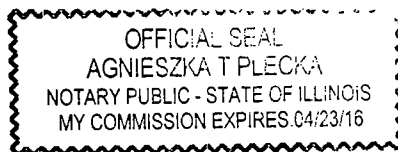

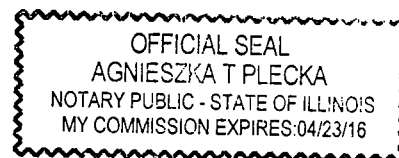
