BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Singly-Unit District symbols and indications as shown on Map No. 5-J in the area bounded by


WEST PALMER STREET; NORTH DRAKE AVENUE; THE PUBLIC ALLEY NEXT SOUTH OF AND PARALLEL TO WEST PALMER STREET; A LINE 25 FEET WEST OF AND PARALLEL TO THE WEST LINE OF NORTH DRAKE AVENUE,

to those of RM4.5 Residential Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
