ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning
Ordinance is hereby amended by changing all of the RS3 Residential Single—Unit
(Detached House) District symbols as shown on Map No. 10-F
in the area bounded by:

A line 275 feet North of and parallel to West 43rd Street; South Wentworth Avenue; a line 225 feet North of and parallel to West 43rd Street; the public alley next West of and parallel to South Wentworth Avenue.

To those of a C1-1, Neighborhood Commercial District

SECTION 2. This Ordinance takes effect after its passage and due publication.




