ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-2 Neighborhood Commercial District symbols and indications as shown on Map No 10-F in the area bounded by:

West 43rd Place; the 14.00 foot public alley next east of South Halsted Street; a line 200 feet south of and parallel to West 43rd Place; and South Halsted Street

SECTION 2. To those of a B2-3 Neighborhood Mixed-Use District, and a corresponding use district is hereby established in the area herein above described;

SECTION 3. This ordinance takes effect after its passage and due publication.
