**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols as shown on Map No. 3-I in the area bounded by:**

**West Haddon Avenue; a line 340.50 feet West of and parallel to North Western Avenue; the public alley next South of and parallel to West Haddon Avenue; a line 364.50 feet West of and parallel to North Western Avenue.**

**To those of an RM4.5, Residential Multi-Unit District**

**SECTION 2. This Ordinance takes effect after its passage and due publication.**
